NOTICE OF PUBLIC ETHICS COMMISSION
ADMINISTRATIVE HEARING

In the Matter of Michael Dabney; Case No. 23-28. In 2023, the PEC opened an investigation into allegations that a mobile food vendor named Michael Dabney attempted to bribe a City inspector. Commission staff completed its investigation and presented its findings to the Public Ethics Commission, which found probable cause that Mr. Dabney attempted to bribe a City employee and that Mr. Dabney furnished false evidence or information to the Commission. The Commission directed staff to schedule the matter for an administrative hearing. The hearing is scheduled for January 23, 2025, and, if additional time is needed, for January 24, 2025, as follows:
