RESOLUTION NO. <u>1-24-22 - 1</u>

ADOPT A RESOLUTION DETERMINING THAT CONDUCTING IN-PERSON MEETINGS OF THE PUBLIC SAFETY AND SERVICES OVERSIGHT COMMISSION AND ITS COMMITTEES WOULD PRESENT IMMINENT RISKS TO ATTENDEES' HEALTH, AND ELECTING TO CONTINUE CONDUCTING MEETINGS USING TELECONFERENCING IN ACCORDANCE WITH CALIFORNIA GOVERNMENT CODE SECTION 54953(e), A PROVISION OF AB-361.

WHEREAS, on March 4, 2020, Governor Gavin Newsom declared a state of emergency related to COVID-19, pursuant to Government Code Section 8625, and such declaration has not been lifted or rescinded. *See <u>https://www.gov.ca.gov/wp-content/uploads/2020/03/3.4.20-</u> <u>Coronavirus-SOE-Proclamation.pdf</u>*

WHEREAS, on March 9, 2020, the City Administrator in their capacity as the Director of the Emergency Operations Center (EOC), issued a proclamation of local emergency due to the spread of COVID-19 in Oakland, and on March 12, 2020, the City Council passed Resolution No. 88075 C.M.S. ratifying the proclamation of local emergency pursuant to Oakland Municipal Code (O.M.C.) section 8.50.050(C); and

WHEREAS, City Council Resolution No. 88075 remains in full force and effect to date; and

WHEREAS, the Centers for Disease Control (CDC) recommends physical distancing of at least six (6) feet whenever possible, avoiding crowds, and avoiding spaces that do not offer fresh air from the outdoors, particularly for people who are not fully vaccinated or who are at higher risk of getting very sick from COVID-19. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html</u>;*

WHEREAS, the CDC recommends that people who live with unvaccinated people avoid activities that make physical distancing hard. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/your-health/about-covid-19/caring-for-children/families.html</u>;*

WHEREAS, the CDC recommends that older adults limit in-person interactions as much as possible, particularly when indoors. *See <u>https://www.cdc.gov/aging/covid19/covid19-older-adults.html</u>;*

ITEM #3

WHEREAS, the CDC, the California Department of Public Health, and the Alameda County Public Health Department all recommend that people experiencing COVID-19 symptoms stay home. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/if-you-are-sick/steps-when-sick.html</u>;*

WHEREAS, persons without symptoms may be able to spread the COVID-19 virus. *See* <u>https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html;</u>

WHEREAS, fully vaccinated persons who become infected with the COVID-19 Delta variant can spread the virus to others. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated.html</u>;*

WHEREAS, the City's public-meeting facilities are indoor facilities that do not designed to ensure circulation of fresh / outdoor air, particularly during periods of cold and/or rainy weather, and were not designed to ensure that attendees can remain six (6) feet apart; now therefore be it:

WHEREAS, holding in-person meetings would encourage community members to come to City facilities to participate in local government, and some of them would be at high risk of getting very sick from COVID-19 and/or would live with someone who is at high risk; and

WHEREAS, in-person meetings would tempt community members who are experiencing COVID-19 symptoms to leave their homes in order to come to City facilities and participate in local government; and

WHEREAS, attendees would use ride-share services and/or public transit to travel to inperson meetings, thereby putting them in close and prolonged contact with additional people outside of their households; now therefore be it:

RESOLVED: that the Public Safety and Services Oversight Commission finds and determines that the foregoing recitals are true and correct and hereby adopts and incorporates them into this Resolution; and be it

FURTHER RESOLVED: that, based on these determinations and consistent with federal, state and local health guidance, the Public Safety and Services Oversight Commission determines that conducting in-person meetings would pose imminent risks to the health of attendees; and be it

FURTHER RESOLVED: that the Public Safety and Services Oversight Commission firmly believes that the community's health and safety seriously and the community's right to participate in local government, are both critically important, and is committed to balancing the two by continuing to use teleconferencing to conduct public meetings, in accordance with California Government Code Section 54953(e), a provision of AB-361; and be it

FURTHER RESOLVED: that the Public Safety and Services Oversight Commission will renew these (or similar) findings at least every thirty (30) days in accordance with California

Government Code section 54953(e) until the state of emergency related to COVID-19 has been lifted, or the Public Safety and Services Oversight Commission finds that in-person meetings no longer pose imminent risks to the health of attendees, whichever is occurs first.

Bruce Nye, from "Make Oakland Better Now" provided an overview of Measure Z and the transition from Measure Y. Bruce Schmiechen from "Make Oakland Better Now" spoke about the current status of Measure Z, and the effectiveness of Community Policing does not seem to be effective currently, and Ceasefire should be funded so that it can again play a role in reducing violent crime. He also addressed the question of what should change going forward, he suggest community (district) meetings to encourage participation. Commissioner Thomas asked about Faith in Action, Commissioner Dixon provided insight into what the organization does, and also supported the suggestion of district meetings. Commissioners were encouraged to reach out to their communities to encourage more community involvement with the SSOC.

ITEM 6. Expenditure Report Overview – Walter Silva, Budget & Management Analyst, provided an overview of the information on the Quarterly Expenditure Reports presented by OPD, DVP and OFD periodically to the SSOC.

ITEM 7. SSOC – DVP – Group Discussion

Commissioner Hawthorne addressed the concern that due to the DVP additional funding that the relationship to the SSOC will change. Commissioner Dinh suggested that SSOC only be involved in the Measure Z funding. DVP will return with a policy decision on how best to report on the General-Purpose Funding but the current funding is 1-time funding. Commissioner Dixon suggested that DVP report on the funding if possible, it can impact the next iteration of Measure Z to increase funding.

ITEM 8. Progress to Date and the Next Steps for Measure Z

Commissioners Thomas, Hodess and Hawthorn worked with Open Oakland to gather information to outline and evaluate all Measure Z Reports to date. Working to pull out specific items that can be analyzed across each evaluation. Information will be gathered so that the information can be presented at the SSOC joint meeting with the City Council. Commissioner Dixon would like to have additional information on Robert's Rules of Order, Commissioner Hodess would like the meeting to run more efficiently and would like a Robert's Rules of Order (RRO) presentation. Commissioner Dinh responded that RRO can be problematic to People of color....create unintentional impact on some communities. Commissioner Hawthorn would like that we remain with current structure of the SSOC.. Will be discussed and voted on at the next regular SSOC meeting. Would like former Commissioners to come to the SSOC and report out. Commission Dinh suggested that conferences may be helpful for commissioners to attend conferences on Violence Prevention. Commissioner Thomas is interested in creating agreements for the role of Commissioner on the SSOC.

 The Committee will ensure that OPD's proposed policy reflects the ideal that community members should take the lead in identifying community priorities for OPD involvement, and that the policy includes specific procedures for, among other things, addressing Beat level challenges, developing Beat and block leaders into viable Citywide networks, expanding public access to information and resources, and increasing community involvement in the training of OPD's Community Resource Officers (CROs), as well as other Department staff.

 Objectives: Revised neighborhood model that is community-led should consider focusing on two overarching goals: increasing broad and diverse community engagement in the neighborhood council and block structure and empowering residents and neighbors.

Track 1: Policy Revision

Step 1: Research and Synthesis

- Group lands on shared/language definition, objectives and editing process.
- Researches best practice, collects ideas, and creates material repository
- OPD weighs in with related materials, and shares what is and isn't working + policies from other agencies worth considering.
- Identify topics/sections to edit/omit/include

Step 2: Discovery and Input Considerations

- Create moments and spaces for broader public engagement:
 - Explain the policy in layman's terms
 - Create and redesign web page
 - Find ways to collect input, perspectives, and ideas.
- Group reviews findings and starts to consider language edits to the policy

Track 1: Policy Revision

Step 3: Research and Synthesis

- Language edits to the policy
- Broader group considers language, implementation implications, and community awareness campaigns.
- Identify partners and Subject Matter Experts (SMEs) to weigh in.
- Shape policy to capture the sentiments and innovative approaches that are discussed.

Step 4: Revision Iterations and Approval

- Final document presented to broader ad hoc group for review and approval
- Prepares for Commission presentation and vote
