## Subcommittee Reports – Adaptive Reuse Subcommittee

**Questions from Chair Rice:** 

- 1) Is the City of Oakland Planning Bureau considering any code changes similar to San Francisco's Adaptive Reuse Program that would support the reuse of office buildings for alternate uses?
- 2) Is the City of Oakland Building Bureau considering any code changes similar to San Francisco's, yet to be released code changes that would also support the reuse of office buildings for alternate uses?

#### **Responses from Planning and Building staff:**

Planning Code does not prohibit alternate uses (e.g., residential) downtown

- Building Code is the Uniform Building Code, used by most CA jurisdictions
- The City encourages the use of the performance-based California Historic Building Code (CHBC) for buildings that meet the thresholds for adaptative reuse. All Designated Historic Properties (DHPs) and Potential Designated Historic Properties (PDHPs) are now qualified structures under the CHBC.
- Staff will bring the Draft Downtown Oakland Specific Plan (DOSP) zoning amendments to the Landmarks Board. These include a "transfer of development rights program" to preserve historic properties and encourage maintenance and restoration, which could include adaptive reuse.
