A. Call to Order/Approval of Agenda

Green called the March 09, 2020 meeting to order at 5:41 p.m.

B. Roll Call/Determination of Quorum/Recite AC-OCAP Promise

Roll was called by Staff M. Francisco. A quorum was established at 5:45 p.m. The AC-OCAP Promise was recited.

C. Approval of Draft February 10, Administering Board Minutes (G. Green) – Attachment C

D. Presentation – Guillermo Cespedes, Chief of Violence Prevention

The Board welcomed Guillermo Cespedes, Oakland's Violence Prevention Chief. Mr. Cespedes presented the demographics and geography of Oakland's crimes, the progress being made and the challenges ahead. Mr. Cespedes outlined the hot spots across the map, revealing 52% of homicides and shootings occur in only 10 of the 35 police beats in Oakland. To date, the City has seen a 48.1% reduction in homicides. Mr. Cespedes discussed the many challenges ahead, and underscored the need for more comprehensive and effective approach to supporting families of homicide victims. This call to action, to support families of homicide victims, was acknowledged by the Board and will be sent to the Advocacy Committee Agenda.

E. Community Action Partnership (CAP) Updates (E. Clemons)

1. Board Update

A. Board Vacancies - Oakland District 1 and 4, and Alameda County - Community Recruitment efforts continue for Oakland District 1, Oakland District 4 and Alameda County-Community. E. Clemons urged Board Members to reach out to their networks and email M. Francisco with all board membership recommendations. There are two potential candidates for Oakland District 4, with one application nearing completion.

B. CAP Reimbursement Form – Attachment E1B E. Clemons reminded community sector board members of childcare and transportation reimbursable expenditures. The CAP Reimbursement Form will continue to be provided in monthly Agenda Packets.
