Responsibilities for the Chairperson and Vice Chairperson roles include, but are not limited to:

#### Chairperson

- The Chairperson is accountable to the Selection Panel as a whole in setting policy and shall also perform such duties as may be assigned by the Selection Panel.
- Finalize the Agenda for Selection Panel meetings with the assistance of City staff and Vice Chairperson.
- May call special meetings of the Selection Panel.
- Represent the Selection Panel in meetings or communications with City Councilmembers, Police Commission, and members of the public.

#### Vice Chairperson

- In the absence of Chairperson, or at the Chairperson's request, preside at meetings of the Selection Panel, which includes managing and leading discussion.
- Work with the Chairperson and City staff in finalizing the Agenda for Selection Panel meetings.
- At the request of the Chairperson, may represent the Selection Panel in meetings or communications with City Councilmembers, Police Commission, and members of the public.

3. Determine its next meeting or series of meetings.

# **Executive Summary:**

This is the first meeting of the Selection Panel for the Oakland Police Commission in 2024. The Panel will initiate its months long process in nominating a new candidate to serve on the Oakland Police Commission. As such, the Panel is being asked to review its 2024 nomination process and schedule.

The term for the nominee will initiate on October 17, 2024. Staff proposes the Selection Panel make its decision no later than mid-August 2024, which will allow staff time to complete the required background check and submit the scheduling request and staff report to be heard at the City Council in early October 2024.

The Panel does have the option to reappoint the current incumbent whose term expires in 2024 since Angela Jackson-Castain is currently completing the term of a previous Commissioner.

#### Background:

In 2024, the Selection Panel will be nominating a slate of one (1) appointee to the Police Commission for City Council approval. The term for Commissioner Angela Jackson-Castain, expires on October 16, 2024. Commissioner Jackson-Castain filled the seat vacated by Rudy Howell in October 2023.

As previously mentioned, if the goal is to get a nominee scheduled for confirmation at the City Council meeting of October 5, 2024, the Selection Panel will need to determine the nominee no later than mid-August 2024. All other dates can be adjusted accordingly based on input from the Selection Panel.

#### 2023 Nomination Process Details

In 2023, each Selection Panel Member reviewed all 34 applications submitted for consideration to the Police Commission. On June 20, 2024, the Selection Panel voted to invite 10 applicants to interview with the Selection Panel, however one applicant withdrew. Two rounds of interviews were held on two separate dates: July 12 and July 13, 2023.

On July 25, the Panel completed their finalist interviews with the following candidates: Omar Farmer, Karely Ordaz, Wilson Riles, Angela Jackson-Castain and Ricardo Garcia-Acosta. The Panel voted and nominated Karely Ordaz and Wilson Riles to fill the two vacancies on the Police commission. The Panel created a reserve that consisted of three members: Omar Farmer, Angela Jackson-Castain and Ricardo Garcia-Acosta

In October 2023, Rudolph Howell resigned from the Police Commission and Angela Jackson-Castain was elevated to full commissioner by the Police Commission. This left an alternate vacancy on the Police Commission. On November 2, 2023, the Selection Panel held a special meeting and interviewed the two remaining members of the reserve pool. During the meeting, the Panel voted and chose Ricardo Garcia-Acosta to fill the vacant seat.

The Panel could also request additional information from reserve pool candidates: Omar Farmer and Ricardo Garcia-Acosta.

Vice Chair Herron invited each candidate to make opening statements. Mr. Farmer provided his candidate statement first and Mr. Garcia-Acosta provided his opening statements second.

Mr. Farmer began by introducing himself and provided an update to the Panel on his work and community service since he last met with them in August 2023. The Panel asked Mr. Farmer a range of questions about his experience and availability to serve on the Police Commission. Mr. Farmer responded to each question in detail.

Mr. Ricardo Garia-Acosta then began his comments and provided background on his work and community experience that qualified him to serve on the Police Commission. Mr. Garcia-Acosta also met with the Panel in August 2023. Mr. Garcia-Acosta provided in-depth responses to the Panel's questions.

#### 4. Alternate Police Commissioner Nomination Process

The Selection Panel will discuss and take action on appointing an Alternate Police Commissioner for the term to end on October 16, 2025, for the position vacated by Angela Jackson-Castain upon her appointment to the Police Commission. This item could also include which candidates will advance to next phase in the interview and selection process.

Vice Chair Herron requested that the Panel proceed with the process.

Panelist Rivera made a motion to accept Ricardo Garcia-Acosta for the alternate position that remains open on the Police Commission. Panelist Goodall seconded the motion.

Vice Chair proceeded with discussion on the item.

Panelist Link suggested considering both of the candidates and simply take a vote for each candidate. He proposed that the person with the most votes would be the Panelist choice. He indicated that he thought they were both qualified.
