The proposed Macarthur Transit Village Parcel B project is located in the western portion of the Macarthur Transit Village (the area bounded by Highway 24 to the west, 40th Street to the north, Telegraph Avenue to the east, and West Macarthur Boulevard to the south). The proposed project is a change from the approved project for the site; the project includes redevelopment of the site with up to 502 residential units, 10,000 square feet of commercial uses, 260 parking spaces, and usable open space. The applicant currently seeks approval of a revision of the PUD, a height variance, a Final Development Permit and a Tentative Parcel Map, to permit the proposed project.
