**1.** Case File Number PUD99215, 1100 Clay Street. Minor revision to the approved T5/6 project. The project was previously approved in 2015 for up to 262 dwelling units in a 15-story building, with ground floor commercial uses. The minor revision is to allow a ten percent increase in the number of residential units (up to 288 units) within the same general footprint, volume and massing and layout as previously approved. The DRC is asked to provide comment and guidance to the Planning Director regarding changes to the exterior building treatments. **2.** Case File Number CMD07390-R01, 1100 Broadway. Design Review discussion for a proposed commercial development containing approximately 310,000 square feet of office space and 10,000 square feet of retail space in a proposed new 18-story tower building and a proposed rehabilitated, existing 8-story historic commercial building (Key Systems Building). The project is a revision to a project that was previously approved by the Planning Commission in 2008.
