SUBJECT: FORECAST OF CPRA REPORT-OUT AUGUST 22, 2024

This document is intended to forecast Executive Director Mac Muir's report-out to the Oakland Police Commission on August 22, 2024. Key points:

Pending Cases

- CPRA currently has 124 pending cases, a 44.6 percent decrease from August 2023 and a 7.8 percent increase from July 2024 (115).
- Of cases closed since the July CPRA report-out (excluding cases that had tolled and a duplicate complaint), the average time from case receipt to case close was 252 days (up from 222 days in June, a 13.5 percent increase).

- As of August 16, 2024:
 - o 18 out of 115 cases had 1-year goals before January 1, 2024. 8 cases were tolled.
 - o The average investigation age i.e., days since CPRA receipt was 134 days
 - Up 1.5 percent from July 2024 (132 days).
 - Down 34 percent from July 2023 (205 days)

Pending Case Goals

- Average time from case receipt to case close averaging under 180 days.
- Close oldest cases within 300 days.
- Note: Average case time may vary from month to month based on age of cases closed.

Budget

- Budget adopted by council in July 2024 included a 37.3 percent decrease to the CPRA budget from projected increases (8.27M to 5.18M).
 - Good news:
 - Budget still increased from 4.42M to 5.18M (17.2 percent increase)
 - CPRA did add two Complaint Investigator II positions, and one CPRA Attorney position.
 - Bad news:
 - 14 investigator and intake positions frozen, two Complaint Investigator II positions downgraded to Complaint Investigator I's.

Vacancies

- The following CPRA positions are vacant:
 - o Complaint Investigator I (2)
 - o Complaint Investigator II (1)
 - o CPRA Attorney (1)
- The CPRA Attorney position and one Complaint Investigator I position are expected to be filled in September.

- The updated Complaint Investigator I and II job specifications remain pending approval from HR to proceed to the Civil Service Board and are expected to proceed in either September or October. Full-time requisitions for these positions cannot proceed until the Civil Service Board approves each specification.

CPRA Manual

- Draft manual was submitted on Friday, August 2, 2024
- Next Steps: Receiving feedback from CPRA Manual Ad Hoc
- Public presentation will occur when all internal feedback has been incorporated.

Contracting

- CPRA to IAD Transition Consultants are continuing work. Next expected update: September 2024.
- CPRA Workflow (Database Application) Contract is currently being drafted to comply with IT contracting rules.
 Estimated timeline for implementation is subject to length of contract negotiations.

CPRA Expansion

- CPRA's presence at the Fruitvale Plaza location continues. Staff have been holding office hours on Mondays.
 - o Next step: Procuring Signage
- CPRA is still exploring options for the 150 Frank Ogawa Plaza location, as budget cutbacks have limited the agency's ability to expand.
- CPRA is exploring advertising opportunities in BART stations and trains.

Mediation Program

- CPRA is working with Community Boards and the CPRA Manual Ad Hoc to finalize draft program design.
- Next Action: Meeting with CPRA Manual Ad Hoc regarding program parameters

Additional Notes

- CPRA investigators continue to attend Police Commission meetings
- Summer interns from the Center for Youth Development through Law Marcel Walker, Oscar Gonzalez, and Zorina Guidry successfully completed their program.
