## THE SET UP:

- WE HAVE AN OUTDOOR PATIO AREA THAT WE WILL USE FOR THE LOUNGE. THE AREA WILL BE FENCED OFF AND WILL ONLY BE FOR CUSTOMERS/ PATIENTS.
- THE SECURITY TEAM ALONG WITH STAFF, WILL MONITOR ALL THOSE IN THE LOUNGE.
- ALL THOSE WHO ENTER THE LOUNGE WILL HAVE TO SIGN A CONSUMPTION AGRREMENT (1
  TIME), WHICH WILL BASICALLY STATE... YOU ARE BEING ALLOWED TO CONSUME
  RESPONSIBLY ON SITE AT YOUR OWN RISK. YOU AGREE TO FOLLOW ALL POSTED RULES OR
  YOU WILL BE SUBJECT TO IMMEDIATE REMOVAL AND REVOCATION OF LOUNGE PRIVLEDGES.
- WE WILL MONITOR FOR ANY OVER INTOXICATION, AND IF THAT DOES OCCUR, WE WILL
  HAVE CAR SERVICES ON STANDBY (AT CUSTOMERS EXPENSE). WE ARE ABOUT A 12 MINUTE
  WALK FROM BART AND 2 AC TRANSIT BUSES STOP RIGHT NEXT TO THE LOUNGE. WE WILL
  ALSO RECOMMEND (BUT NOT REQUIRED) FOR ALL LOUNGE GUEST TO USE PUBLIC TRANSIT.
- WE HAVE A FULL PARKING LOT, WITH ADA PARKING.
- THE AREA IS A 15 X 25 SPACE WITH TABLES, CHAIRS, AND A CANOPY. ASH TRAYS AND TRASH
  CANS WILL BE ON SITE ALSO.
- NO ODOR MIDIGATION AS WE ARE A FULLY EXTERIOR LOUNGE.
- PATIENTS WILL BE LIMITED TO 1-2 HOURS IN THE LOUNGE.
- OUR TEAM WILL RUN ROUTINE CHECKS MAKING SURE OUR CUSTOMERS/ PATIENTS ARE SAFE AND THAT THE AREAS ARE CLEANED AND SANITZED OFTEN.
- OUR TEAM HAS ALREADY BEEN TRAINED ON WHAT TO LOOK FOR REGRADRING OVER INTOXICATION IN ALL FORMS (VAPE, DAB, EDIBLES, SMOKING) AND IF NEEDED WE HAVE A COOLING OFF AREA FOR THOSE WHO HAVE DRIVEN THEIR ON VEHILCE.
- OUR SECUTITY TEAM HAS BEEN TRAINED ON DE-ESCALATION TECHNIQUES IN CASE CUSTOMERS/ PATIENTS HAVE A DISAGREEMENT ARISE.
- I AS THE OWNER WILL HOST MONTHLY MEETING TO ADDRESS ANY ISSUES THAT MAY ARISE AND WILL FACILITATE ANY NEEDED TRAINING.
- THE LOUNGE WILL BE OPEN FROM OPEN OF BUSINESS UNTIL 45 MINS BEFORE CLOSING 7 DAYS A WEEK (WITH POSTED SIGNS).
