RESOLUTION NO. 22-07-06

ADOPT A RESOLUTION DETERMINING THAT CONDUCTING IN-PERSON MEETINGS OF THE CULTURAL AFFAIRS COMMISSION AND ITS COMMITTEES WOULD PRESENT IMMINENT RISKS TO **ATTENDEES'** HEALTH. ELECTING AND TO CONTINUE CONDUCTING **MEETINGS** USING TELECONFERENCING IN ACCORDANCE WITH CALIFORNIA GOVERNMENT CODE SECTION 54953(e), A PROVISION OF AB-361.

WHEREAS, on March 4, 2020, Governor Gavin Newsom declared a state of emergency related to COVID-19, pursuant to Government Code Section 8625, and such declaration has not been lifted or rescinded. *See <u>https://www.gov.ca.gov/wp-content/uploads/2020/03/3.4.20-</u> <u>Coronavirus-SOE-Proclamation.pdf</u>; and*

WHEREAS, on March 9, 2020, the City Administrator in their capacity as the Director of the Emergency Operations Center (EOC), issued a proclamation of local emergency due to the spread of COVID-19 in Oakland, and on March 12, 2020, the City Council passed Resolution No. 88075 C.M.S. ratifying the proclamation of local emergency pursuant to Oakland Municipal Code (O.M.C.) section 8.50.050(C); and

WHEREAS, City Council Resolution No. 88075 remains in full force and effect to date; and

WHEREAS, the Centers for Disease Control (CDC) recommends physical distancing of at least six (6) feet whenever possible, avoiding crowds, and avoiding spaces that do not offer fresh air from the outdoors, particularly for people who are not fully vaccinated or who are at higher risk of getting very sick from COVID-19. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html</u>; and*

WHEREAS, the CDC recommends that people who live with unvaccinated people avoid activities that make physical distancing hard. *See* <u>https://www.cdc.gov/coronavirus/2019-ncov/your-health/about-covid-19/caring-for-children/families.html</u>; and

WHEREAS, the CDC recommends that older adults limit in-person interactions as much as possible, particularly when indoors. *See <u>https://www.cdc.gov/aging/covid19/covid19-older-adults.html</u>; and*

WHEREAS, the CDC, the California Department of Public Health, and the Alameda County Public Health Department all recommend that people experiencing COVID-19 symptoms stay home. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/if-you-are-sick/steps-when-sick.html</u>; and*

WHEREAS, persons without symptoms may be able to spread the COVID-19 virus. *See* <u>https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html</u>; and

WHEREAS, fully vaccinated persons who become infected with the COVID-19 Delta variant can spread the virus to others. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated.html</u>; and*

WHEREAS, the City's public-meeting facilities are indoor facilities that do not ensure circulation of fresh / outdoor air, particularly during periods of cold and/or rainy weather, and were not designed to ensure that attendees can remain six (6) feet apart; and

WHEREAS, holding in-person meetings would encourage community members to come to City facilities to participate in local government, and some of them would be at high risk of getting very sick from COVID-19 and/or would live with someone who is at high risk; and

WHEREAS, in-person meetings would tempt community members who are experiencing COVID-19 symptoms to leave their homes in order to come to City facilities and participate in local government; and

WHEREAS, attendees would use ride-share services and/or public transit to travel to inperson meetings, thereby putting them in close and prolonged contact with additional people outside of their households; and

WHEREAS, on March 28, 2022 the Cultural Affairs Commission adopted a resolution determining that conducting in-person meetings would present imminent risks to attendees' health, and electing to continue conducting meetings using teleconferencing in accordance with California Government Code Section 54953(e), a provision of AB-361; now therefore be it:

RESOLVED: that the Cultural Affairs Commission finds and determines that the foregoing recitals are true and correct and hereby adopts and incorporates them into this resolution; and be it

FURTHER RESOLVED: that, based on these determinations and consistent with federal, state and local health guidance, the Cultural Affairs Commission renews its determination that conducting in-person meetings would pose imminent risks to the health of attendees; and be it

FURTHER RESOLVED: that the Cultural Affairs Commission firmly believes that the community's health and safety and the community's right to participate in local government, are both critically important, and is committed to balancing the two by continuing to use teleconferencing to conduct public meetings, in accordance with California Government Code Section 54953(e), a provision of AB-361; and be it

FURTHER RESOLVED: that the Cultural Affairs Commission will renew these (or similar) findings at least every thirty (30) days in accordance with California Government Code section 54953(e) until the state of emergency related to COVID-19 has been lifted, or the Cultural Affairs Commission finds that in-person meetings no longer pose imminent risks to the health of attendees, whichever occurs first.

5. Cultural Affairs Division Manager's Update

Roberto Bedoya provided an update on staffing, the budget, and the Cultural Funding Program. <u>Staffing</u>

The Cultural Funding Program Coordinator position description has been written and funding has been identified but Human Resources have not been able to post the job description. Once the midcycle budget is approved, Human Resources can begin to recruit for a position support Kristen Zaremba in Public Part. A third position will be recruited for later on who will help provide communications support.

FY22-23 Budget

There is no indication that the Division shouldn't get an additional \$1M for funding festival grants. The new funds will likely increase the dollar amount of grants.

The National Endowment for the Arts American Rescue Plan awarded the Division \$450,000. The funds will be used for a teaching artists jobs program. The grant application announcement will be made in July.

Cultural Funding Program

The Festival Fund program will distribute \$400,000 in awards. The City Attorney determined that the Funding Advisory Committee (FAC) does not have standing because of the Commission's existence, which means that they can hear the funding recommendations but cannot vote. Their governance and role in the Division's grantmaking process is under review.

6. Cultural Affairs Commission Chair Update

Chair Sanchez reported on the following:

Governor's Budget Revise – Arts & Culture Items

- \$30M over 3 years for cultural districts
- \$50M for Parks & Recreation Departments to create arts installations in state and local public parks
- \$173,000 for the Poet Laureate Program

What's missing is SB628 which is a \$50M ask for cultural workers. It was passed in the last session, but funding needs to be identified.

CAC Vice Chair Position

The CAC will vote on Vice Chair position in July. Past Vice Chairs can run again for the one-year term.

7. Advocacy Process: Meetings with City Council Members

Commissioner Sanchez noted that ss part of their role, the CAC will need to build relationships with City Councilmembers year-round so that conversations around funding and investing in arts and culture are frequent and impactful during budget season.

Vice Chair Lee walk the CAC through a slideshow presentation about the Commission's past advocacy efforts and budget achievements. The Commissioners discussed strategy and messaging.

8. Public Comment

No members of the public made a comment.

- 9. Ad Hoc Team Update: Community Cultural Development Oakland 2045 General Plan Commissioner Chan walked the CAC through a slideshow presentation through slideshow about the General Plan process and where arts and culture fits into the conversation around policymaking. An Ad Hoc Team of CAC members (Chan, Whang, Easton, Sanchez) along with Goldman Fellow Claire Pelley, and community members Ada Chan and Jean Johnstone drafted the letter to the City's General Plan staff with their arts and culture specific recommendations for the Plan. Pelley provided an overview of her process for collecting information to inform the recommendations in the letter. Commissioner Whang explained the Guiding Principles for the recommendations which include:
 - Oaklanders can stay in their homes
 - Return of those displaced (residential and business)
 - Have spaces that facilitate cultural productions and allow for exchanges and innovation
 - Maintain and create thriving, culturally-rooted local businesses and organizations
 - Create and activate public and private spaces where we can negotiate and build community that are cultural-equitable, safe, and healthy

The Recommendations

Theme 1: Live/Work and Work/Live

1A Incentivize the development of affordable live/work and work/live units.

1B Provide guiding language in the general plan and policies in the Zoning regulations for live/work and work/live units to reduce absorption into residential-only uses.

1C Track live/work and work/live units as a category within the planning department.

1D Codify policies in the general plan that ease the process and reduce expenses to get non-conforming spaces into code.

1E Adopt policies in the general plan to protect cultural workers and workspaces at risk of displacement or affected by cannabis manufacturing, cultivation and other cannabis businesses.

Theme 2: Cultural Infrastructure

2A Expand the use of zoning regulations being piloted in the Downtown Oakland Specific Plan to increase first-floor cultural spaces to Districts 6 & 7.

2B Establish a working group to make recommendations to the City Council for the timely development and implementation of a Cultural Facilities Policy.

Theme 3: Cultural Equity Impact Assessment

3A Establish the use of a Cultural Equity Impact Assessment as a condition of California Environmental Quality Act (CEQA) review

Theme 4: Right of Return

4A Codify guiding preference policy in the general plan to allow displaced Oaklanders the right of return.

11. Downtown Oakland Specific Plan Update

Commissioner Chan noted that the CAC has the opportunity to offer comment on the DOSP's zoning updates. The Ad Hoc Team will review and provide comments.

12. Ad Hoc Team Update: District 6 & 7 Outreach

Commissioner Choice noted that he, Commissioner Pleasants, and Commissioner Price have held discussions about how best to engage the arts community in District 6 & 7, and support them in activating spaces, finding news spaces, provide information, and establishing a stronger relationship with Councilmembers Loren Taylor and Reid. Commissioner Pleasants noted that they are engaging in discussions with community members including Candice Elder (East Oakland Collective) and Tyrone Stevenson (The Original Scraper Bike Team). The Ad Hoc Team wants to host a Town Hall in the districts.

13. Update: Special Activity Permits Division - Greg Minor, Assistant to the City Administrator Greg Minor provided an update on the new Special Activity Permits Division.

Proposed Changes to the permitting ordinance:

1. The Economic and Workforce Development Department (EWDD) as opposed to OPD will oversee the permitting of special events outside of City parks.

2. Outlines factors that will determine the level of security needed at an event, including when law enforcement may be required, and allows for non-law enforcement staff trained in deescalation to serve as security.

3. Streamlines processing of repeat events by allowing applicants to submit more than one application at once during a twelve-month period as long as the repeat event takes place at same location, consists of same scope, and is produced by same applicant.

4. Consolidate special event permitting process into a one-stop shop approach with an interdepartmental team consisting of police, fire prevention and other departments as needed, as opposed to requiring event applicants to obtain separate permits from each department.

5. Introduces three-person review committee to hear appeals of special event permit denials a. Review committee consists of one Cultural Affairs Commissioner, one representative each from OPD and EWDD that did not take part in the underlying permit denial.

6. Includes an automated approval if a special event applicant does not receive a response within fifteen days of submitting their application. CITY OF OAKLAND ECONOMIC AND WORKFORCE DEVELOPMENT DEPARTMENT

7. Introduces different special events tiers to reflect the wide range of events, with different application timelines based on the complexity of event
