Next Village in San Francisco receives fifty thousand dollars

- Ways to take the Census Starts March 12, 2020 July 2020, available in thirteen (13) languages online, two languages on paper, there are some languages not available for the survey, May 2020 August 2020 Enumerators will reach out to those who did not respond to the survey.
 - Online Computer, Mobile device, telephone, Paper Form (you will receive a letter with a code to do your census)
 - General Rule Count people at their usual residence, which is the place where they live and sleep most of the time
 - Data Privacy & Confidentiality Title 13, United States Code
 - Cybersecurity Monitor and prevent suspicious activity, sophisticated data encryption, protect data collection devices, kill switch on laptops and devices
 - Census by the Numbers Alameda County receives sixty percent (60%) of its revenue from federal and state resources determined b Census data; each person missed = one thousand dollars (\$1000.00) lost in funding per person, per year for ten (10) years; an undercount of six percent (6%) = a loss of one billion

dollars(\$1000,000,000) over ten (10) years. Resources pay for education, housing, roads, health care, social services, and more!

- Federal funding is determined by Census data for social services, housing, transportation, and education
- Hard to count communities include young children, large households, foreign born residents/immigrants, people of color, low income households, homeless individuals, disabled individuals and more
- There will be training on completing the census, grantees serving seniors are Alameda County Meals on Wheels, Center for Independent Living, family Bridges, Inc., Korean community Center of the East Bay, Self Help for the Elderly, St. Mary's Center, United Seniors of Oakland and Alameda County Vietnamese community Center of the East Bay
- Timeline has three (3) phases: education phase, awareness phase, motivation phase
- Alameda County Community Ambassador Program: host an event where people can complete the Census; adopt-a-block; host a questionnaire assistance center (QAC); trained volunteers to support people at QAC's
- Census Messenger Program: Get the word out!

In May the City will sponsor the Older American Month, how can this time be utilized by setting up tables?

Yes, the Census received a Tech RFP for support from a technical organization who will supply laptops, and tablets for this kind of event. This is another way of getting the information out.

The Commission can provide support in reaching out to the elected officials and their districts for the senior population.

Yes, there is a group of elected officials and their staff who will receive special training in answering questions regarding the survey and how to best promote the Census.

Is the most effective way to support the Census through the Ambassador Program?

Yes, it is the best way to track what is needed for the Census.

What is the outreach plan for homeless older adults?

- There will be a Service Based Enumeration (SBE) outreach from March 30,
 2020 April 1, 2020 (Three days) to shelters, soup kitchens, mobile food vans, and target non-sheltered outdoor locations.
- From April 9, 2020 May 4, 2020, The Bureau's Enumeration at Transitory Locations Operation (ETL) will count people who are living in special locations such as recreational vehicle parks, campgrounds, racetracks, circuses, carnivals, marinas, hotels and motels and who do not have a Usual Home Elsewhere.
- The Group Quarters Enumerator will evaluate how many people were reached through the Service Based Enumeration (SBE) and the Bureaus Enumeration at Transitory Locations Operation (ETL) to verify information and reach out to those that were missed.

Two (2) ways to support the Census

- 1. Working with The Regional Office for the Federal Government in Los Angeles is invited to come for The Older American Month in May. They will bring materials and tablets to work with the community.
- Working with the County for mailers. Human Services Department Oakland Paratransit for the Elderly and Disabled (OPED - Taxi Scrips and Senior Companions and Foster Grandparents Program will design a postcard to insert and mail out with their mass mailing.
- Health Insurance Counseling and Advocacy Program (HICAP) David Sayen, CMS Regional Administrator – Retired - 2008-2018

HICAP is a volunteered-based program helping people on Medicare and pre-retirees and people with disabilities navigate the health care system.

- Medicare enrollment is from October December 7, 2019
- Medicare Pays 80% of cost with the monthly premium
- Plans are restrictive, be sure you get legal advice and/or counseling be for signing up and/or changing Programs

8. Age Friendly Oakland

Chairperson Bryan Ricks and Committee

- Four (4) main topics for discussion
 - 1. <u>Health and Wellness</u> regarding the food program, food deserts, food security
 - 2. <u>Housing</u> assisting in finding economical ways to stay in Oakland
 - 3. <u>Communication</u>
 - 4. Parks and Recreation
- Presented at the Making the Difference Conference at Preservation Park sat on a panel along - side other cities. We learned that our Commission is dynamic. There are some opportunities for us as we continue to move down the path, we have to focus on the process changes we need to bring to the table for the city and stay focused on the framework of becoming an Age Friendly City. There was a great mix of some cities that were doing a great job from the administrative and process side and examples of going after key initiatives. We are an initiative driven team at this point.
- The last time we talked about shared housing, we have done some interviews, with Covia, Silvernest and there will one more coming up next month. The commission does not want an online based service where it becomes a referral. Still doing some reviews.
- From a communication standpoint there is great need to close the gap between senior and the city. The Operator City Manager invited Chairperson Bryan Ricks and Commission on Disabilities to a meeting in December, after the power outage and seeing how things can go wrong. Some homes had no outside communication, telephones, medical equipment stop working and when the temperatures drop to 40 degrees there wasn't any source of heat. There is a need for a registry of vulnerable people in the city. This could be a big project for a Subcommittee.

 - Investing in a consultant, Meredith Fenton with two (2) or three (3) people to assess the communication and outreach through fifty (50) minute telephone conference call within the next month
 - Volunteers for the Commission Subcommittee: Chairperson Bryan Ricks, Commissioners Cheryl Moore, Jennifer Seibert, Dianna Garrett

- o Chairperson Bryan Ricks and Committee
 - Food Security East and West Oakland do not have good access to food, AM/PM is not the answer
 - There is a project that the committee is working on with a group of students from SMASH Academy Program, for six (6) weeks during the summer. They study science, math, devices to impact the city. The students were challenged, how do you make Technology into a device to impact the community around you. Without any prompting a group of students came up with a program that looks exactly like a program that is being executed by Mercy Brown Bag. Their idea was a Farmers Market Program concept working with Alameda County Food Bank. They would stock up the trucks with fruits, vegetables, dairy products, staples that most people do not have access to. There would be designated locations for the food distribution. The students said close the food trucks and thought of an online system where a senior could place an order and have sites to drop off the food. Would like to get started the first quarter of next year.
 - How can we have start up plan to help close some of those gaps using a current blueprint and work toward making the plan available to seniors and others. A follow up meeting is planned with District 6, Councilman Taylor, his staff to expand this program. There are Cal fresh programs, have conversations with Grocers to invest in the community.
 - Outdoor space Mosswood as a target for senior activities.

• Scott Means, HSD/Aging and Adult Services Division

There is a Multi-department Group meeting regarding Mosswood Park. Expense is the issue. Not at design yet. A lot of community engagement, there will be a meeting on Tuesday, November 12, 2019 to discuss people's vision on the design of the building facility.

 - Closing with the Livable Oakland updated activities, the commission should look at the different areas and which ones you would like to work with and have passion in certain areas.
- Vice Chairperson Martha (Mattie) Scott
 - Suggested adding the DOSC/EIR Safety Plan as one of the areas of activities. Seniors are not being counted properly in the plan.
- Chairperson Bryan Ricks
 - Bryan agreed and will send an email to Terry highlighting areas of the DOSC/EIR scheduled meetings. It is important that the commission have a voice to remind them of how the population is shifting and let's make sure that your growing population is part of the design in the way they are looking at the city. The commission will need volunteers to attend the meetings.

Senior Center Bylaws

By Laws – one pending item on page 5.4, the minimum number for a quorum has been changed from Twenty (21) to maximum of fifteen (15) and a minimum of nine (9). The Quorum will still be fifty (50%) percent plus one of whatever each senior center decides their number will be. One council member asked if they could be counted through a telephone call. Calling in is not an option.
