

### CITY OF OAKLAND SPECIAL MEETING OF THE COMMISSION ON HOMELESSNESS

Draft Meeting Minutes Wednesday, October 27, 2021 5:30 PM Via Zoom

The meeting was called to order and convened at 5:31 PM.

# 1. Call to Order and Roll Call

## 3. Approval of July 28, 2021, Draft Minutes

A motion was made by James Mittelberger and seconded by Joey Harrison to approve the draft meeting minutes of July 28, 2021. ## 4. The Selection of Officers

### The Commission discussed leadership options in the selection of commission officers.

A motion was made by Janey Castillo and seconded by Mark Walker to nominate Mark Walker as Chair of the Commission and nominate Janny Castillo as the Vice-Chair of the Commission. Upon call of the vote, the motion passed 9 Ayes: Chair Walker, Vice-Chair Castillo, Elder, Harrison, Lozano, Mittelberger, Moss, Rhorer, Stokes

### 5. Draft By-Laws and Rules of Procedure Presented for Discussion

The Commission heard a presentation of the final draft of the bylaws with the following amendments proposed by the staff: 1) that the proposed establishment of a subcommittee of unhoused advisors is directed to the policy committee to plan and coordinate outreach to ensure participation in the development of homeless policies with the support of Commissioner Harrison, and 2) replace the draft lobbyist reporting language with new language that requires commission members report lobbyist activities consistent with the reporting procedures of the Ethics Commission on the event commission members are contacted by individuals attempting to influence the decisions of the Commission.

The Commission discussed the matter and as requested by Commissioner Mittelberger, proposed the bylaws include an additional amendment that the duty of presiding over the commission meetings alternate between the Chair and Vice-Chair.
