☐ Increase garbage collection for encampments to a level where we cooperatively with homeless residents reduce the fire danger within the site. ☐ Increase porta-potty services to encampments to improve living conditions for encampment residents. ☐ Support the city's efforts to lead with dignity and compassion. Review The Encampment Management Policy and make appropriate changes to improve the quality of services and responses through the lens of dignity and respect. ☐ Increase outreach services throughout Oakland adhering to budget constraints yet targeting the persons most in need. ☐ Urge Alameda County to continue to increase homeless services and help reduce barriers to benefits that persons are entitled to. ☐ To better understand how the subgroups (African Americans, Youth, Seniors, LGBTQ, etc.) are affected by the city's EMP and by using an equity lens, identify actions that reduce the harm we cause. ☐ Strengthen policies and strategies regarding responding to Reasonable Accommodations request from our homeless disabled residents, also considering the lens of dignity and respect.
