## RECOMMENDATION

Staff Recommends That The City Council Receive The Informational Cash Management Report For Fiscal Year 2024-2025 First Quarter Ended September 30, 2024.

## EXECUTIVE SUMMARY

As a continued best practice and in accordance with the City's Investment Policy, the Finance Department submits a quarterly informational cash management report to the City Council. For Fiscal Year 2024-2025 First Quarter ending September 30, 2024, the City's Operating Pool Portfolio had a balance of \$1.97 billion and yielded 4.55 percent, while the Successor Agency's Portfolio had a balance of \$16.98 million and yielded 5.08 percent.

## BACKGROUND / LEGISLATIVE HISTORY

The Cash Management Report summarizes the characteristics of the investment portfolios for the quarter. The City and Successor Agency's Portfolio composition includes safety, creditworthiness, liquidity, and diversity. As of September 30, 2024, the portfolios comply with the Investment Policy of the City for Fiscal Year (FY) 2024-25. The portfolios' credit quality remains high and well within Investment Policy parameters. Liquidity remains sufficient to meet projected cash flow needs for the next six months.

**Attachment A** provides each portfolio's current market value and yield as of September 30, 2024, as well as comparisons to other market benchmarks. This report confirms that no leverage (use of debt to supplement investments) was utilized, nor were derivatives (such as interest rate swaps, futures, or options) held during the reporting period. Also included are reviews of key economic factors that may affect the portfolio's potential investment results.

## ANALYSIS AND POLICY ALTERNATIVES

#### **Cash Position**

The City's Operating Pool Portfolio balances decreased from \$2.24 billion as of June 30, 2024, to \$1.97 billion as of September 30, 2024. This net balance decrease was mainly due to the following: receipt of \$25.26 million in property tax revenues, offset by debt service payments of approximately \$85.56 million. The remaining balance decrease of approximately \$209.09 million is due to the receipt of other revenues, such as Sales Tax, offset by operational expenses, such as payroll and vendor payments.

The Successor Agency's portfolio decreased from a balance of \$19.96 million as of June 30, 2024, to a balance of \$16.98 million as of September 30, 2024. The portfolio decreased mainly due to the transfer of \$5.28 million of ROPS excess bond proceeds per the Bond Expenditure Agreement.

The City's and Successor Agency's investment portfolios are effectively managed for safety, liquidity, and yield in compliance with the City's Investment Policy, which supports the Citywide priority of **responsive and trustworthy government**.

#### Yield Comparison

The effective rate of return on total assets in the City's Operating Pool Portfolio for the month ending September 30, 2024, was 4.55 percent. The effective rate of return on total assets in the Successor Agency's Portfolio for the month ending September 30, 2024, was 5.08 percent. The yields differ between the City and Successor Portfolios because the Successor Portfolio has a lower fund balance and a shorter investment horizon due to cash flow needs. The City Portfolio has a more stable long-term investment horizon, allowing for longer-term securities that typically have higher yields. Note that the current yield curve is relatively inverted, and short-term securities are yielding higher returns than long term securities.

The City Portfolio outperformed the one-year government agency benchmark, which had a yield of 4.23 percent, as the 1-year government agency yield has already priced in future interest rate expectations, and City Portfolio slightly underperformed the Local Agency Investment Fund (LAIF), which had a yield of 4.58 percent.

The performance comparison to LAIF, should be considered in the context of LAIF's historical tendency to lag market changes in rising and falling interest rate environments. Moreover, the City does not actively sell securities in the portfolio to take advantage of cyclical swings in the market, which could result in the loss of principal. Rather, the primary investment objective of the City for the portfolio is to maximize safety, liquidity, and return in that respective order.

## FISCAL IMPACT

This item is for informational purposes only and does not have a direct fiscal impact or cost.

#### SUSTAINABLE OPPORTUNITIES

The portfolios' credit quality remains high and well within the City's Investment Policy parameters. Liquidity for both portfolios remain sufficient to meet the City's projected needs.

**Environmental**: To the extent that new investment opportunities are found in companies if or when financially prudent that are involved in environmentally positive activities, the City will consider investing in these companies (i.e., Commercial Paper, Medium Term Notes, etc.) if permitted by the City Investment Policy.



#### I. ECONOMIC REVIEW

#### MARKET OVERVIEW

The Federal Open Market Committee ("FOMC") has been trying to bring down inflation since early 2021 toward the Committee's annual inflation rate of 2 percent over the longer run. At the September 2024 FOMC meeting, the Fed lowered interest rates by 50 basis points, easing monetary policy for the first time in more than four years. This lowers the interest rate target to a range of 4.75% to 5%. Economic variables are trending in the right direction indicating that economic activity has continued to expand at a solid pace. Labor market is less tight than pre-pandemic level in 2019, the unemployment rate has moved up but remains low. Inflation is much closer to Fed's 2 percent target even though it remains somewhat elevated.

According to the U.S. Department of Commerce, Real Gross Domestic Product (GDP) – the output of goods and services produced by labor – increased at a 2.8% annualized rate during the three-month period from July through September. Economists surveyed by Dow Jones had been looking for an increase of 3.1%. The pace of expansion was well above what U.S. central bank officials regard as the non-inflationary growth rate of around 1.8%. Consumer spending and federal government outlays were two of the biggest contributors to GDP growth.

The U.S. economy added far more jobs than expected in September. According to the Bureau of Labor Statistics, nonfarm payrolls surged by 254,000 for the month, up from a revised 159,000 in August and better than the 150,000 Dow Jones consensus forecast. Restaurants and bars led job creation for the month, with the hospitality industry adding 69,000 positions in September after averaging just 14,000 over the previous 12 months. The unemployment rate fell to 4.1%, down 0.1 percentage point. Strength in job creation spilled over to wages, as average hourly earnings increased 0.4% on the month and were up 4% from a year ago. Both figures were ahead of respective estimates for gains of 0.3% and 3.8%.

The Bureau of Economic Analysis reported that the U.S. consumer spending, which accounts for almost 70 percent of the economy rose 0.5% last month after an upwardly revised 0.3% gain in August. Consumer spending increased at a 3.7% annualized rate, the most since the first quarter of 2023. Economists polled by Reuters had forecast consumer spending advancing 0.4%.

According to a Commerce Department, the personal consumption expenditures price index (PCE) showed a seasonally adjusted 0.2% increase for the month of September, with the 12-month inflation rate at 2.1%, both in line with Dow Jones estimates. The Fed uses the PCE reading as its primary inflation gauge, which increased slightly and moved closer to the Federal Reserve's target of a 2% annual rate. Excluding food and energy, the core personal consumption expenditures increased 0.3% on a monthly basis.

The consumer price index, a broad gauge measuring the costs of goods and services across the U.S. economy, increased a seasonally adjusted 0.2% for the month, putting the annual inflation rate at 2.4%. Both readings were 0.1 percentage point above the Dow Jones consensus. The annual inflation rate was 0.1 percentage point lower than August and is the lowest since February 2021. Excluding food and energy, core prices increased 0.3% on the month, putting the annual rate at 3.3%. Both core readings also were 0.1 percentage point above forecast.

The Commerce Department reported U.S. consumer spending held up in September. Retail sales increased a seasonally adjusted 0.4% on the month, up from the unrevised 0.1% gain in August and better than the 0.3% Dow Jones forecast. Excluding autos, sales accelerated 0.5%, better than the forecast for just a 0.1% rise. Spending at miscellaneous store retailers grew by 4%, and 1.5% at clothing stores. Those increases offset a 1.6% drop at gas stations as fuel prices fell, along with a 3.3% decline at electronics and appliances stores.

The Conference Board's Consumer Confidence index slid to 98.7, down from 105.6 in August, the biggest one-month decline since August 2021. The Dow Jones consensus forecast was for a reading of 104. Consumer's assessments of current business conditions turned negative while views of the current labor market situation softened further. Consumers were also more pessimistic about future labor market conditions and less positive about future business conditions and future income. Respondents to the survey said jobs are plentiful continued to decline, falling to 30.9% from 32.7% in August, while the jobs "hard to get" measure rose to 18.3%, up from 16.8%.

The Institute for Supply Management's Purchasing Managers' index (PMI) remained unchanged in September compared to the previous month at 47.2. U.S. manufacturing held steady at weaker levels, but new orders improved and prices paid for inputs declined to a nine-month low. It was the sixth consecutive month that the PMI remained below the 50 thresholds, but above the 42.5 level that the ISM said over time generally indicates an expansion of the overall economy.

According to the Labor Department's Bureau of Labor Statistics, U.S. producer prices index (PPI) which measures what producers get for their goods and services, was flat for the month of September and up 1.8% from a year ago. Economists surveyed by Dow Jones had been looking for a monthly gain of 0.1% after August's increase of 0.2%. Excluding food and energy, the PPI rose 0.2%, meeting expectations, and was up 2.8% from a year ago. Within the PPI, a 0.2% decline in final demand goods prices offset a 0.2% increase in services.

According to the Labor Department's Bureau of Labor Statistic, U.S. import prices slipped 0.4% in September, the biggest drop since December 2023, after a 0.2% decrease in August amid a sharp decrease in the cost of energy products. In the 12 months through September, import prices dipped 0.1%. Imported prices of fuels and lubricants plunged 7.0% while imported natural gas prices plummeted 14.5%. Food prices also dropped 1.5% in September. Excluding fuels and food, the so-called core imported prices gained 0.3% and increased 1.7% year-on-year in September.

According to data released by the Census Bureau, U.S. homebuilding or housing starts dipped 0.5% in September fell to a 1.35 million annual pace from 1.36 million in August, matching what Wall Street was expecting. The overall figure was dragged down by a drop in multi-family construction. Single-family home construction grew slightly in September. Building permits, a sign of future construction, fell 2.9% to a 1.43 million rate. Permits applied for by builders to construct single-family homes inched up 0.3% in September, while permits to build multi-family homes dropped by 10.8%.

U.S existing home sales fell 1% in September compared with August. According to the National Association of Realters, sales of previously owned homes were 3.5% lower than a year ago to an annual rate of 3.84 million in September, which is the lowest level since October 2010. The median price of an existing home sold in September was \$404,500, an increase of 3% year over year and the 15th consecutive month of annual price gains.

According to U.S Census Bureau and the Department of Housing and Urban Development, sales of newly built homes in September jumped 4.1% to a seasonally adjusted annual rate of 738,000 units last month, the highest level since May 2023. Mortgage rates fell in September, dropping to more than a 1-1/2-year low by the end of the month as the Federal Reserve began cutting interest rates. The median new house price was unchanged at \$426,300 in September from a year earlier. New home sales rose in the Northeast and the densely populated South but fell in the Midwest and were unchanged in the West.

### INTEREST RATES

During the third quarter of 2024, the Federal Open Market Committee "FOMC" met on July 30<sup>th</sup> and September 17<sup>th</sup>. At the September meeting, the Federal Reserve lowered interest rates by 50 basis points to a range of 4.75% to 5.00%, easing monetary policy for the first time in four years due to progress on the Fed's dual mandate. The Committee has gained greater confidence that inflation is moving sustainably toward 2%, and judges that the risks to achieving its employment and inflation goals are roughly in balance. The Federal Reserve (Fed) will continue to reduce its holdings of U.S. Treasury securities and agency mortgage-backed securities, under the updated monthly cap of \$25 billion and \$35 billion, respectively.

The FOMC will continue to take into account a wide range of information including readings on labor market conditions, inflation pressures, inflation expectations, and financial and international developments. Projections from the FOMC participants also showed a median cut of an additional 50 basis points across the remaining two meetings this year, followed by 100 basis points of cuts in 2025 and 50 basis points more in 2026 to a terminal rate of 2.9%, where they anticipate rates to remains through 2027.

#### II. CITY OF OAKLAND

#### PORTFOLIO REVIEW

The City's Operating Pool Portfolio balances decreased from \$2.24 billion as of June 30, 2024, to \$1.97 billion as of September 30, 2024. This net balance decrease was mainly due to the following: receipt of \$25.26 million in property tax revenues, offset by debt service payments of approximately \$85.56 million. The remaining balance decrease of approximately \$209.09 million is due to receipt of other revenues, such as Sales Tax offset by operational expenses such as payroll and vendor payments.


#### PORTFOLIO COMPOSITION

The Portfolio continues to comply with all provisions of the City's adopted Investment Policy for Fiscal Year 2024-25, including compliance with applicable local ordinances and resolutions such as Nuclear Free Zone, Linked Banking, Tobacco Divestiture, Fossil Fuels, and Guns/Ammunition.

The following discussion addresses the City's operating pool portfolio characteristics in terms of the Investment Policy's four objectives: safety, liquidity, diversity, and return. Portfolio detail for each month of the current quarter is attached to this report.

<u>Preservation of Capital/Safety.</u> In the chart below, the City's holdings are depicted by credit rating category as of September 30, 2024. Approximately 75.63% of Operating Pool investments were rated in the AA/Aaa category while 16.79% in AAA/Aaa, 3.81% primary unrated holdings represent the Fund's investments in the Local Agency Investment Fund ("LAIF"), 3.77% in the A1/P1 category and none in A1/A category. The government agencies were downgraded by Standard and Poor's Rating Agency to AA+ from AAA in 2011 and S&P has maintained its AA+ rating as of September 30<sup>th</sup> 2024 Moody's Investors Service and on August 1<sup>st</sup> 2023, Fitch Ratings downgraded to AA+ ratings for government agencies.

The City's Investment Policy for FY 2024-2025 does not have a rating criteria level for government agencies.



<u>Liquidity.</u> Liquidity continues to be a primary objective when making investment decisions for the Operating Pool portfolio. With ongoing capital projects at the Port and within the City, and to ensure that sufficient liquidity is available to meet day-to-day expenditures, the City maintains a sufficient "cushion" in money market funds to meet unanticipated project expenditures.

Debt service payable from the City's Operating Pool for the Port and the City for the six months following September 2024 is approximately \$74.48 million. Consequently, staff will continue to invest in short-term instruments and money markets as investment tools to maintain adequate short-term liquidity.


Investments maturing over the next six months are as follows:

Investments maturing within 180 days include \$75 million in LAIF and \$333.47 million in money market funds, both of which are considered to have a one-day maturity due to the ability to withdraw funds daily.








<u>Diversity.</u> To reduce the risks of investing, the portfolio is diversified among a variety of financial instruments, as depicted by the following chart. In addition to limiting the types of investments permissible in any one category as outlined in the Investment Policy, no more than 5% of the total cash portfolio may be invested in any one issue. This single-issue provision does not apply to money market funds or to LAIF, as they each are backed by a large portfolio of highly diversified assets.

<u>Derivatives.</u> The Operating Pool Portfolio contained no derivative instruments (interest rate swaps, futures, or options) during this reporting period.

<u>Yield.</u> Total interest earned for the quarter ended September 30, 2024, was \$23,852,092. The effective rate of return on total assets in the Operating Pool Portfolio for month-end September 30, 2024, was 4.55% as compared to 4.63% for June 30, 2024. It continues to be the City's practice to hold investments to maturity rather than to sell. The primary investment objective of the City for the portfolio is to maximize safety, liquidity, and return in that respective order.

Comparative yields for the quarter are shown below.

## Benchmark Comparison:

The effective rate of return on total assets in the Operating Pool Portfolio for the month ending September 30, 2024, was 4.55 percent. The City's Operating Pool Portfolio had outperformed the 1year government agency which yielded a rate of 4.23 percent, as the 1-year government agency yield has already priced in future interest rate expectations. The City's Operating Pool Portfolio underperformed the Local Agency Investment Fund ("LAIF"), which ended the month at 4.58 percent.

The Alameda County Pool had a preliminary accrual basis rate of return for September 2024 of 3.84 percent. The Alameda County Pool had a Portfolio of \$9.7 billion with 752 days to maturity, meanwhile the City's Operating Pool had an accrual rate of return of 4.55 percent for September 2024. The City Operating Pool had a Portfolio of \$1.97 billion with 215 days to maturity.

As of September 30, 2024, the City Operating Pool's average days-to-maturity (ADM) was 215 days versus LAIF's average days-to-maturity (ADM) was 231 days.

The performance comparison to LAIF must be considered in light of LAIF's historical tendency to lag market changes in both rising and falling interest rate environments. The City does not actively sell securities in the portfolio to take advantage of cyclical swings in the market, which could result in the loss of principal. The primary investment objective of the City for the portfolio is to maximize safety, liquidity, and yield in that respective order.


<u>Valuation and Leverage</u>. Based on information received from Interactive Data Corporation, the market value of the City Operating Pool portfolio was \$1.97 billion, which was above the book value by \$8,851,995. There was no leverage in the portfolio during the reported period, and liquidity was maintained at sufficient levels.

The City's investment strategy, per the Investment Policy, is generally to hold securities to maturity. The net unrealized gain (loss) noted above are "paper gains or paper losses" where there is an inverse relationship between the changes in market interest rates to the value of fixed income investment securities.

The graph below reflects estimated cash balances that breakdown certain funds that primary make up investment portfolio as reflected in the City's Financial System (Oracle). This cash balances are approximate as the period is not closed and balances are not audited.

## III. CITY OF OAKLAND REDEVELOPMENT SUCCESSOR AGENCY PORTFOLIO

#### PORTFOLIO REVIEW

The Successor Agency's portfolio decreased from a balance of \$19.96 million as of June 30, 2024, to a balance of \$16.98 million as of September 30, 2024. The portfolio decreased mainly due to transfer of \$5.28 million of ROPS excess bond proceeds per the Bond Expenditure Agreement.

#### PORTFOLIO COMPOSITION

The Portfolio continues to comply with all provisions of the City's Investment Policy for Fiscal Year 2024-2025, including compliance with applicable local ordinances and resolutions such as Nuclear Free Zone, Linked Banking, and Tobacco Divestiture. In addition, the City will consider investing, when possible, in companies that promote the use and production of renewable energy resources and any other type of socially responsible investments.


The following discussion addresses the Successor Agency's investment portfolio characteristics in terms of the Investment Policy's four objectives of safety, liquidity, diversity, and return. Portfolio detail for each of the months in the current quarter is attached to this report.

#### Preservation of Capital/Safety

The Successor's holdings by credit rating category are depicted in the chart below. Approximately 11.78% of Operating Fund investments were rated in the AAA/Aaa, while 88.22% were rated AA/Aaa. The government agencies were downgraded by Standard and Poor's Rating Agency to AA+ from AAA in 2011 and S&P has maintained its AA+ rating as of September 30<sup>th</sup> 2024. Moody's Investors Service and on August 1<sup>st</sup> 2023, Fitch Ratings downgraded to AA+ ratings for government agencies.

The City's Investment Policy for FY 2024-2025 does not have a rating criteria level for government agencies.

<u>Liquidity</u>. Liquidity within the Successor's Portfolio remains sufficient to meet only debt service needs of the Successor for the next three months and beyond. The debt service payment for the next six months for the Successor is approximately \$4.79 million. The estimated 6-month cash flow for Successor Portfolio is summarized below:





<u>Diversity.</u> To reduce the risks of investing, the portfolio is diversified among a variety of instruments, as depicted by the following chart. In addition to limiting the types of investment in any one category, as outlined in the Investment Policy, no more than 5 percent of the total cash portfolio may be invested in any one issue.



Derivatives. The Successor Portfolio contained no derivative instruments during this reporting period.

<u>Yield.</u> The Total interest earned for the quarter ended September 30, 2024, was \$222,192. The effective rate of return on total assets in the Successor's Portfolio was 5.21 percent for the month ending September 30, 2024. The Successor's Portfolio outperformed the 1-year government agency which yielded a rate of 4.23 percent as of September 30, 2024. The Successor's Portfolio outperformed the Local Agency Investment Fund ("LAIF"), which ended the month at 4.58 percent. The performance comparison to LAIF must be considered in light of LAIF's historical tendency to lag market changes in both rising and falling interest rate environments. The Successor Portfolio has an extremely short duration due to liquidity concerns/needs, thus was able to only generate short-term returns in comparison to LAIF and was slightly below the 1-year government agency, which includes future interest rate expectations priced in.

As of September 30, 2024, Successor's Portfolio Fund's average days-to-maturity (ADM) was 0 days versus LAIF's average days-to-maturity (ADM) of 231 days.


