GoNavia Commuter Benefit Program



The GoNavia Commuter Benefit Program allows you to pay for your work-related parking and transit expenses using pretax dollars. **Navia Benefits Solution** administers our Commuter Benefit Program.

How It Works

Commuter benefit orders are deducted from your paycheck on a pre-tax basis and can be loaded onto a Navia Benefits Card or your Clipper Card. The Navia Benefits Card can be used to purchase services at any transit or parking facility that accepts MasterCard. As a month-tomonth benefit, you can opt in and out or change your benefit election amounts at any time based on your transit and parking needs.

Orders must be placed by 11:59 p.m. on the 20th of the month for commuter benefits for the following month. For more information, please refer to the attached FAQs or <u>Commuter</u> <u>Summary Plan Description</u>.

How To Enroll

- Step 1: Access The Navia website at https://www.naviabenefits.com/
- Step 2: Register your account
 - Click on the "Register" (upper right hand side of screen)
 - Click "I'm A Participant"
 - Complete the online registration form. Use "OKL" for the Employer code.
 - Shortly after submitting your registration you will receive an email confirmation with a temporary password.
- Step 3 Log on to the Navia portal.
- Step 4 Click "place commuter order (under the "GoNavia Program" section)
- Step 5: Click "**Place An Order**" for the type of benefit (transit and/or 0arking) you wish to order.
- Step 6: Select your benefit and amount.
- Step 7: Select whether you want to order for only a single monthly or recurring monthly (if selecting recurring monthly, select months you want to order automatically)
- Step 8: Confirm your order then click "submit"

Commuter Benefits Program FAQs

1. What expenses are eligible?

The Go Navia Commuter Benefit covers your work-related public transit and parking expenses including, but not limited to:

- Buses
- Ferries
- Parking lots and garages
- Trains

Ineligible expenses include non-work related expenses and individual transportation service like tax or a driving service.

2. What is the monthly "tax-free" limit?

The current limit for transit for 2024 is \$315 per month. The current limit for parking is \$300 per month. These monthly limits are subject to change per IRS regulations.

3. What is the deadline to place my commuter order for the following month?

Your order must be placed by 11:59 p.m. on the **20th of the month** for the following month's commuter benefits. For example, orders must be placed by December 20th for January's commuter benefits.

4. Can I change or stop my commuter order?

Yes, you may change, stop, or restart your commuter order at any time. Changes must be made by 11:59 p.m. on the **20**th of the month to be effective the following month.

5. Do I need to place my order each month?

No, the GoNavia Commuter program can be set up with recurring elections for transit and/or parking. You can even pre-select certain months elect the benefit. You will receive an email order reminder prior to the order being processed.

6. Where can I use my Navia Benefits MasterCard for transit or parking?

You may use your Navia Benefits MasterCard at transit authority websites, kiosks, ticket offices, or parking merchants that accept MasterCard, respective to the benefit you've ordered.

7. What happens to the transit and/or parking balance on my Navia Benefits MasterCard at the end of the benefit month?

The balance will roll over from month-to-month as long as you are an active employee and remain eligible for this benefit.

8. When are commuter benefit payments deducted from my paycheck?

Commuter benefit deductions are taken from the paycheck that corresponds with the 2nd Pay Period Ending of each month. Below is the 2024 deduction schedule.

9. What happens to the transit and/or parking balance on my Navia Benefits MasterCard when I leave the City of Oakland?

After your employment with the City of Oakland ends, commuter funds remaining on your Navia Benefits MasterCard are forfeited.

10. How do I set up automatic monthly payments with my parking garage?

You may use your Navia Benefits MasterCard to set up automatic monthly parking payments with your parking garage. Please contact your parking garage to inquire about setting up automatic monthly parking payments with your Navia Benefits MasterCard.

Employees who park at garages managed by the **City of Oakland Parking Partners** (**COOP**) may set-up an auto-pay account with the Navia Benefits MasterCard by calling the COOP at (**510**) 874-7170.
