On December 17, 2024 the Oakland City Council voted to eliminate the General Purpose Fund allocation for the Cultural Funding Program. This memo outlines three scenarios for allocation of the Transient Occupancy Tax funds available for cultural grants. In consideration of their duties as advisors, Commissioners are requested by staff to review the three scenarios and recommend how staff should proceed in deploying available resources. Recommendations are contingent upon legal review and approval by City Councilmembers.

- Scenario #1: Optimizes Cultural Organization Grants and Permit Subsidies for Festivals
- Scenario #2: Maximizes Cultural Organization Grants with No Support for Festivals
- Scenario #3: Reduces Grantmaking and Expands Reach Through Technical Assistance

BACKGROUND

The Fiscal Year 2024-25 contingency budget included \$835,500 to be granted to cultural organizations to support general operating needs and festivals, including \$587,000 from the General Purpose Fund and \$248,500 from the Transient Occupancy Tax Fund. Through public peer reviews, 48 organizations were recommended for grants, pending the approval of allocations by City Council.

Due to a substantial City budget deficit, the general purpose fund allocation to the Cultural Affairs Division was reduced by \$683,532—an amount exceeding the planned general fund allocation for Cultural Affairs grants.

Currently, the remaining Transient Occupancy Tax Funds for FY24-25 is at or below \$188,000.

In public hearings, recommended awardees provided testimony on how the delay and reduction in funding has impacted them. Several cited reduced ability to provide services, including activities that provide access to culturally-responsive arts for low-income youth and seniors.

Compounding the impact of City cuts are both funding reductions and elimination of support for arts organizations from the state, private foundations, corporations, and individual donors. General operating grantees Sarah Webster Fabio Center for Social Justice and Youth Radio DBA YR Media have announced their closure in the last several months. Furthermore, in site visits two organizations disclosed that they have reduced staff and/or worked reduced hours.

FUNDING AVAILABLE

The funding available for FY24-25 is limited to the unobligated Transient Occupancy Tax funds.

GRANTMAKING SCENARIOS

The scenarios listed below take into account:

- ♦ Access to Arts & Culture:
 - <u>Visitor attraction</u>: Our General Operating grantees conduct year-long programming and special events that attract thousands of visitors to Oakland.
 - Benefit to Oaklanders: Our General Operating grantees conduct year-long programming across
 the City, maintaining a consistent presence for Oaklanders. These programs include providing
 impactful arts education for thousands of Oakland students and providing services, support,
 and employment to Oakland artists.
- ♦ <u>Effectiveness</u>: How can the Division maintain the objectives of the funding programs with limited grant dollars? What approach will minimize administrative costs and preserve the most positive impacts for Oakland residents and visitors?
- ♦ Contracting with the City of Oakland: Receiving a grant of any amount from the City of Oakland requires that the organization go through the City's contracting process. This process may include outlining the organization's activities and compliance to City regulations, signing a 19-page grant agreement, providing a business tax certificate, and maintaining good standing with all state agencies.

Furthermore, the organization needs to meet all City insurance requirements as enforced by the Risk Department. Meeting the City's insurance requirements can range from \$500-\$5,000+ annually depending on the organization's scope of work. The entire contracting process can take one to six months to complete and needs to be reviewed by as many as seven employees representing four City agencies.

- <u>Festival Permit Fees:</u> The cost of City fees for festivals can range widely depending on the festival scope, location, and expected attendance. Below are the most common fees and their price range:
 - Special Event Permit Fees: \$94 to \$5,562
 - Fire inspection/permit fees: \$357 to \$2,550
 - Oakland Police Department (OPD) services: Starting at \$3,000 and can exceed \$15,000

Transient Occupancy Tax funds cover permit fees for a select few Oakland Festivals via the Special Activities Division. Festivals already receiving permit subsidies through the Permit Festival Fund are excluded from the scenarios listed below. Staff are exploring updates to the Fairs and Festival Fund eligibility process.

We invite the Commission to discuss and evaluate the scenarios on the following pages (4-6) and we welcome your funding (or other) recommendations to disburse the limited FY24-25 resources. Oakland City Council has approving authority and can request modifications to the Commission's recommendations.

Scenario #1: Optimizes Cultural Organization Grants and Permit Subsidies for Festivals

Pros:

- Provides support in various ways to all groups originally recommended for funding
- Limits the amount of contracting labor on organizations and staff by providing Festival subsidies rather than grants (referenced above on page 2)

Cons:

- Festivals recommended for funding would not receive grants
- Oakland's cultural anchors will receive less financial support since the grantmaking dollars are being bifurcated between General Operating Support grants and Festival subsidies

Notes:

- Two organizations originally recommended for General Operating Support funding have sunsetted
- Festivals already receiving permit subsidies through the Permit Festival Fund are excluded from this list

Pros:

- Oakland's anchor cultural organizations receive more support
- Limits the amount of contracting labor on organizations and staff (referenced above on page 2)

Cons:

• Festivals recommended for funding would not receive any financial support from the Division

Pros:

- Expands the Division's reach to support more members of Oakland's cultural community through Technical Assistance
- Limits the amount of contracting labor on organizations and staff (referenced above on page 2)

Cons:

- Fewer grant dollars going to arts organizations
- Fewer dollars supporting Festival permit subsidies

Technical Assistance & Training for Cultural Community

To stretch limited resources while adding value for Oakland's arts and culture community, the Cultural Affairs Division is exploring technical assistance (TA) programming based on needs expressed by recommended awardees. Technical assistance refers to any specialized service or skill that a nonprofit may need to extend the reach or deepen the impact of their activities. TA is especially critical as nonprofits are reimagining their operations or programming, exploring ways to sustain and/or grow operations, or seeking to enhance team skill sets. The Cultural Funding Program is meeting with TA providers and exploring possibilities for TA implementation next year.

NEXT STEPS

Deploy the financial resources currently available in FY24-25 and offer support beyond dollars to grantees and the wider arts and culture community in Oakland. Continue supporting arts and culture organizations through letters of recommendation, event promotion, networking opportunities, City navigation assistance, and beyond.

RE: Grant recommendations for FY24-25:

- **April:** Presentation at Life Enrichment Committee Meeting (LEC) to have revised grant recommendations reviewed.
- April: City Council approves grants (pending LEC review and recommendation)
- April/May: Cultural Affairs staff begin grant contracting process

RE: Other activities:

- Engaging with philanthropic partners to seek additional funding for these organizations. This engagement includes individual meetings with contacts at private foundations and collaborating with colleagues in the Arts Loan Fund and Just City initiatives.
- Pamela Mattera, Assistant Cultural Funding Coordinator, attended a Technical Assistance gathering
 hosted by the Zellerbach Foundation on January 30, an opportunity to advocate for and expand the TA
 opportunities for Oakland's cultural community.

ATTACHMENT A: Grant Program Descriptions

The **Cultural Organization Assistance program (OA)** is a two-year grant opportunity that supports Oakland-based 501(c)3 non-profit arts and culture organizations. Priority funding goes to groups deeply rooted in Oakland communities with general operating support. Twenty-seven awardees were originally recommended for renewal in FY24-25, reflecting \$567,000 in total grant awards.

Organization Assistance grant recommendations include groups who:

- Present forms of artistic expression which enhance the understanding of and respect for Oakland's diverse cultural traditions and heritages;
- Foster collaboration between Oakland community groups, artists, and organizations;
- Encourage the creative development and artistic education of Oaklanders;
- Work to advance cultural and racial equity in Oakland; AND
- Maintain a consistent presence and benefit for Oakland Communities.

Neighborhood Voices for Festivals is a grant opportunity that builds belonging in City of Oakland neighborhoods through culturally-engaged festivals. This grant program amplifies the cultural expressions, stories, and heritage found within Oakland's neighborhoods and their community members who historically have not received equitable investments of resources or recognition. This program supports in-person Oakland arts and cultural activities that are free and open to the public. Twenty-one organizations were originally recommended for funding in FY24-25, reflecting \$268,500 in total grant awards.

FY24-25 Neighborhood Voices for Festivals grant recommendations include:

- Festivals that lift up the cultural identity of a people or the historical significance of a neighborhood;
- Festival partners who are deeply grounded and engaged in the neighborhood where the festival is based; and
- Festivals that reinforce Oakland as a cultural destination.

These Oakland-based arts organizations create and facilitate community-oriented arts activities that sustain the cultural arts identity of Oakland, fortifying the City as a destination, bolstering the creative economy, and creating positive publicity resulting in economic benefit.
