

- ➡ 670 full-time and part-time employees.
- ➡ Four Bureaus, each led by an Assistant Director.
- The Assistant Directors oversee Division Managers, who in turn oversee Program Supervisors.
- Plans, builds and maintains Oakland's physical and environmental infrastructure for residents, businesses and visitors, making Oakland a sustainable and desirable place to live, work, invest and visit.

- 400 miles of storm drains and 11,500 structures
- 80+ miles of open creek
- 919 miles of sewer pipes
- 11 Sewer pump stations
- 309 Public Buildings, 140 City parks; and 27,000 structures
- 100+ street medians
- 42,600 official street trees
- All open space & park trees
- Implementing environmental priorities for the City
- Managing our solid waste and recycling franchise agreements
- Supporting our Adopt-a-spot program.
- Cleaning 1,100 miles of City Streets
- Fleet & Equipment: 1,575 vehicles & pieces of equipment including fire trucks & police cars


Parks and Grounds Maintenance

- Landscape maintenance, litter removal and homeless encampment abatement for 134 parks and public spaces
- Two region-serving parks, nine community parks, 53 neighborhood parks, 15 special use parks, 26 athletic fields, plus many mini-parks, linear parks, and public grounds.
- 1,055 acres of Resource Conservation Area (open space)
- 100 landscaped medians and streetscapes



Tree Management and Maintenance

- 250,000 trees; 55,000 are street trees, trees in public parks, medians, streetscapes
- Processes over 300 tree permits annually under the City's Protected Tree Ordinance
- Priority One Service only = Fallen tree or branch that poses an immediate hazard
- Tree Inventory and Urban Forest Master Plan

Building & Facilities: Management and Maintenance

- Provides full-spectrum facilities support custodial services, security, preventative and general maintenance, and repairs/modifications
- 300 City-owned buildings (estimated 2.5 million square feet)
- Lead in managing City's efforts to ensure safe and healthy working environments in response to COVID-19 pandemic.
- Two Capital Improvement Project (CIP) Funds- Minor CIP (MCIP) and Emergency CIP (ECIP)



Watershed and Stormwater Management

- 402 miles of pipe range from 6" to 98" in diameter
 15,000 structures, approximately 200 trash capture
 devices such as hydrodynamic vaults and inlet screens
- Over 80 miles of open creek
- Facilitating compliance with the City's National Pollutant Discharge Elimination System (NPDES) stormwater discharge permit
- Undertaking development of a new Storm Drainage Master Plan.



Full title: The 2020 Oakland Parks and Recreation Preservation, Litter Reduction, and Homelessness Support Act

- Passed in March 2020 and authorizes a 20-year annual special parcel tax
- Funding to be directed:
 - 64% for parks, landscape maintenance, and recreational services
 - 30% for services to address homelessness
 - 5% for services and projects to address water quality and litter reduction
 - 1% to cover costs of auditing and evaluation programs
- Citizen oversight performed by PRAC, as decided by the City Council
 - Additional oversight: City Auditor's Audit, Annual Financial Audit

- Meeting monthly to start
- Will invite community presenters
- Initial discussion topics have included:
 - Accountability and transparency expectations,
 - What a proactive vs. responsive role for PRAC might be,
 - Developing a timeline for progress, and
 - OPW providing more fiscal details.




