# SERVICE CATEGORY DESCRIPTIONS

24-hour hotlines 24-hour hotlines provide immediate counseling and service referrals to individuals experiencing intimate partner violence, commercial sexual exploitation, and sexual assault. Service referrals may be related to immediate safety needs or long-term support.

## Bedside advocacy and accompaniment

Bedside advocates respond to individuals in crisis to support them in navigating systems and accessing helpful resources. Advocates make warm-handoff referrals to services whenever possible.

## Emergency shelter

Emergency shelter services provide survivors of genderbased violence with safe, temporary housing through shelter beds, hotel vouchers, or financial support with relocation out of Oakland.

# Legal advocacy

Legal services for survivors of intimate partner violence include legal advice and counseling, preparation of legal paperwork, preparation and filing of temporary restraining orders and orders of protection, and full representation at court hearings. Legal services for survivors of commercial sexual exploitation include legal representation in court and services related to immigration.

## Life coaching

Gender-based violence life coaching services support individuals who have experienced commercial sexual exploitation with identifying and completing goals that reduce their risk for future victimization. Life coaches support clients with system navigation, service referrals, socio-emotional skill development, and strengthening family ties. Life coaches have frequent contact with their participants and use financial incentives to encourage positive behavior change.

## Safe space alternatives

Safe space alternatives provide a physical space where youth who have experienced commercial sexual exploitation, LGBTQ+ youth, and gendernonconforming youth can access food, hygiene products, support groups, a place to rest, and other helpful resources.

# Therapeutic support

Therapeutic support services provide individual clinical therapy, support groups, and non-western healing practices to survivors of gender-based violence.

## Transitional housing

Transitional housing services support survivors of genderbased violence in accessing up to 18 months of safe temporary housing and subsequent support securing permanent housing.
