



Greetings Neighbor,

Before we get into news on upcoming events and important announcements, I want to address an unfortunate reality that has become ever more present in our district and citywide. Over the past couple of months there have been a number of property crimes and violent robberies in parts of North Oakland and in several other neighborhoods

in Oakland. This has not gone unnoticed by our office and we have worked hard to bring this to the attention of law enforcement personnel.

The Oakland Police Department (OPD) and our Department of Violence Prevention (DVP) are certainly aware of these crimes and, while there is not just one underlying reason associated with all these incidents, the City of Oakland is committed to doing our best to investigate all serious crimes and increase visibility in impacted neighborhoods.

Community Resource Officers (CROs) have been working in conjunction with our Area patrol officers and the community on obtaining investigative leads and evidence related to recent robberies, burglaries and catalytic converter thefts.

As available resources are often competing with addressing 911 calls for service, OPD also has directed uniformed officers from non-patrol investigative or other units to spend time assisting with prioritized hotspots, visible patrols, investigative follow-up, etc. to increase the number of officers visible and working on the street.

D-1 staff and I meet regularly with the OPD Area 2 captain and DVP senior staff to discuss recent crime trends in Council District 1, OPD response and investigation, and implementation of DVP short and long-term strategies.

Additionally, our Mobile Assistance Community Responders of Oakland (MACRO) can provide a timely response to nonviolent, lower-level incidents. By increasing the resources for MACRO and our Department of Violence Prevention over time, we are supporting the ability of the MACRO teams to address nonviolent calls, which allows the Police Department to focus more focus on violent crime. And by increasing the number of violence interrupters and other key staff with the Department of Violence Prevention, we have resourced a reduction of violence over time. These policy decisions will reduce crime overall, help reduce violent crime in particular and facilitate MACRO responding to low-level, nonviolent incidents.

\*\*\*School Board Director Sam Davis and I will be hosting a Community Town Hall on Public Safety on Tuesday, May 30th at 6:30 pm at Oakland Tech H.S. Representatives from OPD and our Dept. of Violence Prevention will be present.

The Mayor recently presented her City Budget to the City Council. While we are facing a historic budget shortfall, her proposed budget does not call for layoffs of any City staff, including police officers. Additionally, I am pushing to prioritize filling positions at our 911 dispatch center.



# Mayor Sheng Thao Introduces Proposed 2-yr Budget + D1 Budget Town Hall

On May 1, 2023, Mayor Thao submitted her budget to the City Council. On Wednesday May 3<sup>rd</sup>, the City Council met to hear a presentation and ask initial questions. <u>Click here</u> to watch a video of that meeting. Your input at this stage would be

helpful. The City is facing a \$274 million dollar shortfall. Fortunately, this budget does not propose any layoffs, which could have led to serious reductions in service. That said, the City Budget is a critical piece of legislation that outlines spending priorities for the next two years.

I have scheduled a **Budget Town Hall** to discuss the proposed budget, how it will impact Oaklanders, and what residents would like to see in the final adopted budget. # Do you want to help oversee the Oakland Police Department?

Apply now to be on the Police Commission, which has the authority to revise certain OPD policies and oversee police discipline. It can take a significant time commitment in meetings, meeting prep, and committee work, but you can help bring fair and just policing to Oakland communities.

Commissioners must be over 18 and live in Oakland. They cannot be current police officers or City employees. A high school diploma is not required, and formerly incarcerated people are eligible to apply.

# A Message From Public Bank East Bay

A public bank could be the best way to react to the failures and flaws of our banking system. East Bay residents would be stakeholders in how our public money is used. Instead of passively waiting to see how hard the next economic crisis hits the East Bay, our regional & state public banking alliances are actively working to create new public banks that can keep city money flowing back into our communities by handling our public tax and fee money in a responsible, transparent, and accountable system.

The Friends of the Public Bank East Bay are drafting a business plan for a local Public Bank, a transformative economic institution governed by a board of at least ten proven community leaders along with public representatives from Oakland, Berkeley, Richmond and Alameda County. The Friends of PBEB presented to the Alameda County supervisors and staff on April 4<sup>th</sup>. In a historic collaboration between

community leaders, municipal representatives and the Friends of PBEB the business plan for a regional Public Bank will be finalized and submitted for the necessary regulatory approvals in the next several months. Once approved, the new Bank would be a game changer and have the power to help improve the economics of the region and the lives of many residents.

#### **Wood Street Update**

After three weeks of transitioning Wood Street encampment residents (with their pets) to safe shelter programs with supportive services, the City of Oakland completed the court-authorized closure of the City-owned Wood Street parcel that began April 10. All people and their belongings are safely off the parcel.

"Safety and securing dignified shelter for every resident were our primary goals in this closure," said Mayor Sheng Thao. "I am grateful we achieved both and thankful for the collective efforts of the many staff in City Departments, Alameda County agencies, Operation Dignity, and community partners who contributed to this massive effort."

As of today, 57 people out of an initial census of approximately 70 individuals living at the Wood Street encampment have accepted shelter services. 46 residents have accepted shelter at the Wood Street cabin program and eleven have elected to move to a Safe RV Parking program.

The City's cross-departmental Encampment Management Team worked together to achieve this important milestone. Public Works removed approximately 700 tons of trash and debris and OakDOT's new Vehicle Enforcement Unit removed 39 vehicles, including nine stolen vehicles, from the site. Environmental Services was on hand to safely handle potentially hazardous materials and Oakland Fire Department extinguished several small fires in the encampment. Oakland Police Department helped provide critical public safety support.

The City closed the approximately three-acre encampment on the City-owned parcel to enable construction of the approved development of 170 units of permanent affordable housing.





#### **Sideshows**

The Oakland City Council recently passed a new ordinance to deter sideshows, making it a crime to organize and facilitate sideshows. "Public Safety is and must be a top priority for me and all of us in City Hall," said Councilmember Dan Kalb. "This law will give the City of Oakland an additional tool to protect Oaklanders from the dangers of these ridiculous and destructive sideshows."

In addition to criminal penalties, the law creates civil penalties (fines) that will give the city the authority to address the costs and damages caused by sideshows, and hopefully deter these from happening in the first place. These are critical as the City of Oakland will be able to hold organizers and facilitators of sideshows accountable and impose fines and collect compensation for damages caused by sideshows.

Councilmember Kalb ensured that participant-drivers, who are already engaged in reckless driving as a crime, can also be assessed civil fines for their destructive and dangerous behavior. Kalb also made the sure new law focused on those most responsible for this behavior—the organizers and facilitators—in addition to the drivers.

A "sideshow" is an event in which two or more persons block or impede traffic for the purpose of performing motor vehicle stunts, speed contests, or reckless driving. Sideshows cause significant damage to city infrastructure by destroying intersection markings, street signs, poles, and other equipment. Sideshows are extremely dangerous to people in the immediate vicinity and people have indeed been injured at some of these gatherings. Sideshows necessitate extraordinary police response costs that divert officers from responding to other emergencies in a timely fashion. Sideshows can drastically impact people's quality of life and create an unsafe environment for the neighborhoods in which they occur while attracting hundreds of people from outside of Oakland who have no stake in our community.


The City Council voted unanimously to support this legislation. Thank you to Councilmember Gallo for spearheading this effort. Final passage will occur at second reading scheduled for June 6th.

## **Spring Clean Review**

This month the "One Oakland Spring Clean" was successful in raising awareness about City services that help make Oakland cleaner and safer—not through words, but through action. Each day, our staff came out in force to show Oaklanders our commitment to the communities we serve.

This was an effort that required collaboration across City departments and agencies, including Oakland Department of Transportation (OakDOT), Oakland Public Works, our Councilmembers, and our staff.

Here is what we have been able to accomplish so far:

- Filled 2,700 potholes since March 1
- Doubled the number of abandoned vehicles removed per month from 150 to nearly 300
- Established and operated more than 50 volunteer sites on Earth Day throughout the City
- Established and operated 7 park cleanups with 130+ staff participating in the parks cleanup

Thank you for your time, for your commitment, for the work you put in to ensure that we all live in a City that every resident is proud to call home. This project has shown what we can do together and has set the groundwork for future collaboration—because this was never about one week, but about one shared vision: One Oakland.

Councilmember Kalb is working on a significant ordinance to reduce plastic waste and litter overall on our streets and in our waterways. Details to follow in the coming months.

We look forward to continuing our work to make Oakland an even greater place to live, work and play.
