# Oakland Climate-Friendly Ban on Natural Gas in New Buildings



On Dec. 1, 2020 Oakland City Council unanimously approved my groundbreaking legislation to improve building safety and reduce Oakland's greenhouse gas emissions by prohibiting the use of fossil fuel gas in all newly constructed buildings. While building electrification – powering all energy systems like cooking and heating with electricity – is becoming widespread throughout the state, the legislation I introduced with Mayor Libby Schaaf and Councilmember Nikki Bas represents one of the most comprehensive policies introduced in California thus far. The ordinance requires two readings - its second reading is scheduled for December 15 City Council after which it will be effective (assuming another unanimous vote).



Unlike electricity, natural gas burned within homes and buildings cannot be made clean. Natural gas, which is primarily methane, creates greenhouse gas emissions when it is burned, and even more when it leaks throughout the gas distribution system. These leaks have severe climate impacts because methane is a highly potent greenhouse gas, more than 80 times stronger than carbon dioxide in its potential to trap heat in the atmosphere.

Oakland cannot meet its climate goals without shifting quickly away from natural gas use and my legislation will put Oakland at the forefront of <u>efforts statewide</u>. State energy policies and lower prices of renewables mean that substituting natural gas with electricity is one of the quickest, safest, and least expensive pathways to eliminating greenhouse gas emissions from buildings. Additionally, reducing the reliance on gas systems will reduce the risk of fires, simplify building systems and maintenance, and improve indoor air quality.

As of late 2020, about three dozen California jurisdictions have banned or significantly curtailed the use of natural gas in new building construction, including San Francisco, San

Jose, Berkeley and Richmond. Eliminating natural gas in buildings can lower the risk of fire after earthquakes and reduce the likelihood of childhood asthma. Children living in homes with gas cooking are 42% more likely to have asthma.

"Oakland's national leadership to build cleaner, safer, and healthier cities for all families continues with this historic transition to all-electric buildings," said Oakland Mayor Libby Schaaf. "I'm proud to have worked with Councilmember Kalb on this bold commitment to reduce our carbon emissions and ensure a greener future for Oakland and the world."

Once approved, the legislation will require all residential and commercial building developers to submit building applications that will design and build without any natural gas infrastructure. The ordinance does not impact existing buildings, additions, or alterations, or attached accessory dwelling units (ADUs), and waivers may be granted for technology feasibility reasons.



Modern electric systems and appliances are more efficient than older gas technologies, and in some cases offer lower overall

installation costs and utility bills. Heat pumps add air conditioning capacity in areas with heat stress, and induction cooking is safer with lower exposure to hot surfaces and no open flames.

In 2019, costs for all-electric new construction were already either on par with or less than those for mixed-fuel (i.e. electricity plus natural gas) construction. A recent analysis by California's Statewide Utility Codes and Standards Team found that building all-electric reduced construction costs on average \$5,000 for single-family homes and over \$2,000 per unit in a multi-family building.

The Mayor and I served as lead sponsors of the legislation which was drafted as a collaborative effort by the City's Environmental Services Sustainability Staff and the Planning and Building department. District 2 Councilmember Nikki Bas joined in as a cosponsor of the legislation.

## **COVID-19 Updates**

As we <u>reported previously</u>, due to the recent spike in COVID-19 cases (10,884 cumulative cases in Oakland as of December 1, 2020) <u>Alameda County is now in the purple tier</u> of the Governor's COVID-19 Reopening & Recovery plan. We have also been under the <u>limited stay-at-home order issued by Governor Gavin Newsom</u> since before the Thanksgiving holiday. <u>Thank you for adhering to our public health official's guidance</u> on avoiding unnecessary travel over the Thanksgiving weekend, wearing masks at all times, and limiting your interactions with those outside of your COVID-19 social bubble. It is our collective efforts that will continue to protect our many Oakland residents from a more deadly surge of the Coronavirus similar to what is being seen in other parts of the state and country.



Anticipating infection rates to continue rising throughout the holidays, health officials expect that some of us will let down our guards. As a reminder of why this is important, Today, Alameda County total cases are over 30,000 with an <u>unadjusted rate of 16.7 new cases of COVID-19 per day per 100,000 residents</u> which is up from 11.4 last week and keeps us in the Purple Tier for California's <u>Blueprint for a Safer Economy</u>. Oakland is nearing 11,000 cumulative cases with a case rate of 2,589/100,000 population – second only to Hayward in Alameda County. The disease continues to strike populations differently throughout the County – case rates amongst Latinos is 3,974, compared to 1,373 amongst Blacks, 744 amongst Whites and 633 amongst Asians.



As cases continue to increase, the safest way to celebrate the holiday season is at home with the people you live with fulltime. Gatherings with family and friends who do not live with you increase the chances of getting or spreading COVID-19 or the flu.

# **OPRYD Town Camp Programs Suspended**

Oakland Department of Parks, Recreation and Youth Development (OPRYD) provided inperson enrichment programs throughout the summer and has continued in-person programming at the recreation centers since the beginning of the school year. Due to the recent spike in COVID-19 cases, coupled with the fact that the holiday season and gatherings are anticipated to play a major role in the rise of COVID-19 infections for Oakland families, **OPRYD** is temporarily suspending the Town Camp Enrichment Program.

Outdoor-based youth programming (golf, tennis, and other outdoor-based programs) will continue to operate at this time. Only the indoor-based enrichment programs at the various recreation centers are being temporarily suspended.

We realize that this will be a burden on some families. However, city staff feel it is gravely necessary to control the spread of COVID-19, for both the customers we serve AND our own staff and their families. OPYRD will continue following Alameda County Public Health guidelines and protocols over the next few weeks and will communicate when we feel we can safely resume indoor programming.
