Present draft feasibility findings for a Downtown Oakland Specific Plan zoning incentive program for review and comment by the Zoning Update Committee. The feasibility study will identify whether the provision of increased building intensity in the form of height, density, and/or floor area ratio bonuses, would create additional value for development. The final feasibility study and programmatic recommendations will help inform the creation of a voluntary, streamlined development incentive program to provide increased building intensity in exchange for pre-defined community benefits as part of the zoning code update for downtown that is anticipated to be adopted along with the Final Downtown Oakland Specific Plan in the Summer 2020.
