# A. Call to Order/Approval of Agenda

G. Green called the meeting to order at 5:51pm.

# B. Roll Call/Determination of Quorum/Recite AC-OCAP Promise

Roll call was called by staff C. Garcia. The AC-OCAP promise was recited. A quorum was established.

#### D. Community Action Partnership Update (E. Clemons)

# 1. 2017 Board Meeting Schedule

E. Clemons stated that the 2017 AC-OCAP Administering Board Meeting schedule is in the packet. She pointed out that the February 14<sup>th</sup> meeting will be on a Tuesday.

# 2. 2016 City Council Report Update

E. Clemons thanked the board members who attended the Life Enrichment Committee meeting. She stated that one of the Councilmembers questioned some of the CAP programming; specifically whether the Thanksgiving Dinner is the best utilization of funding. She mentioned that on December 13, 2016, she will be going before the full City Council to receive the 2017 grant from the State. She stated that on February 14, 2017, she will be going before the City Council to present the full resolution and the 2017-2019 funding recommendations.

# 3. AC-OCAP 2017 Budget

E. Clemons stated that the Executive Committee reviewed the 2017 draft budget at their meeting on December 7, 2016. She stated that the budget is basically the same with the exception of personnel costs due to cost of living increasing January 2017.

A letter has been received from the United Seniors of Alameda County requesting to keep their seat on the AC-OCAP board. She also stated that a letter was received from the Oakland Rotary (Sean Callum) expressing their interest in having a seat on the AC-OCAP Board. Sandra Johnson Simon and Sean Callum both gave their reasons for interests on sitting on the CAP Board. E. Clemons also stated that there was a late request for representation from a private sector agency to be added to the list for future consideration.

E. Clemons stated that the 2017 Board Retreat is scheduled for Saturday, March 25, 2017. Staff is currently looking into locations that were recommended by AC-OCAP Board Members. She stated that the CAP Plan which is mandated is due June 30, 2017 in addition to the needs assessment.

E. Clemons stated that Representative Tom Price from Georgia (R-GA 6) is the President-Elect's nominee for Secretary of Health and Human Services. She stated that she is hoping to have updates in March or April and make it part of the packet.

# E. 2017 – 2019 AC-OCAP Review and Funding Recommendations

E. Derenthal stated that notification of the RFP was sent through Constant Contact to 638 contacts and posted in 5 newspapers in Alameda County (except Berkeley): Oakland Tribune, The Oakland Post, The Argus, the Daily Review, and the Tri-Valley Times for multiple printings in August and September. E. Clemons stated that there was a Bidder's Conference. She stated that there was also a Review Panel who reviewed 30 proposals. She stated that there were 32 proposals received but 2 were incomplete with a total ask of over \$2.1 million. She stated that the Panel reviews the proposals individually and scores each proposal. She stated then the Program Planning Committee reviews the scores and makes sure that services will be provided throughout the high impoverished areas in Alameda County and Oakland. E. Clemons addressed the Board regarding some conflict of interest questions, such as whether family members of a Board Member receiving services from one of the agencies recommended for funding is a conflict of interest. A discussion ensued on how to vote for the recommendations.

# F. Committee Reports – (Verbal):

1) Executive Committee – December 7, 2016 (M. Rivera)

M. Rivera stated that some agencies who are not recommended for funding received higher scores from the Advisory Panel that some agencies that were recommended. These agencies were not selected for funding due to the fact that their proposals either did not include job placement numbers, or placements were very low relative to the amount of money they requested. Job training and education outcomes are not sufficient for funding.. She also stated that there was a discussion on which goals are important to CAP which will also be discussed at the 2017 board retreat. She stated that at the Program Planning Committee meetings the Committee voted unanimously to bring the recommendations to the full Board. D. Brown stated that there aren't any agencies being recommended that advocate for immigrant rights. M. Rivera stated that there was discussion of having a process/pending list for organizations that are not being recommended for funding if any additional funding becomes available. E. Derenthal stated that there were also comments received on behalf of the Vietnamese American Community Center who reached out to Alameda County Supervisors' Nate Miley, Scott Haggerty, and Wilma Chan's offices as well as Oakland City Councilmember Abel Guillen's office. There were also letters of support received from Congressmen Eric Swalwell and Ninay Johnson on behalf of Downtown Streets. Family Fremont Resource Center also reached out asking why they were not recommended for funding as well as communications from other agencies requesting materials from the public meetings.

M. Rivera presented L. Wheeler with a plaque for her service on the AC-OCAP Board. This was her last meeting. G. Green presented D. Brown with a plaque for his service on the AC-OCAP Board. This was his last meeting. A letter was received from Supervisor Wilma Chan's Office stating that Brittaney Carter will be her alternate on the AC-OCAP board.
