
Environmental Enforcement Program

History

- Formally known as Litter Enforcement Officer (LEO) Program in 2001
- Consisted of (8) Litter Enforcement Officers, (2) Public Works Supervisor
 I, (1) Public Works Supervisor II
- Eliminated in mid 2011 due to budget cuts
- May 2018, City Council voted to reinstate the program by onboarding (4) Environmental Enforcement Officers and (1) Clean Community Supervisor

Illegal Dumping Reports

In 2010, Oak311 (Public Works Call Center) received approximately 12,500 illegal dumping service requests

UNLAWFULLY DUMPED WASTE MATERIAL O.M.C. §8.11 VIOLATION

The City may notice a dumping violator to remove illegally dumped waste matter from City or private property (with the property owner's prior approval). If a dumping violator is noticed to remove illegally dumped material and fails to remove the same within 24 hours after notice by the City or the oroperty owner, such failure to timely remove the illegally dumped material constitutes a separate violation and is a major violation subject to civil senalties.

Each and every day after being served this notice is a separate and distinct offense, which may result in a fine of up to \$1000 per day.

Failure to remove obstructions AND restore area by date and time posted will result in City's removal of waste matter, a fine, and a bill for waste removal and dispusal costs to be presented to the owner of record. Costs may be recovered by legal means including tax lien, tax levy, assessment and court action.

WARNING NOTICE

ABUSE OF LITTER CONTAINER

It is unlawful for any person to deposit any material from any building or yard in, on top of, or alongside the street litter receptacles placed in the sidewalk area; provided, that pedestrians and other persons using said streets shall be permitted to deposit in said receptacle miscellaneous small articles of refuse carried by them. – OMC \$8.28.160

This is a notice to cease and desist from Litter Container Abuse. Fine will NOT be assessed at this time.

Failure to comply with OMC §8.28.160 may result in a fine of \$750/ \$1,000/ \$1,500 per day. To arrange for adequate solid waste collection service, contact Waste Management of Alameda County at 510-613-8710 to begin new service or increase existing service.

- OMC 8.28.110 *insufficient service after 15-day notice*









Piles Abated By Owner/Resident





