Specific Question Request:

- 1. More clarification is needed on these proposed allocations to ensure that the proposed spending is consistent with Measure Q: (...and which allocation apportions to Parks, Homelessness or Water Quality?):
 - \$600,000 to Keep Oakland Beautiful Contract

This funding will extend the overall contract with Beautification Council and ensure continuation homeless encampment clean-up services. This funding is appropriated under the "Services to address Homelessness" allocation.

• \$500,000 to East Oakland Sports Center

The Oakland Public Works Department is responsible for ensuring facility management and maintenance services for the East Oakland Sports Complex (EOSC) located at Ira Jinkins Park. The \$500,000 funds the maintenance at the EOSC through contract services. The services required at EOSC require a vast array of facilities maintenance expertise in all key areas including HVAC, landscaping, custodial, mechanical, electrical and plumbing (MEP), and elevator and pool maintenance. This funding is appropriated under the "Parks, Landscape Maintenance, and Recreational Services" allocation.

Neighborhood Services Coordinators transfers to Measure Q

The transfer will merge NSD into OPW and streamline division of work duties such as; illegal dumping, abandoned autos, and maintenance of public spaces related to Homeless Encampments. This funding is appropriated under the "Services to address Homelessness" allocation.

 Assistant Director of Public Works, Administrative Services Manager, Administrative Assistant in OPW and several positions in the City Administrator's Office to Measure Q

OPW

The Assistant Director of Public Works oversees three divisions including the Parks & Tree Services Division (PTD), Keep Oakland Clean & Beautiful (KOCB), and the Environmental Services Division (ESD) within the Bureau of Environment (BOE). PTD maintains, protects, and improves parks, open space, and rec facilities in Oakland. They also provide litter abatement in parks that is often the result of homelessness in Oakland. KOCB contributes significantly to the alleviation of negative impacts resulting from homelessness. They support the cleaning of encampments and facilitate the relocation of the unsheltered in or near parks. The Environmental Enforcement Unit housed under KOCB patrols City ROWs, park lands, and other assets and enforces against illegal dumpers. Lastly, ESD provides water quality sampling of waterways to assess contamination caused by homeless encampments. As the head of BOE, the AD provides direction to these groups in their efforts to comply with Measure Q and ensure equitable maintenance of city parks and protection of our waterways.

The Administrative Assistant II is the glue that binds the above groups together. The position provides critical administrative and clerical support to the Assistant Director of Public Works and to BOE and helps to coordinate activities of the divisions as needed. The Administrative Assistant II maintains and assists in the tracking of Bureau priorities, many of which are Measure Q-related. The position also provides critical support for the management and tracking of Council agenda items, including the upcoming adoption of the Urban Forest Plan.

The Administrative Services Manager (ASM I) plays a major role developing and managing the budget of BOE and Measure Q. This position seeks and obtains grants and other funding sources to sustain City priorities including litter abatement and beautification that benefit Oakland's parks and other assets. She also performs data collection and analysis and implements special projects and contracts to, for example, deep-clean City ROWs and deploy illegal dumping surveillance cameras in collaboration with the Environmental Enforcement Unit. These efforts protect and improve Oakland's vital public spaces including parks and rec facilities. This funding is appropriated under the "Parks, Landscape Maintenance, and Recreational Services" allocation.

CAO

Administrative Analyst I - Manages the Homelessness email account, reviews and responds to public emails. Provides digital assessments on encampment services from email requests and

coordinates with EMT departments to respond to the encampment conditions. Prepares reports quarterly for the division, keeps current reference materials and files, data entry/ data management, Commission on Homelessness staffing, agenda management and taking meeting notes. **Assistant to the City Administrator** - Assists with responding to homeless encampment inquiries. Assists in prioritizing sites for EMT action as it pertains to the Encampment Management Policy. Lead for construction project and external agency encampment requests. Conducts site assessments at encampments, assists with intake, triage, scheduling of EMT actions, and leading EMT operations. Assistant to the City Administrator (0.25 FTE) - Directs/supervises the Neighborhood Services Division (NSD). In FY 2023-24, NSD developed a pilot program in collaboration with the EMT, to identify recently-closed encampment sites and coordinate with Environmental Services to promote Adopt-a-Spot as a way to support residents to maintain and create community gardens and prevent reencampment at the site.

Assistant to the City Administrator - Assists with responding to homeless encampment inquiries. Assists in prioritizing sites for EMT action as it pertains to the Encampment Management Policy. Lead for construction project and external agency encampment requests. Conducts site assessments at encampments, assists with intake, triage, scheduling of EMT actions, and leading EMT operations.

Deputy City Administrator - Interagency liaison responsible for working with BART, CalTrans, BNSF, Union Pacific, and other agencies to coordinate activities including encampment response and closures. Supervises Assistant to the City Administrator PN_46854 (A. Martinez) over NSD. Project manages interdepartmental/interagency projects to build community cabin sites, temporary shelters.

• \$2.4 million shown as "Parks, CIP, Communications, and Engagement"

This one-time \$2.4 million appropriation is reserved for Parks capital projects, deferred Maintenance projects, and infrastructure improvements. It will facilitate the planning of improvements to parks including community engagement to ensure capital and deferred maintenance projects meet the needs of the local communities using City parks. This funding is appropriated under the "Parks, Landscape Maintenance, and Recreational Services" allocation.

2. On what basis is the \$2,363,203 of LLAD funding (in OPRYD) being transferred to Measure Q?

The transfer of the internal service fund budget \$2,363,203, which funds the maintenance of Recreation Centers locating in City parks, is based on the eligibility of these costs under the measure. The costs associated with operating and maintaining facilities and include activities such as custodial cleaning, disinfecting, restocking of restrooms and kitchenettes, recycling, routine maintenance and repairs to building systems, and preventive maintenance.
