Hank Phan, OPRYD Capital Improvement Project Coordinator, introduced speaker Ryan Stokes, Eagle Scout, and Dale Risden, Friends of Joaquin Miller Park, for the presentation.

Request for future update on project installation takeaways and use from the Commission. Clarification was provided on the maintenance Friends of Joaquin Miller Park would provide to the unit. Anti-theft mechanism for unit explained.

Dr. Christopher Schell, Schell Lab at the University of California Berkeley, provided the presentation.

Discussion around equipment ability to capture sound and noise pollution. Clarification provided around privacy and timeline of equipment install and project. Request for future updates on project. Questions answered addressing current locations for equipment install, how community members can opt in or out of project involvement, and liabilities. Success stories from other cities provided.

Motion: Chair Allen entertained a motion to approve the request for the Schell Lab and UC Berkeley to deploy ten (10) wildlife cameras in the designated parks and green spaces noted in table 1 on page 16 of the agenda packet, and staff also concurs that Dr. Schell and associates will assume full responsibility for equipment, maintenance, damage and loss. Clarification provided on creek design with respect to general standards, climate, and recent rainstorms. Concerns raised around tree removal process and planting of new trees for the project. Explanation relating to project funding requested in forthcoming report. Equity-community outreach strategies discussed.

Funding, event history, and crowd expectancy explained.

- 8. <u>UPDATE FROM DIRECTOR, COMMITTEES, RECREATION ADVISORY COUNCILS & ANNOUNCEMENTS:</u>

# **Director's Report:**

- Provided by Interim Director Riley.
  - o Thanked Commission for the moment of silence for Marc Weinstein.
    - OPRYD is working with the family looking to do a scholarship fundraising event at Davies Tennis. Marc had been with the department for nearly 15 years starting with Davies Tennis program and running citywide tennis, to a recently promoted Supervisor.
  - OPRYD has been working along with the rest of City departments, Red Cross, and County on providing services during this winter storm event. Park and Recreation is part of the Mass Care and Shelter Unit in Emergency Response, meaning temporary shelters

are opened to provide residents a place to get dry and warm. OPRYD does not provide a place for residents to get cool because most sites do not have air conditioning, so the libraries become cooling centers towards the summer and OPRYD helps with warming centers in the wintertime.

- OPRYD did stand up a shelter last weekend at Ira Jinkins Recreation Center and that was a 3-day shelter. Typically, the shelters are based on an incident such as a fire at an apartment complex or a tree fell and displaced residents. Because of the possibility of flooding and windstorms OPRYD temporary shelters opened to respond to provide unsheltered residents a place to come.
- Park Stewards worked with the City's Macro team on community engagement and went out to various encampments to entice folks to come in and take advantage of the shelter. Difficult to do in a short time frame, but several residents came into the shelter. One of the residents was ill, placed in a quarantined area of the shelter, and had to be taken by paramedics to a hospital due to breathing issues in the middle of the night. Had he been in an encampment he may not have received help so quickly. It is good to keep in mind that even though the numbers may not be high, the impact is very important.
- O Director's recruitment for Parks, Recreation & Youth Development is moving forward. The recruiters are expecting the posting to go live the end of next week or the week following. The position will be posted for about 6 weeks, then they will go through the screenings and interview recruitment process. Hoping a tentative timeline for interviews will be the month of March.

Additional explanation provided around staffing, leadership transition and timing given the new administration, along with status of access and damage to the City's parks and recreation centers from the recent storm.

# **PRAC Committees:**

- Park Rules & Regulations: No update.
  - Commissioner Kos-Read advised stronger staff guidance and involvement would be a benefit to the committee to move forward given the magnitude of the project. Previous finish line set was not adequate address our park complexities. To update them would require research into other regional parks' rules and has been difficult to undertake as volunteers. Also, uncertain if staff person they were previously working with is still with OPRYD.
  - o Commissioner Duhe noted some confusion around roles and expectations from both parties (Staff versus Commissioners) needing reevaluation to get on the same page.
  - o Interim Director Riley added that the previous visit to Life Enrichment ended in a stalemate because of enforcement of the rules and equity concerns. Research was done in different communities and districts. The new council coming in may be worth exploring for guidance or support. The task force can examine if some of the changes need to be removed. Staff are facilitating meetings, but perhaps lack participation. We need some sticking points before returning to Council.
- Tree Advisory: No update.
  - Commissioner Ha clarified there are two tree committees; one addresses tree removal permit appeals. Only non-developmental, residential tree removal permit appeals will

- reach PRAC. Have not had any in the past year. Sample responsibilities provided. The other tree committee has to do with the Urban Forest Master Plan Process through Public Forestry Services for the past 1-2 years. Has not met due to Urban Forest Master Plan Process point-of-contact, lack of working relationship and inactivity.
- Commissioner Ha agreed with Chair Allen's suggestion with the possibility of combining the two tree advisory committees into one.
- O Interim Director Riley advised that the tree committee that handles appeals (Tree Advisory) was established by City Council and must remain, but all others are ad-hoc and may go dormant and become active as-needed. They are to resolve an issue and then discontinued or go into dormancy until another issue arises. Other tree-related items could be heard under the Tree Advisory Committee without the Council's approval.
- Commissioner Watkins agreed that the tree committees could be combined, advised that he worked closely with Pete Moore, and did not mind taking his place on those committees.

# Measure Q: No update.

o Will remain as is. Chair Allen will meet with Sean Maher on Friday about meetings and frequency. Advised to swap out Corey Riley for Vice Chair Tran.

# • Lake Merritt Ad Hoc: No update.

- Mobile vending pilot program is now over. Chair Allen will ask Greg Minor for an informational report with updates since last January/February. Would also like to know the status of some other matters at the Lake such as an art installation put up without the proper approval. Noted new Rotary Nature Center Director conflicts. Chair Allen advised the importance of supporting our parks and recreation center directors/supervisors.
- O Commissioner Kos-Read advised updates are needed on the status of various things around the Lake such as parking and the Park Stewards impact for a comprehensive look. Historically, activity around the Lake quiets down in the wetter, colder months and then heats back up again. Notable issues, not reserved for Lake Merritt alone, are: dumping, loud music after-hours, the unauthorized installation of art, the drum circle takeover and unhoused residents at the pergola, and unlicensed vendors still popping up. A comprehensive report at the February meeting would be helpful so that the committee could have robust discussion about what a plan looks like for the year ahead. Also helps with looking into rules and at those that are enforceable and respected. Advised he is not attending Lake Merritt Task Force and that Joe Devries's role has shifted with the staffing issues.

#### • Priority & Goals Ad Hoc: No update.

 Vice Chair Tran have met sporadically to discuss the big picture for PRAC. Focused on putting together a handbook to help onboard new commissioners. Looking for feedback on how to be a more effective body from commissioners.

  - o Hosting Yoga class for beginners. Registration available for \$65 on OPRYD's site.

- City's Master Plan 2<sup>nd</sup> Phase begins this year including the rewriting of the OSCAR. Chair Allen requests the creation of ad-hoc committee for this purpose. The OSCAR is 25 years old and various updates to parks and waterways are anticipated.
- Measure Y has passed, and Chair Allen will request informational report to better understand PRAC's forthcoming relationship with the Zoo.

RESOLUTION RENEWING AND CONTINUING THE PARKS AND RECREATION ADVISORY COMMISSION'S DETERMINATION THAT CONDUCTING IN-PERSON MEETINGS OF THE PARKS AND RECREATION ADVISORY COMMISSION AND ITS COMMITTEES WOULD PRESENT IMMINENT RISKS TO ATTENDEES' HEALTH, AND ELECTING TO CONTINUE CONDUCTING MEETINGS USING TELECONFERENCING IN ACCORDANCE WITH CALIFORNIA GOVERNMENT CODE SECTION 54953(e), A PROVISION OF AB-361.

WHEREAS, on March 4, 2020, Governor Gavin Newsom declared a state of emergency related to COVID-19, pursuant to Government Code Section 8625, and such declaration has not been lifted or rescinded. **WHEREAS,** on June 17, 2022 Gavin Newsom issued Executive Order N-11-22 reaffirming that a State of Emergency exists in California as a result of COVID-19. (*See* <a href="https://www.gov.ca.gov/wp-content/uploads/2022/06/6.17.22-COVID-EO-Rollback-signed.pdf">https://www.gov.ca.gov/wp-content/uploads/2022/06/6.17.22-COVID-EO-Rollback-signed.pdf</a>.); and

WHEREAS, on March 9, 2020, the City Administrator in their capacity as the Director of the Emergency Operations Center (EOC), issued a proclamation of local emergency due to the spread of COVID-19 in Oakland, and on March 12, 2020, the City Council passed Resolution No. 88075 C.M.S. ratifying the proclamation of local emergency pursuant to Oakland Municipal Code (O.M.C.) section 8.50.050(C); and

WHEREAS, City Council Resolution No. 88075 remains in full force and effect to date; and

WHEREAS, the Centers for Disease Control (CDC) continues to recommend physical distancing of at least six (6) feet whenever possible, avoiding crowds and poorly ventilated spaces, particularly for people who are not fully vaccinated or who are at higher risk of getting very sick from COVID-19. (See <a href="https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html">https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html</a>.); and

WHEREAS, the CDC recommends that families with children under 5 and unvaccinated household members continue to take steps to prevent COVID-19 infection including distancing. (See <a href="https://www.cdc.gov/coronavirus/2019-ncov/groups/families-covid-19.html">https://www.cdc.gov/coronavirus/2019-ncov/groups/families-covid-19.html</a>.); and

- WHEREAS, the CDC continues to caution that older adults remain more likely to get very sick from COVID-19. (See https://www.cdc.gov/aging/covid19/covid19-older-adults.html.); and
- WHEREAS, the CDC, the California Department of Public Health, and the Alameda County Public Health Department all recommend that people experiencing COVID-19 symptoms or who have tested positive for COVID-19 stay home. (*See* https://www.cdc.gov/coronavirus/2019-ncov/if-you-are-sick/steps-when-sick.html.); and
- WHEREAS, the CDC still finds that COVID-19 vaccines are highly effective at preventing severe illness, hospitalizations and death and continues to recommend that all eligible persons get vaccinated for COVID-19 and stay up to date on their COVID-19 vaccines. (*See* https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html.); and
- **WHEREAS**, vaccinated persons may still get COVID-19 and can spread the virus to others. (*See* <a href="https://www.cdc.gov/coronavirus/2019-ncov/vaccines/effectiveness/why-measure-effectiveness/breakthrough-cases.html">https://www.cdc.gov/coronavirus/2019-ncov/vaccines/effectiveness/why-measure-effectiveness/breakthrough-cases.html</a>.); and
- WHEREAS, anyone infected with COVID-19 can spread the virus, even if they do not have symptoms. (See <a href="https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/how-covid-spreads.html">https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/how-covid-spreads.html</a>.); and
- WHEREAS, the City's public-meeting facilities are indoor facilities not designed to ensure circulation of fresh/outdoor air, particularly during periods of cold and/or rainy weather, and were not designed to ensure that attendees can remain six (6) feet apart; and
- WHEREAS, holding in-person meetings would encourage community members to come to City facilities to participate in local government, and some of them would be at high risk of getting very sick from COVID-19 and/or may live with someone who is at high risk; and
- WHEREAS, in-person meetings would tempt community members who are experiencing COVID-19 symptoms to leave their homes in order to come to City facilities and participate in local government; and
- WHEREAS, attendees would use ride-share services and/or public transit to travel to inperson meetings, thereby putting them in close and prolonged contact with additional people outside of their households; and
- WHEREAS, for the first time on October 13, 2021, and most recently on September 14, 2022, the Parks and Recreation Advisory Commission adopted a Resolution determining that conducting in-person meetings would present imminent risks to attendees' health, and electing to conduct meetings using teleconferencing in accordance with California Government Code section 54953(e), a provision of AB 361; and
- WHEREAS, by making these findings that conducting in-person meetings would present imminent risks to attendees' health, and by making an election to conduct meetings via teleconference, the Parks and Recreation Advisory Commission may elect to continue to meet via teleconference by adopting subsequent resolutions, at least every 30 days, as part of a broader Parks and Recreation Advisory Commission agenda, and need not do so on a single-subject agenda; now therefore be it:

**RESOLVED:** that the Parks and Recreation Advisory Commission finds and determines that the foregoing recitals are true and correct and hereby adopts and incorporates them into this Resolution; and be it

**FURTHER RESOLVED:** that, based on these determinations and consistent with federal, state and local health guidance, the Parks and Recreation Advisory Commission renews its determination that conducting in-person meetings would pose imminent risks to the health of attendees; and be it

**FURTHER RESOLVED:** that the Parks and Recreation Advisory Commission firmly believes that the community's health and safety and the community's right to participate in local government, are both critically important, and the Parks and Recreation Advisory Commission is committed to balancing the two by continuing to use teleconferencing to conduct public meetings, in accordance with California Government Code section 54953(e), a provision of AB 361; and be it

**FURTHER RESOLVED:** that the Parks and Recreation Advisory Commission will renew these (or similar) findings at least every thirty (30) days in accordance with California Government Code section 54953(e) until the state of emergency related to COVID-19 has been lifted, or the Parks and Recreation Advisory Commission finds that in-person meetings no longer pose imminent risks to the health of attendees, whichever is occurs first.



# **SUMMARY**

# **SUMMARY**

This report provides OPW's routine updates to PRAC regarding updated performance measures in the delivery of Measure Q-funded services, as well as a hiring update for OPW positions funded by Measure Q.

# FISCAL IMPACT

# BACKGROUND / LEGISLATIVE HISTORY

Measure Q, approved by Oakland voters in March 2020, provides funding for City of Oakland services related to parks maintenance, homelessness services, and water quality, subject to civilian oversight. The Oakland City Council assigned PRAC the oversight role regarding the Measure Q expenditures related to parks maintenance and water quality services.

As a component of this oversight function, OPW routinely submits to PRAC updates on hiring of positions related to Measure Q-funded park maintenance services.

Measure Q includes service performance requirements. OPW has been working with the PRAC Measure Q ad hoc committee and with community members to develop a reporting template for measuring and tracking performance of those services. The department's goal is a routine report that is clear, simple, and accessible to the community to provide transparent and accessible reporting on service delivery. This remains an iterative process, and OPW welcomes feedback from PRAC on how the department can continue honing that reporting template.

# **RECOMMENDATION**

OPW recommends that PRAC accept this informational report.







Oakland Parks, Recreation & Youth Development received a request from Angie Kandalaft of Soul Focus LLC, for approval to serve and sell alcoholic beverages (Beer & Wine), food (mobile food vendors), commemorative merchandise and accept donations onsite at the Oakland Running Festival Marathon to be held at Snow Park on Sunday, March 19, 2023. Applicant is aware of the additional permits required. Approval from the Parks and Recreation Advisory Commission is required per O.M.C. Section 12.64.080.

# FISCAL IMPACT

Soul Focus LLC is paying all rental fees associated with the event estimated at \$10,000.00.

# PROJECT / PROGRAM DESCRIPTION

This is the 14th year of the Oakland Running Festival Marathon in the City of Oakland. The Oakland Running Festival Marathon is a five-race event which attracts people from all over the world to run through the streets of Oakland. The Oakland Running Festival in the past has had over 10,000 participants and bring in over 2 million in revenue to businesses in Oakland.

# BACKGROUND / LEGISLATIVE HISTORY

Soul Focus LLC was established in 2011, They have created and produced some of the most impactful running events in the world. They talk the talk and run the run. They pride themselves in being able to connect to endurance athletes in an authentic way; while running is their specialty, they would be nothing if they didn't also surf, skate, ski, ride, hike, climb, shoot, score, and more. Regardless of the form, their mission is to support local communities through the power of human movement and create memorable experiences through sporting events. The Oakland Running Festival has proven to be well planned, extremely successful, and well received by the community. There are approximately 10,000 registered participants.

The Oakland Running Festival is a citywide event and is jointly supported by the City Council Office, Economic and Workforce Development Department Special Events Unit, and Oakland Parks, Recreation & Youth Development.

**History**: The Oakland Running Festival is celebrating its 14th year March 19<sup>th</sup>, 2023 and its first year of ownership by Soul Focus LLC. Soul Focus LLC was founded in 2011 and our mission is to Support Local Communities through the Power of Human Movement. At our core, we are runners. We pride ourselves in being able to connect to endurance athletes in an authentic way - the way we would want to be talked to. As the proud, new owners of the Oakland Running Festival, we are excited to be a part of this wonderful Oakland tradition and celebrate a healthy, positive event for all. Each year, ORF has chosen a local mural to highlight and make that our runners medal for the event, supporting local artists and makers. This year we plan to have over 7,000 participants. The weekend brings in over \$2 million in revenue to the city while providing a fun, active festival for Oakland residents. We work with multiple city agencies to celebrate Oakland through its streets, parks, and people.

**Overview of Event**: The event is set for the weekend of March 17<sup>th</sup>-19<sup>th</sup> at Snow Park. Snow Park set up will begin as early as possible on Friday to accommodate our tents and stage all operations. Participants pre-register for events online to enjoy the running course around Lake Merritt. Some street closures are necessary to keep runner traffic safe and allow for park traffic to be unchanged. We plan to use several parks throughout Lake Merritt to make this event happen including, Lake Merritt Pergola, Amphitheater, Snow Park, and the grandstand.

#### Request to collect funds on site:

All runners are pre-registered. We sell merchandise at the finish line provided by Soul Focus LLC only. This includes shirts, mugs, glasses, to commemorate the event. We provide beer (TBD for 2023) for each runner through our partnership with Running For a Better Oakland. Local food trucks provide food for sale for runners and the community and fans of the event. Most items are \$10 or less and all provided by local companies. Each vendor is registered through the health department and if necessary, provides fire clearance for their operations.

# Why are funds being collected:

We cover street closures, permitting costs, race shirts, race medals, medical teams, and finish line engagement like DJ, awards, and sponsor giveaways. This covers our costs to operate the event while providing a great platform for local businesses, charities, and future community running events.

**Who is benefited**: Race participants, City of Oakland, local businesses, and nonprofits. Previously some of those groups have been; Running for a Better Oakland, Asian Health Services, The Crucible, Oakland Parks and Rec Foundation, and Youth Uprising.
