

# **Project Summary**


- What: Repair harm from construction of I-980 and improve connections between West Oakland & Downtown Oakland
- Why: I-980 has divided communities and is a barrier to opportunities and travel between those communities
- How: Build trust through inclusive and collaboration with the public and other partners



# Project Area

## I-980 Construction Impacts

- I-980 disrupted the local street grid in favor of long-distance commuter traffic.
- More than 500 homes, 22 businesses, and 4 churches were removed.
- The few crossing points are wide, multi-lane streets with minimal pedestrian & bike infrastructure.




Interstate 980 construction in the 1980s.

### Study Process and Outcomes

- Address past harms and develop equity-based performance measures
- Collaborate with community to envision a future concept for I-980
- Balance multi-modal transportation
  demand and community needs
- Develop a range of scenarios to address those needs
- Identify corridor vision and recommend next steps to advance the vision

Identify a new concept and vision for transportation and land use along the entire I-980 corridor. Perform a more detailed feasibility and technical analysis of the concept/vision

Spring 2024 – Fall 2025

Early 2026 – Late 2027

# **Complete Streets Plans**

#### Oakland Walks (2017)

• W. Oakland sidewalks are in the worst shape in the city and W. Oakland has the 2nd highest average injury rate (behind Downtown)

### Let's Bike Oakland (2019)


- 72% of W. Oaklanders want to bike more than they do today.
- Half of survey respondents in W. Oakland more than any other area - felt that new bike lanes are a sign that a neighborhood is about to get less affordable.

### **Oakland High Injury Network Analysis** (2024)

• HIN crossings include MLK Jr Way, W. Grand Ave, and San Pablo Ave.

# **Air Quality & Freight Plans**

### West Oakland Community Action Plan (BAAQMD - 2019)

- Higher concentrations of air pollution than most communities in Bay Area
- Heavy-duty trucks account for 40% of diesel PM emissions as well as PM2.5.

# Land Use Plans

### City of Oakland General Plan


(anticipated 2025)

### **Downtown Oakland Specific Plan** (2024)

 Calls for studying feasibility of replacing I-980 and for improving connections over the freeway

### West Oakland Specific Plan (2014)

 Notes opportunities to "soften" I-980 crossings and provide transit loops to connect West Oakland and Downtown



# **Anti-Displacement Policies**




**Tenant Protections** – Rent Adjustment Ordinance, Just Cause for Eviction Ordinance, Uniform Relocation Ordinance

**Affordable Housing Production Policies** – Dedicate units in new developments to low-income households

### **Downtown Oakland Specific Plan**

- Zoning Incentive Program Voluntary program where developers can build more intensity in exchange for community benefits (affordable housing units, streetscape improvements, public restrooms, etc.)
- Economic Development Strategy 2.8 City of Oakland hopes to provide city owned or leased space at affordable rates for local entrepreneurs and small retailers

### Public Engagement

- City Commissions and Neighborhood Councils
- Technical Advisory Committee with 10 agency and 6 CBO reps
- Tabling at Community Events
- 2 Mobile Workshops
- 1 Virtual Public Workshop



## What We've Heard

- No project should worsen air quality or increase truck traffic in the West Oakland neighborhood
- Prioritize affordable housing for residents displaced or impacted by I-980 construction
- Understand feedback already provided in other planning processes on existing neighborhood issues
- Include potential near-term improvements for over/underpasses
