- Comparison of police salaries and lawsuit payouts, between City of Oakland and other Bay Area cities
- Total number of probationers and parolees in Oakland, broken down by age, gender and type of offense
- Total number of expelled, suspended and "chronically truant" students by grade level
- Estimated homeless population, and subset of population in encampments
- Total number of gunshot and stabbing victims treated at area hospitals (County EMS should have this)
- Estimates of other victim populations: survivors of domestic violence and sexual assault, child and elder abuse, sexual exploitation
- Substance abuse treatment slots in Oakland
- Homeless shelter, transitional housing, and permanent housing slots in Oakland
- OPD's legal obligations are in terms of what they are required to do by law. Including a list of the relevant state codes with some analysis about not just what the law says but some understanding of whether required police response must be (a) by city police vs sheriff or other law enforcement body, (b) by a uniformed officer or other sworn officer vs a non-sworn police staff person, and (c) what the penalty is for non-compliance.
- Estimate of cost if all the overtime hours were covered by additional police officers who did not work overtime

- An audit of calls-for-service and crimes-reported-by-citizens that quantifies such calls by crime type and by time-of-day:
  - 911 Emergency calls-for-service
  - Non-Emergency calls-for-service
  - Online Crime Reports
- Two-Week Time Study of patrol officers use of work-hours by shift.
- Investigation case-solve rates for homicide, rape, felony assault, robbery, burglary, auto theft.
