INTRODUCED BY MAYOR SHENG THAO

RESOLUTION CONFIRMING THE MAYOR'S REAPPOINTMENT OF JOEY HARRISON, ALEXIS LOZANO, CANDACE ELDER, BETH STOKES, AND MARK WALKER AS MEMBERS OF THE COMMISSION ON HOMELESSNESS

WHEREAS, Section 601 of the City Charter provides that members of City boards and commissions shall be appointed by the Mayor subject to confirmation by the affirmative vote of five members of the City Council; and

WHEREAS, Oakland Municipal Code Section 4.56.060 established the Commission on Homelessness to advise the Mayor and City Council and make recommendations on Measure W and Measure Q homelessness funds received by the City of Oakland for homelessness programs and services; and

WHEREAS, the Commission on Homelessness consists of nine (9) members appointed by the Mayor and confirmed by the Council, the composition of which must include no less than half of the commissioners being residents of heavily impacted neighborhoods, no fewer than two (2) commissioners being currently or formerly homeless, no fewer than three (3) commissioners having professional expertise with housing or homeless services, and no fewer than one (1) commissioner having financial expertise; and

WHEREAS, the appointed commissioners listed herein meet the aforementioned requirements; and

WHEREAS, members serving initial appointments shall serve staggered terms of one (1), two (2) or three (3) years, all appointments for subsequent terms shall be for three-year terms; and all member terms shall begin on the date of the first six (6) appointments and future terms shall begin and end on that date; and

WHEREAS, the Honorable Mayor Sheng Thao has reappointed Joey Harrison, Alexis Lozano, Candice Elder, Beth Stokes, and Mark Walker, to the Commission on Homelessness, to the terms listed below; now, therefore, be it

RESOLVED: That pursuant to City Charter section 601, the City Council hereby confirms the Mayor's appointment to the Commission on Homelessness, as follows:

Joey Harrison, to serve a three-year term that began December 2, 2022 and ends December 1, 2025, filling a seat previously held by himself.

Alexis Lozano, to serve a three-year term that began December 2, 2022 and ends December 1, 2025, filling a seat previously held by herself.

Candace Elder, to serve a three-year term that began December 2, 2022 and ends December 1, 2025, filling a seat previously held by herself.

Beth Stokes, to serve a three-year term that began December 2, 2021 and ends December 1, 2024, filling a seat previously held by herself.

Mark Walker, to serve a three-year term that began December 2, 2021 and ends December 1, 2024, filling a seat previously held by himself.
