#### 1. Call to Order/Roll Call/Determination of Quorum

Gladys Green (Chair) called the meeting to order at 5:35 p.m. Roll was called by staff member Estelle Clemons. A quorum was established.

# Approval of June 6, 2018 Executive Committee Meeting Minutes

#### 2. AC-OCAP Program Update

E. Clemons gave an update of programming activities. She stated that the site visits to the 5 grantees that needed follow up have been completed. Per the monitoring visits, all grantees are on track to achieve their 2018 goals. Mid-year progress reports and requests for funds (RFF) are coming in. Grantees are scheduled to present to the Board in September and October. The By-laws are being updated. Comments from City Attorney Amber McCauley are being reviewed and will be forwarded to the ad hoc by-laws committee for review and discussion. The committee discussed next steps for County "Ask" letter.

**ACTION:** E. Clemons will work to get the City of Oakland's "Ask" letter signed by the City Administrator, Sabrina Landreth.



## **3. Board Recruitment** – (District Letter 1, 2, 6, & Alameda County)

E. Clemons reported that there are four (4) community vacancies on the Board (District 1, 2 & 6 and Alameda County). A constant contact notification has been sent out regarding the vacancies and a letter sent to each elected official requesting their assistance in identifying qualified residents. Discussion ensued around the need to re-align expiring board terms to ensure 3 year terms are staggered as outline in the by-laws to prevent the board from losing too many members at one time. E. Clemons stated that the state has approved the use of CSBG funds to help remove barriers like child care costs or lack of transportation for low-income representatives who serve on the Board. **ACTION:** E. Clemons will develop a new Board alignment chart with four - 3 year staggered terms.
