The City of Oakland is developing its 2030 Equitable Climate Action Plan (ECAP) to identify how Oaklanders and the City can work together to take critical actions to combat climate change and adapt to a changing climate. In October 2018, City Council adopted a Climate Emergency and Just Transition Resolution, calling for an urgent climate mobilization effort to reverse global warming, reduce greenhouse gas emissions as quickly as possible, and accelerate adaptation and resilience strategies in preparation for intensifying climate impacts. This includes actions that create good green jobs, reduce pollution, and help Oaklanders thrive. The ECAP is the tool that will make this happen.

Town Hall with OUSD: Developing Quality Schools - Saturday, June 8

Please join me and OUSD District 1 Director **Jody London** for a Town Hall meeting to examine: how do we develop higher quality schools with excellent support for historically underserved groups of students, and programs that are attractive to families? OUSD Superintendent Kyla Johnson-Trammell also will be present for most of the meeting.

We want to know what's important to you as our Oakland Unified School District makes decisions that affect the schools in District 1 and across the city. The School Board in March adopted a Citywide Plan that examines the current environment in which Oakland Unified is operating and lays out a vision to ensure equitable access to quality school across the City. OUSD will be using a process called Convergent Facilitation to review, update, and possible add to [criteria](#) that are being developed by various stakeholders and community members, and then use them to evaluate the plan and any proposals that emerge from the Town Hall meeting, with the intention to reach a path forward that works as well as possible for stakeholders. Update on Oakland's Homeless Response

All Oaklanders deserve safe, affordable housing. If you have been feeling that Oakland's homelessness problems have been getting worse, you are absolutely correct. According to the 2019 [EveryOne Counts!](#) (the Alameda County Homeless Point-In Time Count), our homeless population has increased 43% since 2017. It is estimated that 8,022 people in Alameda County are experiencing homelessness - 1,710 sheltered and 6,312 unsheltered. Oakland staff estimates that nearly 50% of all homeless residents in Alameda County live in Oakland.



While we have many programs in place, we know that much more needs to be done to address this crisis. To answer this call, I requested a staff report on the City's efforts to address the challenges and needs of the homeless individuals residing in Oakland with options and recommendations for additional administrative, legislative and budgetary actions. This report was presented at the May 28 Life Enrichment Committee, and can be downloaded [here](#). One of the main recommendations in this report, which I support, is to focus increased attention on preventing homelessness by identifying and providing support to those most at risk of becoming homeless. While the city helped to create the [Keep Oakland Housed](#) initiative, there is more we must consider doing.

Other highlights of the report include:

1. Increasing emergency beds - from 1142 in 2018 to 2403 by end 2021 through strategies such as community cabins, sprung tent shelters, safe parking, respite beds, and other models;
2. Focus on homeless families through investments in expanded shelter, housing navigation, and rapid rehousing, aligning existing childcare and workforce funding;
3. Focus on equity - African Americans are 68% of the homeless population (vs. 28% of Oakland general population);
4. Purchase third housing facility./rapid re-housing facility, like The Holland and Henry Robinson center;
5. Create multi-agency Housing Pipeline Committee including representatives of the City, Alameda County and the Oakland Housing Authority to coordinate and align investments of all resources to finance the capital, operating, and supportive service costs of permanent supportive housing and deeply affordable housing to meet the needs of people experiencing homelessness;
6. Explore a Countywide ballot measure for support services and to create deeply affordable housing for 20% and below Area Median Income.

The long-awaited [Bike Plan Update](#) is ready! Thousands of Oaklanders provided thoughtful participation during the year and a half planning process. Renter protections adopted for all tenants in duplexes & triplexes; plus introduction of tax relief for small landlords

On June 4th, the Oakland City Council unanimously passed legislation that I introduced with Councilmember Noel Gallo to give tenants in owner-occupied two- and three-unit parcels the same renter protections already provided to both (1) owner-occupied four-or-more-unit parcels and (2) two- and three-unit parcels not occupied by the owner. Following last year's Measure Y approved by the voters to bring these units under Just Cause for Eviction, the new legislation completes that process by bringing these units under Oakland's rent stabilization and tenant protection ordinances. The City will notify affected property owners of the change within the next 60 days. This legislation included a possible limited transitional increase, and of course owners of newly constructed units retain applicable exemptions under state law from these requirements.

Councilmember Gallo and I also have introduced a legislative proposal to give a business tax exemption or reduction for low-to-moderate income landlords who only rent out rooms in their own home or a second unit on the property on which they live. This proposal is anticipated to be considered by the City Council this month.

Oakland Public Library Eliminates Overdue Fines

Oakland City Council approved a request from the Oakland Public Library (OPL) to eliminate overdue fines for library materials during its May 21st meeting. Books, audiobooks, CD's, DVDs and items reserved through LINK+ will no longer incur overdue fines. Tools checked out from

the Oakland Tool Lending Library will still have overdue fines, although those fines will be significantly reduced. Patrons will still be billed a replacement fee for items not returned 30 days past the due date. The fee will be excused when the item is returned in good condition.

OPL joins over 50 library systems nationwide in recognizing that overdue fines create unnecessary and inequitable barriers to resources. Moreover, overdue fines negatively affect patrons who can least afford the fine and are not an effective incentive to returning library materials.

Overdue fines disproportionately impacted communities of color. An adult in a predominantly non-White zip code in Oakland, compared to an adult in predominantly White zip code in Oakland, was:

- 5% more likely to have a blocked record due to fines
- 26% more likely to owe library fines
- 45% less likely to use their card (based on average total checkout)

In 2017-18, the Library collected \$77,600 in overdue fines which were deposited into Oakland's General Purpose Fund. However, it cost the Library more than twice that amount in staff time to collect that income.

Finally, OPL does not anticipate negative impact on availability of popular titles. After City Council approved elimination of overdue fines for youth patrons in 2017, the number of Juvenile and Teen library cardholders increased by 17%; circulation of Juvenile of Teen materials increased by 12%; and there was no impact to the rate of unreturned items.

AC Transit bus fare changes: July 1, 2019

In order to continue providing safe and efficient service while addressing rising operational costs, in March 2019 the AC Transit Board of Directors adopted a new local fare structure to be applied on July 1, 2019. Adult Single ride cash fare will rise from \$2.35 to \$2.50; Adult Day Pass cash fare will rise from \$5.00 to \$5.50. Youth, Senior, and Disabled fares will rise from \$1.15 to \$1.25.

However, Clipper Adult Single ride and Day Pass will remain the same: \$2.25 for a single ride and \$5.00 for a day pass, due to higher Clipper discounts. Clipper Youth/Senior/Disabled fares will be adjusted from \$1.10 to \$1.12. You can apply for a Youth and Senior Clipper card [here](#).

CAHOOTS: An alternative response to 911 calls

Not all 911 calls need a police response. Oakland is considering a pilot program in which mental health professional and EMT respond to certain 911 calls - instead of police officers. An example of this approach is CAHOOTS (Crisis Assistance Helping Out On The Streets), a mobile crisis intervention team integrated into the public safety system in Eugene and Springfield, Oregon. CAHOOTS handles a broad range of non-criminal cases including homelessness, substance abuse and mental illness problems, dispute resolution, non-emergency medical care, and transportation to services.

Oakland Police Commission recruiting new members

In 2016, 83% of Oakland voters passed Measure LL, a change in the city charter, to create an independent Police Commission. The purpose of the Police Commission is to oversee the Oakland Police Department's policies, practices and customs to meet national standards of constitutional policing and to oversee the Community Police Review Agency that investigates police misconduct and recommends discipline.

The Commission is currently accepting applications for new members. Commissioners must be Oakland residents and cannot be current or former police officers, current city employees, or current or former officials, employees, or representatives of a union that represents police officers.

Measure W Vacancy Tax community meetings - June 27

Measure W, the Oakland Vacant Property Tax Act, was passed by Oakland voters in November 2018. Measure W establishes an annual tax on vacant property for 20 years to provide funding for homelessness programs and services, affordable housing, code enforcement, and clean-up of blighted properties and illegal dumping. A property is considered vacant if it “is in use less than fifty (50) days in a calendar year.”

We have received a number of queries from residents and property owners who are concerned about how this new tax will be implemented, primarily residents in the Oakland Hills where issues of land movement, density and wildfire prevention are top of mind.

The City’s Finance Department, responsible for the implementation and administration of the tax, is working on Implementation Ordinance and other decision-making strategies for submission to City Council for approval. City Staff working on Measure W implementation are very aware of the complexity of implementation, and that only residents can shed light on many issues the City will need to consider.

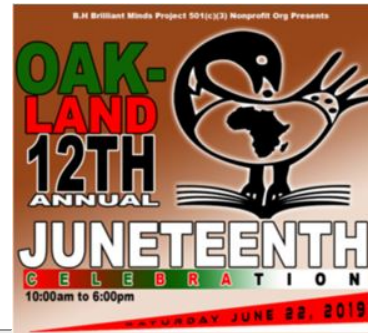

Official Bird of Oakland: The Black-crowned Night Heron

Two years ago, a class from a North Oakland Elementary School approached us about the plight of the Black-crowned Night Heron. They did a lot of research and impressed our office with their commitment to saving and celebrating this persevering bird. We also followed up with organizations that have expertise in migratory birds and bird conservation.

Based on all the input, we recognized a pretty strong consensus that this bird is a logical and appropriate bird for the City of Oakland. No matter how many times they are displaced or face hardships, Black-Crowned Night Herons keep coming back and even thrive. So I introduced legislation, co-sponsored by Mayor Libby Schaaf, to make the Night Heron our official bird.

The students attended and spoke up at the April 4th Rules Committee to get the item scheduled. Then they came to the May 14th Public Works Committee and convinced members to recommend the official bird designation to City Council. And on May 21, City Council approved adopting the [Black-crowned Night Heron](#) as the official Bird of Oakland. Through the process, Oakland students learned about city government, including the fact that perseverance and effective advocacy can make things happen!
