SUMMARY

The Oakland Parks, Recreation & Youth Development received a request from A Sista's Touch, a non-profit organization, whose mission is to nurture and acknowledge positive personal and professional influences of African American women of all generations in the community, with a foundational focus on adolescent girls. A Sista's Touch is requesting approval to collect on-site donations for the We Run Oakland For Our Daughter Charity Walk/Run to be held at Lakeside Park-Lake Merritt Blvd. Amphitheater on Saturday, August 27, 2022, 8:00am -12:00pm. The donations raised will go towards increasing awareness and resources to prevent "Our Daughters" from the epidemic of human trafficking. The applicant is aware of the additional permits required. Approval from the Parks and Recreation Advisory Commission is required per O.M.C. section 12.64.080.

FISCAL IMPACT

A Sista's Touch is paying all rental fees associated with the event estimated at \$670.00.

PROJECT / PROGRAM DESCRIPTION

The We Run Oakland: For Our Daughters Charity Walk/Run will solicit registrants to walk/run the 3.1-mile distance around Lake Merritt as well as sponsors to provide education, resources,

giveaways, and donations to support "our daughters", parents, families, and community interests in understanding and mitigating sex trafficking in the community. This event will be a fun time for all community members to cultivate mindfulness, exercise the body, and connect spiritually with those who seek to create a positive society For Our Daughters.

This written proposal is also to request the option to collect on-site registration donations to support future programming ideas aimed at the For Our Daughters campaign.

The estimated attendance is 150.

BACKGROUND / LEGISLATIVE HISTORY

A Sista's Touch was established in 2017, to serve the Oakland and Greater Bay Area communities, their aim is to address local issues from a three-fold perspective: Edify, Elevate, and Celebrate Excellence. Their model of character is to cultivate through the experience of Sista's who have achieved success, begets a strengthened community for a profound legacy of Sista's.

Beginning in 2018, program development will focus on their new campaign: *For Our Daughters*. Curriculum will be designed to mature young Sista's in the areas of self-efficacy, physical & mental developmental health, social media safety, and legacy formation. One of the spearheading topics in 2018, is sex exploitation and the human trafficking epidemic in local communities. To put their mission in action, A Sista's Touch is organizing this event to raise awareness and to mitigate the effects of this epidemic on "*our daughters*", our families, and our communities.

RECOMMENDATION

Staff recommends that the Parks and Recreation Advisory Commission approve the request from the A Sista's Touch to collect onsite registration donations at the We Run Oakland: For Our Daughters Charity Walk/Run to be held at Lakeside Park (Pergola) on Saturday, August 27, 2022, at 8:00am-12:00pm.

Living in a society that continues to challenge the ideals of morality, ethics, social justice, and gender equality, the demand to build a strong community of Sistas to secure a legacy in which our young queens are able to thrive, is evident.

Organization History

A Sista's Touch (AST) is a newly incorporated 501c3 nonprofit public benefited organization with a mission is to cultivate and celebrate positive personal and professional influences of African American women of all generations in the community; with a foundational focus on our adolescent girls. Formed in 2017 to serve the Oakland and Greater Bay Area communities, our aim is to address issues impacting the community of African-American girls/women from a three-fold perspective: *Edify, Elevate, and Celebrate Excellence.* Our model of character cultivation through the experience of Sistas who have achieved success, begets a strengthened community for a profound legacy of Sistas.

AST began our first public activity in June 2018 with our inaugural charity 5k run/walk event, We Run Oakland: For Our Daughters, to raise awareness for human trafficking. The focus of the 2018 race was to bridge the community gap between resources and community members to advocate for Our Daughters against the perils of human trafficking. The focus for the 5th annual, We Run Oakland: For Our Children, will continue to bridge the gap on the behalf of our children, as the perils of human trafficking impact our young boys/men as well. Returning back to in-person for this milestone event after a 2-year hiatus gives us great motivation to pick up where we left off in 2019. Our programs are designed to cultivate our young Sistas in the areas of selfefficacy, physical & mental developmental health, social media safety, and legacy formation. To put our mission

in action, AST has taken a path to advocate for the ending of sex exploitation and the human trafficking epidemic in our local communities. The goal is to raise awareness and to mitigate the effects of this epidemic on Our *Children*, our families, and our communities.

We Run Oakland: For Our Children, a charity 5k run/walk event to build community engagement and involvement in Oakland to increase awareness and resources to prevent and support Our Children from the epidemic of human trafficking.

The event is strategically scheduled at the beginning of summer to ensure parents/guardians and their children have the knowledge and resources to defend their safety during a heightened season for leisure time and predatory behavior.

Event Overview

This written proposal is to request the use of Oakland Parks and Recreation facility: Lake Merritt Blvd Amphitheater at Lake Merritt, to support the "We Run Oakland: For Our Children" charity 5k run/walk event on August 27, 2022.

The purpose of the event is to afford a holistic: mind, body, and spirit approach to civic engagement for a population fundamental to our mission and a common cause central to the legacy of our children, community, and our city. The goal of *We Run Oakland* is to realize the vision of garnering community support to mobilize against the perils of sex trafficking through awareness and edification.

We Run Oakland: For Our Children will solicit registrants to run/walk the 3.1-mile distance around Lake Merritt as well as sponsors to provide education, resources, giveaways, and donations to support Our Children, parents, families, and community interests in understanding and mitigating human trafficking in our community. The event will be a fun time for all community members to cultivate mindfulness, exercise the body, and connect spiritually with those who seek to create a positive society For Our Children.

Request to Collect On-Site Funds

This written proposal also requests the option to collect on-site funds to accept same-day registrations donations, which will support our programs. Monies collected on-site will be in electronic formats only (RunSignup, Cash App, PayPal, Vimeo, and Square), NO cash will be collected. Donation amounts will be at the discretion of the donor, but not to exceed \$100 for a single transaction.

Additionally, same-day registration allows latecomers to participate. As a newly established nonprofit organization, the ability to receive on-site donations from individuals who happenstance on our preplanned event at Lakeside Park and have the desire to donate, allows AST to capitalize on community contributions in the moment. The establishment of a relationship with the community through donations will help in the development and delivery of programs support our mission.

Benefits

The benefits of receiving on-site funding increases the opportunity for AST to enlarge financial support from individuals who feel inclined to donate in real time, rather than depending on a deferred method of support by directing potential donors to our website. Additionally, the presentation of readiness through the receipt of on-site donations exhibits the technological advancement and quality customer service AST espouses.

SUMMARY

Oakland Parks, Recreation and Youth Development (OPRYD) received a request from the Friends of the Oakland Municipal Band, also known as FOMB, accept donations and sell refreshments on site at the five concerts of the current season of the Oakland Municipal Band. The Oakland Municipal Band performs a variety of musical selections from classical to Broadway and Hollywood at the Edoff Memorial Bandstand. The musicians are union professionals who are members of orchestras and symphonies throughout the Bay Area. The concerts are free and open to all.

FISCAL IMPACT

FOMB is responsible for paying the musicians, the conductors and other direct expenses of the Oakland Municipal Band's performances at the Edoff Memorial Bandstand. The members of FOBM are volunteers. FOMB are partners with OPRYD in continuing one of Oakland's longest running cultural arts programs.

PROJECT DESCRIPTION

The purpose of the current season of the Oakland Municipal Band is in line with the mission of OPRYD. The concerts are part of the national culture of live summer music performances. They foster a better understanding of American diversity by presenting selections from the nation's rich musical traditions. As free, open air concerts, the band performances are accessible and fun entertainment for all generations. Many families have attended for many years, and for children, these concerts can be their first exposure to live classical and pops music.

BACKGROUND

The Friends of the Oakland Municipal Band is a 501(c)3 organization, was founded in November, 2010 and incorporated on January 26, 2012 in the city of Oakland, California. FOMB is registered as a Californian non-profit corporation and has a valid city business license.

RECOMMENDATION

Staff recommends that the Park and Recreation Advisory Commission approve the Friends of the Oakland Municipal Band's request to collect donations and sell refreshments at the five concerts of the current season of the Oakland Municipal Band.

On behalf of Friends of the Oakland Municipal Band (FOMB), I ask that you and your fellow commissioners on the Parks and Recreation Advisory Commission (PRAC) allow FOMB to collect monies on site during the five concerts of the 108th season of the Oakland Municipal Band. The concert dates are July 4, 10, 17, 24 and 31. Presented at the historic Edoff Municipal Bandstand in Lakeside Park, the concerts begin at 1:00 pm and end at 3:00 pm. FOMB accepts donations from audience members and sells refreshments during intermission. Accepting donations is critical to our mission as we are responsible for paying the musicians, the conductors and other direct expenses of the Oakland Municipal Band's performances. FOMB sells refreshments during intermission in order to retain our audience. We make only a modest amount of money from the sale of snacks, but people attending cultural arts events expect to find refreshments during intermission.

The members of FOBM are volunteers. The group began in 1988 as a committee of the Oakland Parks and Recreation Foundation (then known as the Oakland Parks Foundation.) FOMB was founded as a independent non-profit in November 2010 and incorporated as a 501c(3) organization on January 26, 2012. FOMB is duly registered as a non-profit corporation in the State of California and has a valid City of Oakland business license.

The 35-piece band Oakland Municipal Band performs a variety of musical selections from classical to Broadway and Hollywood for the enjoyment and enrichment of the diverse population of Oakland and the surrounding communities. Musicians are members of orchestras and symphonies throughout the Bay Area. We hire through the Musicians Union Local 6, and these concerts provide a welcome income during the offseason to musicians in our community.

The Oakland Municipal Band is one of oldest musical organizations in the United States. Since 1912, the Oakland Municipal Band has performed live music in the heart of the city. These free outdoor concerts make live music available to many who may otherwise not be able to experience the excitement of live performance. Lakeside Park is the cultural heart of the city, and these concerts bring residents of all ages and backgrounds together for quality live music, picnicking and socializing. Some audience members have been enjoying concerts for more than 50 years. For children, these concerts are often their first exposure to live performance of the American songbook. Many people enjoy the music as they engage in other activities at Lakeside Park. The volunteer members of FOMB are committing to keeping the Band playing on.

Oakland Parks, Recreation & Youth Development received a request from the East Bay Front Runners and Walkers, a non-profit organization, that is affiliated with Road Runners Club of America, a nationwide organization that provides advice, support and liability insurance for recreational running clubs. East Bay Front Runner and Walkers is requesting approval to collect on-site registration fees at the 5K and 10K Pride Run/Walk, proceeds raised from the event will be donated to several local nonprofit organizations after expenses. The applicant is aware of the additional permits required. Approval from the Parks and Recreation Advisory Commission is required per O.M.C. section 12.64.080.

FISCAL IMPACT

East Bay Front Runners and Walkers is paying all fees associated with the event estimated at \$550.00.

PROJECT / PROGRAM DESCRIPTION

The East Bay Front Runners and Walkers since 2005, has held their Pride Run/Walk consisting of 5K and 10K loops around Lake Merritt to encourage healthy recreation, particularly among those who are interested in a competitive event. The Pride Run/Walk is timed, and prizes are awarded to the winners in various categories.

The following funds and items are being requested to collect on site:

• Registration Fees – Day of Race \$30

The estimated attendance is 150.

BACKGROUND / LEGISLATIVE HISTORY RECOMMENDATION

East Bay Front Runners and Walkers is a group of LGBTQ runners and friends who enjoy exercising outdoors. The club holds run/walks every Saturday morning as scenic locations in the East Bay, including Lake Merritt, Emeryville-Berkeley Shoreline, and Bay Farm Island. The Saturday morning run/walks are non-competitive and very informal; participants simply meet at the announced location and then run or walk together.

East Bay Front Runners and Walkers is a group of LOBTQ runners, walkers, and friends who enjoy exercising outdoors. Club members meet for a run or walk every Saturday morning at a scenic location in the East Bay, including Lake Merritt, the Emeryville-Berkeley shoreline, and Bay Farm Island. The Saturday morning run/walks are non-competitive and informal; participants simply meet at the announced location and then run or walk together.

Beginning in 2005, the club has held an annual Pride Run/Walk consisting of 5K and 10K loops around Lake Merritt to encourage healthy recreation, particularly among those who are interested in a competitive event. In 2020 and 2021, a virtual run/walk rather than an in-person event was held; participants simply ran or walked at the location of their choice. For 2022, the club plans an inperson event. As in previous years, the Pride Run/Walk is timed, and the winners in various categories are recognized. All participants receive simple refreshments (muffins, bagels, fruit, and juice) and a pair of EBFRW socks bearing the club's initials. At a couple of the past events, informational booths have been set up by a local chiropractor or gym, but nothing was sold.

Net proceeds from the Pride Run/Walk event have been donated to several local nonprofit organizations, and we plan to continue doing this in future years. The club has endeavored to turn over all event proceeds after expenses to recipient organizations. (Ordinary club expenses are supported by annual membership dues and not by the Pride Run event.) The most recent in-person Pride event, held in October 2019, generated a total of \$1,700 that was divided among:

- Pacific Center in Berkeley, which provides professional counseling and advocacy to enhance the well-being and self-respect of lesbian, gay, bisexual, and transgender individuals.
- Oakland LGBTQ Community Center, dedicated to enhancing and sustaining the well-being
 of Oakland's LGBTQ individuals, families, and allies.
- Oakland Gay Men's Chorus, a 40 to 50 voice choral group that performs a wide variety of
 music each year in concert and in numerous church, community, and outreach performances.

Recipient organizations have not yet been determined for 2022.

The number of participants has varied from year to year. In 2019, 142 persons registered for the event, 19 of them on-site. Most runners and walkers pre-register using the club's website

(www.eastbayfrontrunners.org). Registration fees have always been kept very low in order to maximize participation. The pre-registration fee of \$25, versus the on-site fee of \$30, has encouraged participants to sign up in advance. We anticipate that registration fees for 2022 will be the same or slightly more, depending on event expenses.

In 2022, the East Bay Front Runners and Walkers club hopes to expand the reach of its annual Pride Run/Walk, both in the number of participants and in the funds raised for donation to worthy nonprofit organizations. To assist in meeting this goal, the club requests permission to accept registration fees on race day at the event in Lakeside Park on October 8, 2022. Pre-registration will continue to be encouraged. We anticipate that most participants will pre-register, but having the option to accept on-site registration enhances the event's appeal and increases the number of participants. We hope to reach a goal of approximately 180 registrants in 2022, with fees to be collected on-site amounting to perhaps \$500 at most.

No on-site donations will be solicited, although if offered, any donations to EBFRW to support the event would be gladly accepted. No sale of food or other items will take place.

East Bay Front Runners and Walkers is a nonprofit organization with 501(c)(3) status and is affiliated with Road Runners Club of America (www.rrca.org), a nationwide organization that provides nonprofit status and other services to recreational running clubs (see attachments). Liability insurance for East Bay Front Runners and Walkers' Pride Run/Walks is supplied through RRCA.

Thank you for your consideration, and please do not hesitate to let me know if I can provide additional information. Members of our club would be very willing to attend a Parks and Recreation Advisory Commission meeting and answer any questions.

SUMMARY

This report provides:

- 1. OPW's routine updates to PRAC regarding the hiring of staff related to Measure Q-funded park maintenance services.
- 2. In additional supplemental material, this report includes updated performance measures in the delivery of Measure Q-funded services, incorporating input the department received from PRAC Commissioners in recent presentations.

FISCAL IMPACT

Since this report is informational only, no fiscal impacts are included.

BACKGROUND / LEGISLATIVE HISTORY

Measure Q, approved by Oakland voters in March 2020, provides funding for City of Oakland services related to parks maintenance, homelessness services, and water quality, subject to civilian oversight. The Oakland City Council assigned PRAC the oversight role regarding the Measure Q expenditures related to parks maintenance and water quality services.

As a component of this oversight function, OPW routinely submits to PRAC updates on hiring of positions related to Measure Q-funded park maintenance services. This report provides an update for the PRAC's meeting of February 9, 2022. For the first time, this report now also includes a chart representing hiring trends, so that PRAC and the public can see how hiring and staffing of Measure Q positions is changing over time.

Additionally, Measure Q includes service performance requirements. OPW has been working with the PRAC Measure Q ad hoc committee and with community members to develop a reporting template for measuring and tracking performance of those services. The department's goal is a routine report that is clear, simple, and accessible to the community to provide transparent and accessible reporting on service delivery. This will be an iterative process, and OPW welcomes feedback from PRAC on how the department can continue honing that reporting template.

RECOMMENDATION

OPW recommends that PRAC accept this informational report.



ADOPT A RESOLUTION DETERMINING THAT CONDUCTING IN-PERSON MEETINGS OF THE PARKS AND RECREATION ADVISORY COMMISSION AND ITS COMMITTEES WOULD PRESENT IMMINENT RISKS TO ATTENDEES' HEALTH, AND ELECTING TO CONTINUE CONDUCTING MEETINGS USING TELECONFERENCING IN ACCORDANCE WITH CALIFORNIA GOVERNMENT CODE SECTION 54953(e), A PROVISION OF AB-361.

WHEREAS, on March 4, 2020, Governor Gavin Newsom declared a state of emergency related to COVID-19, pursuant to Government Code Section 8625, and such declaration has not been lifted or rescinded. *See* <u>https://www.gov.ca.gov/wp-content/uploads/2020/03/3.4.20-</u> Coronavirus-SOE-Proclamation.pdf; and

WHEREAS, on March 9, 2020, the City Administrator in their capacity as the Director of the Emergency Operations Center (EOC), issued a proclamation of local emergency due to the spread of COVID-19 in Oakland, and on March 12, 2020, the City Council passed Resolution No. 88075 C.M.S. ratifying the proclamation of local emergency pursuant to Oakland Municipal Code (O.M.C.) section 8.50.050(C); and

WHEREAS, City Council Resolution No. 88075 remains in full force and effect to date; and

WHEREAS, the Centers for Disease Control (CDC) recommends physical distancing of at least six (6) feet whenever possible, avoiding crowds, and avoiding spaces that do not offer fresh air from the outdoors, particularly for people who are not fully vaccinated or who are at higher risk of getting very sick from COVID-19. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html</u>; and*

WHEREAS, the CDC recommends that people who live with unvaccinated people avoid activities that make physical distancing hard. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/your-health/about-covid-19/caring-for-children/families.html</u>; and*

WHEREAS, the CDC recommends that older adults limit in-person interactions as much as possible, particularly when indoors. *See <u>https://www.cdc.gov/aging/covid19/covid19-older-adults.html</u>; and*

WHEREAS, the CDC, the California Department of Public Health, and the Alameda County Public Health Department all recommend that people experiencing COVID-19 symptoms stay home. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/if-you-are-sick/steps-when-sick.html</u>; and*

WHEREAS, persons without symptoms may be able to spread the COVID-19 virus. *See* <u>https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html</u>; and

WHEREAS, fully vaccinated persons who become infected with the COVID-19 Delta variant can spread the virus to others. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated.html</u>; and*

WHEREAS, the City's public-meeting facilities are indoor facilities that do not ensure circulation of fresh / outdoor air, particularly during periods of cold and/or rainy weather, and were not designed to ensure that attendees can remain six (6) feet apart; and

WHEREAS, holding in-person meetings would encourage community members to come to City facilities to participate in local government, and some of them would be at high risk of getting very sick from COVID-19 and/or would live with someone who is at high risk; and

WHEREAS, in-person meetings would tempt community members who are experiencing COVID-19 symptoms to leave their homes in order to come to City facilities and participate in local government; and

WHEREAS, attendees would use ride-share services and/or public transit to travel to inperson meetings, thereby putting them in close and prolonged contact with additional people outside of their households; and

WHEREAS, on October 13, 2021, year the Parks and Recreation Advisory Commission adopted a resolution determining that conducting in-person meetings would present imminent risks to attendees' health, and electing to continue conducting meetings using teleconferencing in accordance with California Government Code Section 54953(e), a provision of AB-361; now therefore be it:

RESOLVED: that the Parks and Recreation Advisory Commission finds and determines that the foregoing recitals are true and correct and hereby adopts and incorporates them into this resolution; and be it

FURTHER RESOLVED: that, based on these determinations and consistent with federal, state and local health guidance, the Parks and Recreation Advisory Commission renews its determination that conducting in-person meetings would pose imminent risks to the health of attendees; and be it

FURTHER RESOLVED: that the Parks and Recreation Advisory Commission firmly believes that the community's health and safety and the community's right to participate in local government, are both critically important, and is committed to balancing the two by continuing to use teleconferencing to conduct public meetings, in accordance with California Government Code Section 54953(e), a provision of AB-361; and be it

FURTHER RESOLVED: that the Parks and Recreation Advisory Commission will renew these (or similar) findings at least every thirty (30) days in accordance with California Government Code section 54953(e) until the state of emergency related to COVID-19 has been lifted, or the Parks and Recreation Advisory Commission finds that in-person meetings no longer pose imminent risks to the health of attendees, whichever occurs first.

ADOPT A RESOLUTION DETERMINING THAT CONDUCTING IN-PERSON MEETINGS OF THE PARKS AND RECREATION ADVISORY COMMISSION AND ITS COMMITTEES WOULD PRESENT IMMINENT RISKS TO ATTENDEES' HEALTH, AND ELECTING TO CONTINUE CONDUCTING MEETINGS USING TELECONFERENCING IN ACCORDANCE WITH CALIFORNIA GOVERNMENT CODE SECTION 54953(e), A PROVISION OF AB-361.

WHEREAS, on March 4, 2020, Governor Gavin Newsom declared a state of emergency related to COVID-19, pursuant to Government Code Section 8625, and such declaration has not been lifted or rescinded. *See* <u>https://www.gov.ca.gov/wp-content/uploads/2020/03/3.4.20-</u> Coronavirus-SOE-Proclamation.pdf; and

WHEREAS, on March 9, 2020, the City Administrator in their capacity as the Director of the Emergency Operations Center (EOC), issued a proclamation of local emergency due to the spread of COVID-19 in Oakland, and on March 12, 2020, the City Council passed Resolution No. 88075 C.M.S. ratifying the proclamation of local emergency pursuant to Oakland Municipal Code (O.M.C.) section 8.50.050(C); and

WHEREAS, City Council Resolution No. 88075 remains in full force and effect to date; and

WHEREAS, the Centers for Disease Control (CDC) recommends physical distancing of at least six (6) feet whenever possible, avoiding crowds, and avoiding spaces that do not offer fresh air from the outdoors, particularly for people who are not fully vaccinated or who are at higher risk of getting very sick from COVID-19. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html</u>; and*

WHEREAS, the CDC recommends that people who live with unvaccinated people avoid activities that make physical distancing hard. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/your-health/about-covid-19/caring-for-children/families.html</u>; and*

WHEREAS, the CDC recommends that older adults limit in-person interactions as much as possible, particularly when indoors. *See <u>https://www.cdc.gov/aging/covid19/covid19-older-adults.html</u>; and*

WHEREAS, the CDC, the California Department of Public Health, and the Alameda County Public Health Department all recommend that people experiencing COVID-19 symptoms stay home. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/if-you-are-sick/steps-when-sick.html</u>; and*

WHEREAS, persons without symptoms may be able to spread the COVID-19 virus. *See* <u>https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html</u>; and

WHEREAS, fully vaccinated persons who become infected with the COVID-19 Delta variant can spread the virus to others. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated.html</u>; and*

WHEREAS, the City's public-meeting facilities are indoor facilities that do not ensure circulation of fresh / outdoor air, particularly during periods of cold and/or rainy weather, and were not designed to ensure that attendees can remain six (6) feet apart; and

WHEREAS, holding in-person meetings would encourage community members to come to City facilities to participate in local government, and some of them would be at high risk of getting very sick from COVID-19 and/or would live with someone who is at high risk; and

WHEREAS, in-person meetings would tempt community members who are experiencing COVID-19 symptoms to leave their homes in order to come to City facilities and participate in local government; and

WHEREAS, attendees would use ride-share services and/or public transit to travel to inperson meetings, thereby putting them in close and prolonged contact with additional people outside of their households; and

WHEREAS, on October 13, 2021, year the Parks and Recreation Advisory Commission adopted a resolution determining that conducting in-person meetings would present imminent risks to attendees' health, and electing to continue conducting meetings using teleconferencing in accordance with California Government Code Section 54953(e), a provision of AB-361; now therefore be it:

RESOLVED: that the Parks and Recreation Advisory Commission finds and determines that the foregoing recitals are true and correct and hereby adopts and incorporates them into this resolution; and be it

FURTHER RESOLVED: that, based on these determinations and consistent with federal, state and local health guidance, the Parks and Recreation Advisory Commission renews its determination that conducting in-person meetings would pose imminent risks to the health of attendees; and be it

FURTHER RESOLVED: that the Parks and Recreation Advisory Commission firmly believes that the community's health and safety and the community's right to participate in local government, are both critically important, and is committed to balancing the two by continuing to use teleconferencing to conduct public meetings, in accordance with California Government Code Section 54953(e), a provision of AB-361; and be it

FURTHER RESOLVED: that the Parks and Recreation Advisory Commission will renew these (or similar) findings at least every thirty (30) days in accordance with California Government Code section 54953(e) until the state of emergency related to COVID-19 has been lifted, or the Parks and Recreation Advisory Commission finds that in-person meetings no longer pose imminent risks to the health of attendees, whichever occurs first.

The concert dates are July 4, 10, 17, 24 and 31. Presented at the historic Edoff Municipal Bandstand in Lakeside Park, the concerts begin at 1:00 pm and end at 3:00 pm. FOMB accepts donations from audience members and sells refreshments during intermission. Accepting donations is critical to our mission as we are responsible for paying the musicians, the conductors and other direct expenses of the Oakland Municipal Band's performances. FOMB sells refreshments during intermission in order to retain our audience. We make only a modest amount of money from the sale of snacks, but people attending cultural arts events expect to find refreshments during intermission.

The members of FOBM are volunteers. The group began in 1988 as a committee of the Oakland Parks and Recreation Foundation (then known as the Oakland Parks Foundation.) FOMB was founded as a independent non-profit in November 2010 and incorporated as a 501c(3) organization on January 26, 2012. FOMB is duly registered as a non-profit corporation in the State of California and has a valid City of Oakland business license.

The 35-piece band Oakland Municipal Band performs a variety of musical selections from classical to Broadway and Hollywood for the enjoyment and enrichment of the diverse population of Oakland and the surrounding communities. Musicians are members of orchestras and symphonies throughout the Bay Area. We hire through the Musicians Union Local 6, and these concerts provide a welcome income during the offseason to musicians in our community.

The Oakland Municipal Band is one of oldest musical organizations in the United States. Since 1912, the Oakland Municipal Band has performed live music in the heart of the city. These free outdoor concerts make live music available to many who may otherwise not be able to experience the excitement of live performance. Lakeside Park is the cultural heart of the city, and these concerts bring residents of all ages and backgrounds together for quality live music, picnicking and socializing. Some audience members have been enjoying concerts for more than 50 years. For children, these concerts are often their first exposure to live performance of the American songbook. Many people enjoy the music as they engage in other activities at Lakeside Park. The volunteer members of FOMB are committing to keeping the Band playing on.

East Bay Front Runners and Walkers is a group of LOBTQ runners, walkers, and friends who enjoy exercising outdoors. Club members meet for a run or walk every Saturday morning at a scenic location in the East Bay, including Lake Merritt, the Emeryville-Berkeley shoreline, and Bay Farm Island. The Saturday morning run/walks are non-competitive and informal; participants simply meet at the announced location and then run or walk together.

Beginning in 2005, the club has held an annual Pride Run/Walk consisting of 5K and 10K loops around Lake Merritt to encourage healthy recreation, particularly among those who are interested in a competitive event. In 2020 and 2021, a virtual run/walk rather than an in-person event was held; participants simply ran or walked at the location of their choice. For 2022, the club plans an inperson event. As in previous years, the Pride Run/Walk is timed, and the winners in various categories are recognized. All participants receive simple refreshments (muffins, bagels, fruit, and juice) and a pair of EBFRW socks bearing the club's initials. At a couple of the past events, informational booths have been set up by a local chiropractor or gym, but nothing was sold.

Net proceeds from the Pride Run/Walk event have been donated to several local nonprofit organizations, and we plan to continue doing this in future years. The club has endeavored to turn over all event proceeds after expenses to recipient organizations. (Ordinary club expenses are supported by annual membership dues and not by the Pride Run event.) The most recent in-person Pride event, held in October 2019, generated a total of \$1,700 that was divided among:

- Pacific Center in Berkeley, which provides professional counseling and advocacy to enhance the well-being and self-respect of lesbian, gay, bisexual, and transgender individuals.
- Oakland LGBTQ Community Center, dedicated to enhancing and sustaining the well-being
 of Oakland's LGBTQ individuals, families, and allies.
- Oakland Gay Men's Chorus, a 40 to 50 voice choral group that performs a wide variety of
 music each year in concert and in numerous church, community, and outreach performances.

Recipient organizations have not yet been determined for 2022.

The number of participants has varied from year to year. In 2019, 142 persons registered for the event, 19 of them on-site. Most runners and walkers pre-register using the club's website

(www.eastbayfrontrunners.org). Registration fees have always been kept very low in order to maximize participation. The pre-registration fee of \$25, versus the on-site fee of \$30, has encouraged participants to sign up in advance. We anticipate that registration fees for 2022 will be the same or slightly more, depending on event expenses.

In 2022, the East Bay Front Runners and Walkers club hopes to expand the reach of its annual Pride Run/Walk, both in the number of participants and in the funds raised for donation to worthy nonprofit organizations. To assist in meeting this goal, the club requests permission to accept registration fees on race day at the event in Lakeside Park on October 8, 2022. Pre-registration will continue to be encouraged. We anticipate that most participants will pre-register, but having the option to accept on-site registration enhances the event's appeal and increases the number of participants. We hope to reach a goal of approximately 180 registrants in 2022, with fees to be collected on-site amounting to perhaps \$500 at most.

No on-site donations will be solicited, although if offered, any donations to EBFRW to support the event would be gladly accepted. No sale of food or other items will take place.

East Bay Front Runners and Walkers is a nonprofit organization with 501(c)(3) status and is affiliated with Road Runners Club of America (www.rrca.org), a nationwide organization that provides nonprofit status and other services to recreational running clubs (see attachments). Liability insurance for East Bay Front Runners and Walkers' Pride Run/Walks is supplied through RRCA.

SUMMARY

This report provides:

- 1. OPW's routine updates to PRAC regarding the hiring of staff related to Measure Q-funded park maintenance services.
- 2. In additional supplemental material, this report includes updated performance measures in the delivery of Measure Q-funded services, incorporating input the department received from PRAC Commissioners in recent presentations.

FISCAL IMPACT

Since this report is informational only, no fiscal impacts are included.

BACKGROUND / LEGISLATIVE HISTORY

Measure Q, approved by Oakland voters in March 2020, provides funding for City of Oakland services related to parks maintenance, homelessness services, and water quality, subject to civilian oversight. The Oakland City Council assigned PRAC the oversight role regarding the Measure Q expenditures related to parks maintenance and water quality services.

As a component of this oversight function, OPW routinely submits to PRAC updates on hiring of positions related to Measure Q-funded park maintenance services. This report provides an update for the PRAC's meeting of February 9, 2022. For the first time, this report now also includes a chart representing hiring trends, so that PRAC and the public can see how hiring and staffing of Measure Q positions is changing over time.

Additionally, Measure Q includes service performance requirements. OPW has been working with the PRAC Measure Q ad hoc committee and with community members to develop a reporting template for measuring and tracking performance of those services. The department's goal is a routine report that is clear, simple, and accessible to the community to provide transparent and accessible reporting on service delivery. This will be an iterative process, and OPW welcomes feedback from PRAC on how the department can continue honing that reporting template.

RECOMMENDATION

OPW recommends that PRAC accept this informational report.


