The Human Services Department's Interim Director, Scott Means, delivered a brief update on staffing and the mid-cycle budget process. Due to the reductive budget and its potential impact to Aging and Adult Services, Director Means intends to invite incoming Fiscal Manager Kurry Foley to a future meeting. Outreach Developer Jessi Cutter will attend the next meeting to discuss Zoom Public Meetings at Senior Centers.

#### 9. MCOA Stakeholders Groups and Other Updates

#### Health and Wellness

B. Spears reported on the distribution of 500 copies of the Seniors Resource Guide. Commissioners will deliver the resource guides to their respective Senior Centers. B. Spears additionally addressed hosting Listening Sessions after the new AAS Manager is in place, with an expected completion date of the end of summertime (September 22, 2024).

B. Scott reported on the ongoing hand-off between former Commissioner Dianna Garrett and himself. Additionally, B. Scott discussed contract delays and the status of the Eden I&R database project.

- **8.** Advocacy Presentation: Wendy Peterson, Senior Services Coalition of Alameda County Wendy Peterson presented a wonderful presentation providing very detailed information about what the Senior Services Coalition of Alameda County is about, including the data they have collected and key points to what this data could be good for. Wendy provided her key messages and talking points document for all the commissioners and audience members to following along during her presentation. Wendy suggests a meeting where the MCOA presents at their coalition. Chair Gunst asked, how long should the meetings be. Wendy responded with 30 mins, a wellorchestrated meeting, and at the beginning of the meeting discuss why we are there, leading into other things. Should we provide advance meeting material Chair Gunst asked. Wendy replied, it would be more productive to have a personal connection rather than focusing on a piece of paper. Commissioner Scott asked about organization of the meeting with staff. Wendy responded Staff will coordinate the meeting details and will be helpful. Commissioner Siebert asked if two commissioners at a time, rather than individual one on one conversations. Chair Gunst believes one on one will be better for this. Commissioner Siebert asked if we could get a break down of data by district. Wendy will investigate it. Commissioner Beene-Clarke asked, what can we do more to make sure we are doing everything we can to make our presence known. Wendy suggests different ways to approach this.
  - Chair Gunst opened the floor for public comment, (insert name) asked about maintaining relationships and keeping key departments in the loop with information. Wendy suggests maintaining communication.

Jessi provided a brief understanding of what we need to host zoom public meetings at senior centers. MCOA plans to host a meeting there in the coming months, and Jessi let the commissioners know what they will need to consider before hosting the meeting. We need someone with expertise in amplified sound to help with understanding how to do that for these meetings at DOSC.
  - Scott Means, HSD Interim Director: Scott Means introduced Kurry Foley.
    - o **Introduction of Kurry Foley, HSD Fiscal Manager**Kurry Foley the HSD Fiscal Manager introduced herself by sharing a robust presentation about HSD's Budget and how the funds are being issued. Kurry answered questions from commissioners about future plans.

6. Presentation: Transportation Options for Oakland Seniors and Persons with Disabilities – AC

#### Transit and Oakland Paratransit for Elderly and Disabled (OPED) Program

Andrea Mok acting supervisor for Oakland Paratransit for the Elderly and Disabled gave a brief introduction of herself and team. Andrea gave a presentation on what services they offer, requirements for eligibility, and how to access the services. Chair Gunst open the floor to commissioners for questions, and then to the public. Andrea Mok provided informative feedback to the questions received.

Chair Gunst requested a motion to add an additional presentation from Department of Violence Prevention (DVP) to the agenda.

#### • Presentation: Department of Violence Prevention (DVP) - Chief Yoshi

Chair Gunst gave a brief introduction of chief Yoshi. Holly Yoshi, Chief of department of violence prevention gave a very informative presentation on status of violence in Oakland and plans the City of Oakland is implementing to continue to tackle crime in Oakland. The department is under construction, currently building a team of life coaches who are in the field working hands on to reduce violence in the city. Chair Gunst opened this item up to the commissioners for questions and then to the public. Chief Yoshi provided great feedback to the questions that were asked.

## 7. Announcement: Development of the next Aging and Adult Services/Mayor's Commission on Aging 5-Year Plan

Chair Gunst opened this item on the agenda up with explaining what the Mayor's Commission on Aging 5-year plan is about, how we are ending the current 5-year plan, and how the MCOA intends on starting the planning of the new 5-year plan. Chair Gunst invited Human Services Manager Ana Bagtas to give a more detailed explanation of this process. Ana is excited to get this strategic plan started as she specializes in this area; she provided a great overview of how the team will get into the weeds of things. Ana asked the commissioners to be involved by reaching out to chair Gunst showing interested in join the Strategic Planning team.

#### 8. Advocacy for Senior Services

Chair Gunst turned this item over to Commissioner Hill who provided an understanding of how the MCOA plans to advocate for seniors and our Aging department. The stakeholder groups have a lot of goals and are requesting more help from the commissioners on reaching out to councilmembers from different districts to be the voice for our seniors in Oakland. This action will be done by the commissioners, they will not lean on the help of Human Services Department staff. Chair Gunst opened this item up to commissioners and public for comments and questions, Commissioner Hill and Chair Gunst provided great feedback to the questions asked.

#### 9. Calendaring of MCOA meetings at senior centers

Chair Gunst suggested that the commissioners discussed what months to host the next in the community MCOA meetings at the remainder senior centers (North Oakland, West Oakland, and Downtown senior centers). The commissioners collectively agreed to July 2024, October 2024, December 2024, and February 2025 meetings in the community. Chair Gunst suggested reaching out to the Kayla Brown Senior centers supervisor to find out each center's schedules, and which

months would be best to host which community session. Also, to reach out to the councilmembers in each district to support these meetings, like Councilmember Reid District 7 did for our April 2024 MCOA meeting that was held at the East Oakland Senior Center.
