 Teleconference Protocol, Roll Call/Determination of Quorum Meeting called to order by Noah Smith3 at 5:31pm. At roll call, quorum was established with seven of nine commissioners present (X); one (x) arrived later in the meeting; one was excused.

- 2. Open Forum
 - Sheila Gunn-Cushman, received her first CoVid vaccine shot. Made note that persons with disabilities are now eligible for shots.
 - Speaker name / topic.
- 3. Agenda Modification
 - A motion to accept the agenda as written was made by Commissioner Sperling, seconded by Commissioner Tevelson, and passed with all voting in favor.
- 4. Approval of February 2021 Minutes
 - A motion to approve the minutes was made by Commissioner Davenport, seconded by Commissioner Nakamura, and passed with all voting in favor.
- 5. Commissioner's Announcements
 - Commissioner Tevelson announced that the MACRO program is up for a final vote in the City Council and will be under the auspices of the Oakland Fire Dept.
 - Commissioner Tevelson reached out to the Reimagining Public Safety Task Force (RPSTF) to include learning objective 37 with CIT and learned that it had been pulled from the agenda. Was advised that once it is finalized there is a chance to have both issues put back in.
 - Commissioner Tevelson has advised the Department of Violence Prevention that he is their liaison from the Commission. The next Department of Violence Prevention town hall is Thursday, March 18, 2021.
 - Commissioner Nakamura will be coordinating with Yvonna Cazares from the Mayor's office on a future date for the MCPD to Co-Host a Community Safety Town Hall with the Oakland Fire Department and Oakland Emergency Services.
 - Commission Chair Smith, with assistance from previous Chairs, wrote and forwarded a letter to state officials regarding "vaccine rollouts" that impact people with disabilities. He also reported that the date for people with disabilities to receive vaccinations had been moved up to March 15. After noting accessibility issues with that the state's vaccine website, he received a response from the Department of Public Health, Director Gaily, who indicated that he will look further into the raised concerns and communicate them

with the Governor. Commission Chair Smith has scheduled meetings with a City of Berkeley staff member currently working on their elevator ordinance and a lawyer who worked on the original ordinance to learn about the process they went through in developing the ordinance.

6. Zero Emission Vehicle Action Plan

Michael Randolph from the Department of Transportation introduced the Zero Emission Vehicle Action Plan, a roadmap for a clean and equitable transportation system in Oakland, currently under development by the DOT and the Sustainable Oakland Program. See agenda Exhibit B for an overview of the presentation.

Highlights of discussion:

- Consider charging of wheelchairs (and scooters/other micromobility devices) in multi-unit buildings.
- Consider charging facilities at Oakland Public Libraries.
- Consider creating City incentives for the installation of facilities.
- Consider designs to make it easy as possible for people with disabilities to use; test designs in advance.
- Consider facilitating the ability of renters to install facilities—would require a City Ordinance.
- The public can suggest locations via an interactive/online map at <u>https://oakgis.maps.arcgis.com/apps/webappviewer/index.html?id=</u> <u>6d376e194e424a1e90a0edeba8873b2e</u>.
- People with visual impairments will have difficulty giving input using the map.
- The City's plan will be coordinated with the plans of other agencies, including BART and AC Transit.
- The minimum number of spaces that must be accessible are determined by the Division of State Architect and are in the California Building Code.
- Electric cars, scooters, bikes, etc. should be equipped to make noises such that they can be heard by the visually impaired.
- Michael would like to return to the MCPD at a later phase in the project.

7. Adaptive E-scooters

Kerby Olsen, New Mobility Supervisor at Oak DOT, provided a brief update on the adaptive scooter program. Each of Oakland's three shared Electric scooter providers presented their plans for adaptive vehicles in Oakland. See agenda Exhibit C for an overview of the presentations from Spin (Alex April and Julia Wunsch), Link (Walter Rosenkranz), and Veo (Alex Keating). Each provider described their services and vehicles.

Highlights of discussion:

SPIN

- Spin's delivery service is free. They are looking at how to support oneway trips including designs that can allow users to bring wheelchairs. The seated three-wheel device helps with stability. Other design elements include audible elements.
- Designs should allow for hauling crutches and should be ambidextrous. Steering dampers would help a wide range of users operate scooters.
- Braille is included on devices allowing people to report misplaced vehicles.
- Can service dogs be accommodated?

A motion to extend the meeting by 15 minutes was made by Commissioner Gregory, seconded by Commissioner Ryan, and passed with all voting in favor.

LINK

- New operator, powered by Superpedestrian, founded in 2013 at MIT.
- Launching a wheelchair assist pilot project, a partnership with the Center for Independent Living, in March in Berkeley. Project equips a user's chair by installing permanent hardware.
- Consider supporting one-way trips and how vehicles will be parked.

A motion to extend the meeting until 7:50pm was made by Commissioner Smith, seconded by Commissioner Gregory, and passed with all voting in favor.

VEO

New to Bay Area, but around since 2017, operating throughout the U.S.

- Deploying an adaptive device, one for every 50 stand-up scooters. Home delivery will be included.
- Looking to coordinate with BART, bike shops, other entities that could assist with user outreach/onboarding.

In 2021, the City of Oakland will update its <u>2016-2021 Local Hazard Mitigation</u> <u>Plan</u> (LHMP). The Plan update is a requirement to maintain FEMA funding eligibility. Throughout the process we will detail the natural hazards faced by our city and identify the risk reduction strategies that can help lessen the impact of future disasters. The Plan helps guide the City and its partners to implement these strategies throughout Oakland.

Oakland's most recent LHMP was adopted in 2016 but requires an update every five years. This current effort is the 2021 update to the 2016 Plan and will remain active, once approved, until 2025. Without the update the 2016 Plan expires in 2021. The overarching goal of the LHMP is to address multiple hazards faced by the City of Oakland and develop specific action items to reduce risks.





West Oakland MANDELA PARKWAY - SAN PABLO AVENUE/I-980


- Widest road with three travel lanes in each direction
- Longest blocks between intersections
- Vehicular traffic is prioritized & highest average vehicle speeds
- Parking is most-underutilized
- No bicycle facilities in this segment nor enhanced pedestrian crossing infrastructure at any of the uncontrolled crossings



Downtown SAN PABLO AVENUE/I-980 -HARRISON STREET

- Slower vehicles speeds
- More signalized intersections
- Greater volume of pedestrians and bicyclists
- Parking is very well utilized in this segment.
- Segments of bike lanes
- Less uncontrolled crossing

Adams Point HARRISON STREET -MACARTHUR BOULEVARD/I-580

- Higher density residential and Lake
 Merritt
- More commercial and retail fronting Grand Ave
- Parking is highly utilized in this segment
- Bicycle lanes are mostly continuous in the segment
- Multiple pedestrian crossing treatments at unsignalized crossings

Current Conditions - Walking

- Over 60% of the crossings of Grand Avenue in West Oakland are **uncontrolled** crossings with no crossing enhancements.
- Uncomfortable/highly-stressful crossings.
- Graphic below shows sidewalk inventory











Activated Median



Activated Median – Description of previous slide

CONCEPT

This concept puts emphasis on the center of Grand, focusing on improved circulation for transit and bicyclists. Important features include:

- a center running bus rapid transit BRT system, efficient for regional and local transit
- a raised two-way cycle-track, buffered from the roadway with amenities, trees, and bus stops
- widened sidewalks with bulb-outs for trees

• ample parking, less traffic noise, and slower vehicle speeds Vehicular movement is the most constrained with one lane in each direction. **INTERSECTIONS**


The center-running bus lanes and cycletrack access may require an increase in signal phasing and slow cross-traffic throughput with reduced left turns.

GOALS

This concept excels at meeting "Design for All" criteria with separated facilities for pedestrians, transit users, and bicyclists.

Design Alternatives

Bicycle & Micromobility Focus



Bicycle & Micromobility Focus - Description of previous slide CONCEPT

This concept places emphasis on a high-quality bicycle facility. Important features include:

- one-way cycle-tracks, raised to sidewalk level buffered from the roadway with a planters and parking
- widened sidewalks with a large amenity zone and canopy for a comfortable walking experience
- in-lane bus-stops that reduce transit delays with buses needing to pull over and back into traffic.

In this scenario, the BRT shares a lane with vehicles, so it is less transit focused.

INTERSECTIONS


Left and right turn lanes will require removal of parking lanes. Vehicular traffic/ transit mixing areas and bus stop placements require signal timing modifications.

GOALS

This concept excels at meeting "Make it Vibrant" criteria with a high-quality, lowstress bikeway, widened sidewalks set back from motorists, a continuous canopy.

Design Alternatives

Transit Edge



Transit Edge - Description of previous slide CONCEPT

This concept puts emphasis on the edges of the roadway with side-running Business Access & Transit (BAT) lanes. Important features include:

• side-running dedicated transit lanes BAT

• large sidewalks with a large tree canopy with flexible space for community gatherings, bus stops, lighting, and other amenities

Bike facilities are omitted in this concept, focusing on a walking/transit environment. **INTERSECTIONS**


BAT lanes are primarily dedicated for transit use, but allow some general traffic circulation for turning into driveways or onto intersecting streets. Right turning vehicles, bus stops, and transit movement should be coordinated.

GOALS

This concept excels at meeting "Keep it Oakland" criteria with a tree lined, expansive pedestrian experience, transit lanes, and space to hold community activities. However, the lack of bicycle facilities and large crossings are on the lower performing metrics for the "Feels Safe" goal.

Design Alternatives

Vehicular Throughput



Vehicular Throughput - Description of previous slide CONCEPT

In this concept, all modes are considered, with an emphasis on maintaining vehicle lanes. Important features include:

- maintaining number of existing vehicular lanes
- widened sidewalks
- bike lanes

While there is space provided for walking, biking, taking transit, and driving – the quality of the facilities is the important tradeoff - sidewalks do not have large amenity zones, bikeways do not have buffers, and motorists and transit are mixed.

INTERSECTIONS

Transit, vehicular turning movements, and bicycle movements should be explored at the intersections.

GOALS


This concept does not necessarily excel at any one goal. Though all modes are accommodated in this design alternative, the quality of each facility places the design on the lower-performing end for most of the evaluation criteria.




What transportation elements or improvements do you want to see on Grand Avenue?





