1. Teleconference Protocol and Roll Call/Determination of Quorum

At roll call, quorum was established with seven commissioners present ( $\mathbf{X}$ ). One commissioner arrived shortly after roll call ( $\mathbf{x}$ ).

- 2. Opportunity for reflection and comment on the passing of Chair Lester Meu
  - Commissioners expressed their deepest condolences upon the passing of the late MCPD Chair Lester Meu.
- 3. Open Forum

#### 4. Agenda Modification

- None
- Motion to accept by Commissioner Sperling, seconded by Commissioner Gregory, approved with all voting in favor.
- 5. Approval of January 2020 Minutes
  - Motion to approve by Commissioner Gregory, seconded by Commissioner Tevelson, approved with all voting in favor.
- 6. Nominations and voting for new Chair of MCPD
  - There were three rounds in the call for chair nominations:
    - Commissioner Thomas nominated Commissioner Tevelson and Commissioner Smith. Commissioner Smith declined and Commissioner Tevelson accepted.
    - 2. Commissioner Lynne nominated and declined. Commissioner Ryan nominated, and accepted.
    - 3. No nominations.
  - Commissioners discussed the duties and term for the interim chairperson, during which Commissioner Tevelson declined his nomination and declared support for Commissioner Ryan.
  - Commissioners voted, unanimously for Commissioner Ryan.
  - Commissioner Ryan was elected and assumed chairperson position.
  - Co Vice-Chairs Smith and Tevelson will retain their positions.

#### 7. Commissioner's Announcements

- Commissioner Thomas announced that he is no longer an employee of the Center for Independent Living, CIL.
- 8. How the City and State are Responding to Pandemic-Related Housing Challenges
  - Maryann Leshin, Deputy Director of Oakland's Housing and Community Development Department, discussed the various programs and actions being taken by HCD. She outlined the Department's three-pronged approach, "Produce, Preserve and Protect." Produce means development; preserve means creating immediate solutions; and Protect means eviction moratoriums, emergency loans, and other efforts. The Deputy Director responded

to the many questions and recommendations from the Commissioners.

- Deputy Director Leshin conveyed that the city works with external partners (CBOs) to develop and manage affordable housing. She shared that the city does 10% mobility and 5% communication accessibility units.
- See attached handouts from Housing Department.
- MCPD Commissioners recommended the following:
  - Use Universal Design guideline when building new accessible housing.
  - Increasing the number of mobility units above what is Oakland is currently doing; closer to 100 percent to meet the spirit & intent of the ADA and to factor in seniors population who might need accessible housing as they age.
- 9. Mobile Assistance Community Responders of Oakland ("MACRO") Project Testing
  - Anne Janks from the Coalition for Police Accountability and David Harris from the Urban Strategies Council gave an update on Oakland's "MACRO" Program, a pilot effort to dispatch counselors or EMTs, not policer officers, to respond to non-violent emergencies. Mr. Harris, Vice President of Urban Strategies Council, described the approach of the proposed new program. Ms. Janks talked about the training of the staff that will be involved in the program. The Commissioners highlighted the special needs of the disability community.

At 7:30, a motion made to extend the meeting by 20 minutes, was seconded and approved with all voting in favor.

#### 10. Staff Updates and Announcements

 Anh Nguyen, ADA Programs Division Manager, introduced Jennifer Stanley, on loan from the Bicycle and Pedestrian Program to assist with meeting administration until Hoang Banh's position can be filled. Commissioners voiced concerns about the ongoing staffing challenges.

#### 11. Future Agenda Items

- Commissioner Thomas expressed concern that the ADA Programs
   Division is in the Department of Transportation and requested that a
   discussion be agendized.
- Other future items will be discussed in coordination meetings with the Chair and Co Vice-Chairs.

#### 12. Adjournment

A motion to adjourn the meeting at 7:50pm was made by Commissioner Gregory, seconded by Commissioner Davenport, and approved with all voting in favor.






What vehicle design features would improve your access to bike share? (N=51)


What scooter design features would improve your access to e-scooters? (N=43)



#### How to increase access?


What vehicle design features would improve your access to carshare? (N=28)

#### **Recommendations from BORP**

- Increase outreach to specific groups and organize rides
- Corrective action on bathrooms
- Increase ADA parking
- Facilities to store bikes

# Reduce impacts to persons with disabilities traveling by other modes



- Improve bike share station placement
- Require E-scooters to have lock-to technology
- Establish designated scooter parking areas



- Better E-scooter user education and enforcement
- Require ride hail drivers to use pick-up/ drop-off areas

## Recommendations – Strategy 2

#### Modify Vehicle, Device, or Station Design



- Require or incentivize alternative vehicle designs
- Provide grants or subsidies for individuals to purchase their own adaptive vehicles
- Improve physical access to bike share stations
- Provide E-bikes in bike share program



- Invest in accessible vehicle design modifications
- For ride-hail, incentivize accessible vehicle owners to join platform

# Recommendations – Strategy 3

#### **Provide Alternative Service Models**



Extend adaptive bike share program



- For ride-hail, create a preferred driver certification program for drivers with disability-related trainings
- Create options for at home delivery of accessible vehicles
  - Guaranteed ride home for micro-mobility

#### **Expand User Information and Transaction Opportunities**



- Clearly define and disseminate information about accessible options
- Require web accessibility analysis score of 90% or more for shared mobility apps
- Integrate shared mobility into existing equity programs (i.e. discount transit passes)
- Conduct in-person outreach to introduce new mobility options

## Recommendations – Strategy 4

#### **Expand User Information and Transaction Opportunities**



- Set company targets for digital accessibility
- Provide clear information about accessible service options and how to request them
- Provide payment options that do not require credit/smart phone

### Recommendations – Strategy 5

#### Leverage new partnerships, planning and funding




- Incorporate new strategies for accessible shared mobility into planning efforts, such as East Oakland MAP
- Increase WAVs in car share/ ride hail through incentives to purchase
- Identify and integrate existing WAVs into shared mobility services
- Fund an "Access for All" program through revenue from shared mobility trips (i.e. 10c/ trip), exempting providers w accessible services. Use this to fund accessible services or infrastructure

### Changes to E-scooter program

#### **Starting in November 1, 2020**

- Scooters are required to have integrated locking mechanisms so they can lock to bike racks
- Adaptive vehicles must have three wheels, a seat and a basket
- All vehicles must have a minimum wheel size of 9 inches
- Request: A motion to support these changes
