7. Oakland Lesbian, Gay, Bisexual, Transgender, Queer (LGBTQ)

Community Center; *Joe Hawkins, Co-Founder, Executive Director* Joe Hawkins gave an overview of the new LGBTQ Community Center and the Services it provides. The Center is 6 months old, serves over 2000 people, includes 40 groups and is run solely by 600 volunteers. Mr. Hawkins, expressed concern for Senior LGBTQ people living in Oakland. They are the most marginalized and neglected. Many are currently in crisis mode. These Seniors tend not to have as much support as younger LGBTQ. Many lost their friends during the AIDs epidemic and are now alone. Mr. Hawkins is asking the Commission on Aging for their support of the Center. He would like the Commissioners to visit the Center and speak with the members. To learn more about advocacy for the LGBQT community, visit SAGEUSA.org.

8. Family of Choice Homecare, LLC.; Kevin & Kenneth, Owners of Family of Choice Homecare

Kenneth Boozer gave an overview of the in-home care agency opened by him and his partner, Kevin Pete. The agency, Family of Choice, specializes in the needs of the LGBTQ Senior Community. Their focus is to have Seniors age in place with dignity. The facility is for those in the aging LGBTQ community who are not ready to leave their home but need support to live comfortably and safely. Some of the services offered include: homemaking, personal care, errands, transportation and meal preparation. Mr. Boozer wants to partner with the Commission to get the word out about Family of Choice.
