A. Call to Order/Recite AC-OCAP Promise

G. Green called the February 08, 2021 Administering Board Teleconference to order at 5:38 p.m. The AC-OCAP Promise was recited.

B. Roll Call/Determination of Quorum/Approval of Agenda

Roll call was performed by M. Francisco. A quorum was established 5:45 p.m. **MOTION:** To approve the February 08, 2021 Administering Board Agenda. **M/S/Carried:** M. Rivera / S. Johnson / Motion Carried Unanimously.

D. Presentation: Gregory Garrett, Community Development Block Grant (CDBG)/Coronavirus Aid, Relief, and Economic Security (CARES) Report

G. Garrett, City of Oakland Housing & Community Development Department Program Manager was welcomed by the AC-OCAP Administering Board. G. Garrett reported on the City's response to the challenges presented by the Coronavirus Disease (COVID-19). The City received funding for round one and round three of the CARES Act distribution, which provided subsidized housing and expanded economic opportunities to the Oakland community. The City received \$4.5 million in CDBG CARES funds in round one, and \$3.7 million in the third round of distributions, for a total of \$8.2 million. By means of City Council's and Housing and Urban Development's (HUD) approval, the distribution of these funds is as follows: 2.5 million set aside for rental and homeowners financial assistance program delivery and \$1 million for affordable housing operations and support. The City received a HUD grant for round three on February 3, 2021. Previously, the City launched a collaborative rolling Request For Qualifications (RFQ), with the City's Community Housing Division, an agency within the Human Services Department. Over \$3.3 million was invested in Oakland tenant and homeowner programs. Approximately, 1031 renters and 17 homeowners were assisted, many of whom were severely impacted by the COVID-19 pandemic and most at risk of losing their homes and becoming homeless. Program progress will be reported through the City's consolidated annual performance evaluation to HUD and City Council. G. Garrett concluded his report with a question-and-answer session.

Williams provided reported on their participation in the training conference, both noting Keynote Speaker Ibram Kendi, a leading antiracist scholar and author of "Stamped from The Beginning" as a highlight of the conference. G. 2021 Travel

National Community Action Partnership (NCAP) Annual Convention, Boston, MA, August 30 – September 3, 2021

The NCAP Annual Convention is the largest gathering of regional, state, and local Community Action Agencies in the United States, drawing more than 1,500 attendees each year. Travel at this time is tentative since the Convention may become a virtual event, contingent upon the COVID-19 pandemic. Updates on travel will be provided to Board Members as they become available.

2. 2021 Programming

A. AC-OCAP Update

E. Clemons discussed the three open contracts: CSBG 2020, CSBG 2021, and 2020 CARES. Staff D. Williams reported the 2020 Annual Outcomes: AC-OCAP completed 2020 with thirteen grantees and 2 internal partners. One grant was cancelled due to non-compliance. Each grantee provided a Modified Workplan describing their pivot in response to COVID-19/Shelter-In-Place. In the strategic area of Housing and Community Development, 656 individuals obtained emergency or transitional housing, and 122 obtained permanent housing. In the strategic area of Job Training and Placement, 363 individuals obtained job readiness/vocation training, and 128 obtained employment. 15,298 unduplicated callers were assisted, \$29.2 million was captured in Tax Returns from 18,425 filers, and \$8.5 million was captured from Earned Income Tax Credit (EITC). E. Clemons noted the outcomes shared are preliminary, as D. Williams continues to prepare the report for the state. An outcome matrix will be provided to the board once the report is finalized.

B. Ashland Cherryland Healthy Community Collaborative (ACHCC) General Meeting Presentation (01-14-21) Update

Working with Supervisor Nate Miley's office, CAP staff connected partner, Rubicon Programs, Inc. to the robust community development efforts of Alameda District 4. Rubicon will work to provide neighborhood-based employment opportunities in this most impoverished area of Alameda County. In order to expand collaboration in unincorporated Alameda County, E. Clemons presented at the ACHCC General Meeting.

C. 2020-2021 Earned Income Tax Credit (EITC) Campaign

Staff D. Raulston is once again the EITC Coordinator, with M. Francisco acting as Co-Coordinator. This year, the program has partnered with University of California Berkeley to provide 12 volunteer tax preparers that will work virtually through the <u>getyourrefund.org/oakland</u> platform. The new virtual platform is a pilot program offered in collaboration with United Way of California. The Young Child Tax Credit (YCTC) Postcard included in the Agenda Packet was created in partnership with First 5 and Oakland Housing Authority, and will aid in the promotion of the California Earned Income Tax Credit (CalEITC) and YCTC.
