#### A. Call to Order/Recite AC-OCAP Promise

Board Vice-Chair M. Rivera called the April 11, 2022, Administering Board Teleconference to order at 5:35 p.m. The AC-OCAP Promise was recited.

# F. Presentation: Patrice Berry, AssistHub

E. Clemons introduced Patrice Berry, who was welcomed by the AC-OCAP Board. On the teleconference screen, P. Berry displayed a PowerPoint Presentation titled *AssistHub - Find and Claim Public Assistance*. The presentation began by detailing the existing situation: \$60 billion in public assistance, such as food stamps, unemployment insurance, and college financial aid, goes unclaimed each year. P. Berry went on to propose raising awareness, simplifying procedures, and eradicating stigma as approaches to reducing the barriers that prevent individuals from obtaining the resources to which they are entitled. Project AssistHub streamlines the process of identifying, applying for, and maintaining public assistance. The AssistHub initiative's

priorities include enhancing data intelligence and automation through a beta web app, establishing strategies for specific groups and building partnerships. The presentation was followed by an answer and question session. **ACTION ITEM:** CAP staff to share AssistHub PowerPoint Presentation with Board Members and AC-OCAP Grantees.

# 2. AC-OCAP Programming

# A. Community Service Block Grant (CSBG)/Community Aid, Relief, and Economic Security (CARES) and Program Updates

CAP staff is working with CitySpan to accept online Request for Partnership (RFP) applications. The RFP for the next 3-year CSBG funding cycle will be released this fall. CARES funds continue to aid families directly and/or indirectly impacted by COVID-19. While the \$1.8 million CARES funding took eight months to completely operationalize, there is now just \$200,000 left to disperse through UpTogether (formerly Financial Independence Initiative (FII)). CARES funding was due to expire on May 31st, however AC-OCAP is in the process of securing an extension through August 31st.

# B. 2021 Annual Outcomes Report – Attachment G2B

Page 9 of the Outcomes Report was presented by E. Clemons. The \$608,500 CSBG investment resulted in a leveraged total of \$8,434,726. This investment translates to a community impact of 27 High School Diplomas Earned, 185 Jobs Obtained, 324 Employment Trainings Received, 603 Transitional Housing/Emergency Shelter Received, 131 Obtained/Maintained Permanent Housing. There were 10,468 tax returns filed in Alameda County which captured \$19,627,500 million in tax returns, \$3,745,631 million in EITC, and \$4,397,920 million in Child Tax Credit. Staff D. Williams brought attention to the 13 seniors over age 65 who transitioned from homelessness to having stable housing. E. Clemons advised Board Members to review the complete 2021 Outcomes Report, which showcases AC-OCAP and its partners accomplishments.

# C. 2022 Earned Income Tax Credit (EITC) Campaign

Drop-off services at the Downtown Oakland Senior Center, as well as remote tax preparation, began February 7, 2022 and will conclude on Tax Day, April 18<sup>th</sup>. To date, forty-three tax returns have been e-filed by the EITC program's volunteer IRS-certified tax preparers.

# RESOLUTION NO. 5-22

ADOPT A RESOLUTION DETERMINING THAT CONDUCTING IN-PERSON MEETINGS OF THE ALAMEDA COUNTY-OAKLAND COMMUNITY ACTION PARTNERSHIP (AC-OCAP) ADMINISTERING BOARD AND ITS COMMITTEES WOULD PRESENT IMMINENT RISKS TO ATTENDEES' HEALTH, AND ELECTING TO CONTINUE CONDUCTING MEETINGS USING TELECONFERENCING IN ACCORDANCE WITH CALIFORNIA GOVERNMENT CODE SECTION 54953(e), A PROVISION OF AB-361.

WHEREAS, on March 4, 2020, Governor Gavin Newsom declared a state of emergency related to COVID-19, pursuant to Government Code Section 8625, and such declaration has not been lifted or rescinded. *See <u>https://www.gov.ca.gov/wp-content/uploads/2020/03/3.4.20-</u>Coronavirus-SOE-Proclamation.pdf* 

WHEREAS, on March 9, 2020, the City Administrator in their capacity as the Director of the Emergency Operations Center (EOC), issued a proclamation of local emergency due to the spread of COVID-19 in Oakland, and on March 12, 2020, the City Council passed Resolution No. 88075 C.M.S. ratifying the proclamation of local emergency pursuant to Oakland Municipal Code (O.M.C.) section 8.50.050(C); and

WHEREAS, City Council Resolution No. 88075 remains in full force and effect to date; and

WHEREAS, the Centers for Disease Control (CDC) recommends physical distancing of at least six (6) feet whenever possible, avoiding crowds, and avoiding spaces that do not offer fresh air from the outdoors, particularly for people who are not fully vaccinated or who are at higher risk of getting very sick from COVID-19. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html</u>;* 

WHEREAS, the CDC recommends that people who live with unvaccinated people avoid activities that make physical distancing hard. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/</u>your-health/about-covid-19/caring-for-children/families.html;* 

WHEREAS, the CDC recommends that older adults limit in-person interactions as much as possible, particularly when indoors. *See <u>https://www.cdc.gov/aging/covid19/covid19-older-adults.html</u>;* 

WHEREAS, the CDC, the California Department of Public Health, and the Alameda County Public Health Department all recommend that people experiencing COVID-19 symptoms stay home. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/if-you-are-sick/steps-when-sick.html</u>;* 

WHEREAS, persons without symptoms may be able to spread the COVID-19 virus. *See* https://www.cdc.gov/coronavirus/2019-ncov/prevent-getting-sick/prevention.html;

WHEREAS, fully vaccinated persons who become infected with the COVID-19 Delta variant can spread the virus to others. *See <u>https://www.cdc.gov/coronavirus/2019-ncov/vaccines/fully-vaccinated.html</u>;* 

WHEREAS, the City's public-meeting facilities are indoor facilities that do not designed to ensure circulation of fresh / outdoor air, particularly during periods of cold and/or rainy weather, and were not designed to ensure that attendees can remain six (6) feet apart; now therefore be it:

WHEREAS, holding in-person meetings would encourage community members to come to City facilities to participate in local government, and some of them would be at high risk of getting very sick from COVID-19 and/or would live with someone who is at high risk; and

WHEREAS, in-person meetings would tempt community members who are experiencing COVID-19 symptoms to leave their homes in order to come to City facilities and participate in local government; and

WHEREAS, attendees would use ride-share services and/or public transit to travel to inperson meetings, thereby putting them in close and prolonged contact with additional people outside of their households; and

WHEREAS, on April 11, 2022 the AC-OCAP Administering Board adopted a resolution determining that conducting in-person meetings would present imminent risks to attendees' health, and electing to continue conducting meetings using teleconferencing in accordance with California Government Code Section 54953(e), a provision of AB-361; now therefore be it:

**RESOLVED:** that the AC-OCAP Administering Board finds and determines that the foregoing recitals are true and correct and hereby adopts and incorporates them into this Resolution; and be it

**FURTHER RESOLVED:** that, based on these determinations and consistent with federal, state and local health guidance, the AC-OCAP Administering Board determines that conducting in-person meetings would pose imminent risks to the health of attendees; and be it

**FURTHER RESOLVED:** that the AC-OCAP Administering Board firmly believes that the community's health and safety seriously and the community's right to participate in local government, are both critically important, and is committed to balancing the two by continuing to use teleconferencing to conduct public meetings, in accordance with California Government Code Section 54953(e), a provision of AB-361; and be it

**FURTHER RESOLVED:** that the AC-OCAP Administering Board will renew these (or similar) findings at least every thirty (30) days in accordance with California Government Code section 54953(e) until the state of emergency related to COVID-19 has been lifted, or the AC-OCAP Administering Board finds that in-person meetings no longer pose imminent risks to the health of attendees, whichever is occurs first.

# BOARD OFFICER ELECTION POLICIES AND PROCEDURES

#### POLICY

The officers of the Community Action Partnership Administering board shall be Chair, Vice chair, Secretary and Treasurer. All officers must be members of and elected by the Board. Officers shall serve two-year terms, or until she or he resigns or becomes disqualified, or until a successor shall be named. The election of officers will be held every other year with those elected assuming office commencing January.

#### PROCEDURES

- 1. Per Article V of the bylaws, "election of each officer shall be at the regular monthly meeting of the Administering Board in December, bi-ennially" and must be agendized and noticed in advance.
- 2. At the noticed meeting, establish that a quorum is present. A quorum for CAP is the *majority* of the eighteen (18) member board or ten (10) members.
- 3. Reiterate Board bylaw that stipulates "No Proxy voting": Refer to Section VII.D.5 of the Bylaws that state that "proxy voting by any Administering Board Member shall be prohibited at meetings of the Administering Board and its Committees." For clarity's sake, proxy is defined as "the authority or written authorization to act for another."
- 4. Nominations can be made from the floor or via the nomination form.
- 5. Accept nominations for each Office: Chairperson, Vice Chairperson, Secretary and Treasurer. After each nomination, announce that the nomination for that office is "closed".
- 6. Either announce or write the nominees' names on the board. Here is an example:

- 7. Each candidate is allowed no more than 2 minutes to present their reason for seeking office.
- 8. A ballot for each office is distributed and then each Board member is asked to write in the name of the candidate of their choice and return the folded ballot to persons in charge of counting. Ballots are signed by board member. Ballots are not distributed until the slate of officers is established.
- 9. Tallying of votes should be done by staff and at least one board member who are not running for office. When the ballots have been counted, they are given to the presiding officer who announces the results. The results must be read in their entirety. For example, Donna Jones has been elected as the new chairperson by receiving a total of 10 votes.
- 10. This procedure is repeated until all officers have been elected. In the event of a tie, ballots are re-distributed and the vote is taken again.
- 11. In the case where a candidate is running unopposed, only a single vote is needed to elect them. This can be handled with a verbal motion to "elect Donna Jones by acclimation" **This motion must be seconded.**
- 12. A motion should be rendered that the ballots be kept for 30 days and then destroyed.
- 13. Return control of the meeting to the current Chairperson. The newly elected officers will assume their role at the next regularly scheduled meeting in January. At that time, the "Acting" chairperson will officially relinquish the gavel to the newly elected chairperson.

 motion would have to be ratified at the full Administering Board meeting.

#### OR

• If the Executive Committee decides to have representation from another agency, send letters to all the agencies on the Administrative Board Private Sector Recommendations list. Make sure list is current with the contact and address information. Once letters are received from any interested agencies, a discussion should be held at the Executive Committee meeting and if a motion occurs it would be ratified at the full Administering Board meeting.

If the board wishes to have other agency representation, any letters of interest received will be discussed, contacted, and interviewed. (see AC-OCAP Private Sector Board Selection Criteria and AC-OCAP By-laws – Article IV, Administering Board Membership).
