### 2. Review Final Minutes of January, 17 2022 PDF, Live on website were adopted without revisions.

#### 3. Lake Merritt Signage: update Jen Stern, OPW, Watershed and

Jen provided an update on the six new interpretive signs planned for Lake Merritt. The signs celebrate the nature, history, and stewardship of Lake Merritt. <u>See the designs here</u> and planned placement of the signs on <u>this map</u>. Response to <u>public comment on previous drafts is documented here</u>. Installation is anticipated for June.

# 4. Decomposed Granite (DG) Path Repair: update Craig Pon, OPW, Capital Improvements Project Coordinator, Facilities Services Division

Craig provided an update to the Decomposed Granite (DG) Path Repair <u>the pathway parallel to Lakeshore Ave</u>, <u>closest and adjacent to Lake Merritt at Brooklyn Avenue</u>. The Elephant Armor pilot will assess the material's performance through winter and over time. The material is also being tested for curb and driveway repair at the Oakland's Municipal Service Center and its corporation yard

Material costs are high, though hopefully the material will last longer, be easier to maintain, and easier to apply on other repair sites, especially since it can be applied on top of existing paths.

Coloring of material is also being tested.

Impact to runners is also a consideration.

The Department of Transportation and Park facilities are also considering the material in their plans.

The Coalition recommended that Craig move ahead with the path repair within available funding and application process.

The Coalition is interested in seeing a map of current and planned patches to paths.

# 5. DD Program Manager: report Mike Perlmutter, OPW, Watershed Program Specialist, Watershed and Stormwater Management Division, with Rebecca Darr, OPW, Project Delivery Division

Mike and Terri covering for Kristin. <u>March 21 Project Summary Report</u> and <u>Project Summary Report Table</u>

- Lake Merritt Improvement Project /Garden Center & Grande Ave entrance COMPLETE
- Snow Park/Lakeside Green Street Project Will be complete this spring once plant establishment period concludes.
- Harbor Master Trail Connection COMPLETE
- Lake Merritt Channel at 10th Street Rebecca Darr explained the history of the area and current fencing installed to protect Peralta Park wetlands along Merritt Channel from encroachment by homeless encampments. Rebecca recruited volunteers to help clean up the site. Replanting of marsh may be needed in fall of 2022.
- Union Point Park to 23rd Avenue Trail aka Miller Milling to Cemex E. 7th St to 23<sup>rd</sup>/29th Aves Contract extension due to delays. There was a short discussion about eminent domain that included the cost prohibitive aspects and historical position of the City.

- Waterfront Trail Connections at Park and High Street Bridges Seeking approval by the Coast Guard and County of Alameda County Public Works. Slated to head to design & permitting by late 2024. Construction completion is planned for late 2026.
- Waterfront Trail at Fruitvale (Fruitvale Bridge Gap Closure) Permits in review with City of Oakland Building Department and Bay Conservation and Development Commission (BCDC). Construction anticipated to begin spring 2024.
- Estuary Park -See in the January DD Coalition minutes the summary from project manager Chris Reed. Since then the Coalition formed an ad hoc committee, compiled feedback, and shared it with Chris. A draft of the Master Plan is expected at the end of March. California Environmental Quality Act (CEQA) Environmental Impact Report (EIR) Addendum preparation in progress. Phase 1 construction planned for fall 2023.
- Crowley Trail (formerly known as Brooklyn Basin) Interim Trail East Bay Regional Park project. EBRPD is
  working with the Port of Oakland to develop the trail, with the original DD funding set aside for use by
  EBRPD to build a permanent trail. Estimated construction in 2023. See page 3 in March 21 Waterfront
  Trails Update to City Council.
- Tide Gate Operations Guidance for the 7<sup>th</sup> Street Flood Control Facility Alameda County Flood Control and Water Conservation District reviewed a draft of the memo commissioned by City of Oakland and prepared by Wood Rogers. District and City staff met on September 1, 2021 to discuss next steps. The Draft Memo suggests that only marginal water quality benefits are predicted from modifying the existing 7<sup>th</sup> Street pump station operations; rather it's thought that additional large capital improvements would be required to achieve further water quality enhancement.

The Coalition participants at the meeting believe this analysis to be incomplete and based on a faulty memo. See <u>minutes from the November 15, 2021 Measure DD Community Coalition meeting</u>, which document some of these concerns. The Coalition formed an ad hoc committee that seeks to meet with the City about the document prepared by Wood Rogers and the City's next steps. Kristin Hathaway and Jeff Roubos who are managing the City participation in this issue are both expected to return from leave by mid-August, at which point the Coalition could revisit the issue with them.

The City is also seeking a contact at the Alameda County Flood Control District (District) to whom questions, concerns, and recommendations from the Coalition regarding the District's 7th Street Flood Control Station tide gate operations can be submitted.

- Lake Merritt Channel at 7<sup>th</sup> Street Pedestrian crosswalk COMPLETED, then damaged in car accident and being repaired.
- Courtland Creek Restoration 65% design plans under way as are permit applications. \$5.8 million needed has been raised via grants, most notably with the recent Caltrans awards: \$2.03 million Clean California grant and \$190,000 mitigation funds.
- Glen Echo Creek Restoration Early planning and initial data gathering by consultant. Funding sought and public engagement is being planned. The project will stabilize and repair steep and eroding creek banks and restore native riparian vegetation along ~1,000 feet of open creek channel and will enhance Oak Glen Park.
- Creek Restoration of Beaconsfield Branch Sausal Creek Early pre-design stage. Researching funding possibilities.

 Watershed Acquisition - City is pursuing acquisitions across Oakland, including at Arroyo Viejo Creek, Sausal Creek, near Claremont Canyon Regional Park, and Temescal Creek. Staff is engaging with many stakeholders including the Segorea Te Land Trust and East Bay Regional Park District. Staff is coordinating with City of Oakland Real Estate on conservation easements of certain City parcels. Staff is coordinating with various property owners on donation and/or sale of property and conservation easements.

### 6. Lake Merritt Channel Wish List: update Mike Perlmutter

Mike gave an overview of the Capital Improvement Project process for prioritizing City projects every two years. He addressed the question from the Coalition how to elevate Measure DD request confirmation. Terri will confer with the Project and Grants Management Division for more information about the process and how Measure DD funds are differentiated from non-DD projects. Staff will report back at next meeting.
