A. Roll Call and Determination of Quorum

Present: Martin, Corder, Mercado, Chase, Tucker, Turner, Floyd-Johnson, Long, Minor

Absent: Goldsberry

B. Open Forum / Public Comment

Public speakers spoke regarding incentivizing dispensaries to hire locally, concerns around requiring cannabis operators to participate in community meetings, restrictions on delivery impacting people getting cannabis delivered to their place of work.

Members then inquired about the equity tax rebate program. Member Floyd-Johnson made a motion requesting the following information: (1) What is involved in getting a tax rebate? (2) How is the program marketed? (3) What is the plan for outreach? (4) Ask businesses why they have not yet applied? Chair Martin seconded the motion and it passed by consensus.

C. Review of the Pending List and Additions to Next Month's Agenda

Member Floyd-Johnson made a motion for the equity subcommittee to place a proposed agenda for the retreat on the CRCs November meeting agenda. Member Tucker seconded the motion and it passed by consensus.

Chair Martin made a motion to add revisiting the cannabis business tax rate to the pending list. Member Floyd-Johnson seconded the motion and it passed by consensus.

D. Approval of the Draft Minutes from the Special CRC meeting on August 13, 2020 and CRC Meeting on September 8, 2020.

Passed with no objections.

- E. Reports for Discussion and Possible Action
 - 1. Annual Report from Revenue Management Bureau

Public speaker stated that report shows cannabis industry is struggling and taxes should be lowered further.

Chair Martin asked Revenue staff if they would oppose reducing the City's cannabis tax rate; Interim Finance Director Margaret O'Brien replied that they are not the policymakers and that it is best to ask questions and make proposal in advance of the City's budget cycle. In light of the change in tax rates between 2019 and 2020, Interim Finance Director encouraged the CRC to compare apples to apples and examine the total gross receipts as opposed to taxes collected in 2019 and 2020.

Chair Martin then requested that staff calculate what the tax revenue would have been in 2020 if the tax rate had not changed.

Vice-Chair Long asked what the projected tax revenue is from the cannabis tax revenue next year. Revenue staff replied that there is just an overall business tax projection consisting of 22 separate categories.

2. Revisiting Cannabis Business Tax Rate

Public speaker encouraged immediate tax reductions and to make them retroactive. Chair Martin emphasized that this item needs to be thought through seriously, policies should not come up on the fly, and to move on from the item.

Member Minor provided background on the different proposals. Public speakers emphasized the need to continue cannabis operators access to properties and to explore expanding cannabis uses in commercial zones. Public speakers also encouraged keeping equity permits with equity businesses.

Members encouraged more outreach on these proposals. Member Minor identified items 3(a)(1) and 3(b)(2-4) as time sensitive. Member Floyd-Johnson then moved to accept staff's recommendations on items 3(a)(1) and 3(b)(2-4) and to continue the other items to next month's agenda including any updates from staff consistent with the feedback received. Vice-Chair Long seconded the motion and it passed by consensus.

ITEM C (1) Draft Agenda for CRC Retreat

At the September 3, 2020 meeting Chair Martin made a motion to schedule a retreat to build cohesion and introduce all new members of the CRC. At the October 2, 2020 CRC meeting Member Floyd-Johnson made a motion for the equity subcommittee to place a proposed agenda for the CRC retreat on the November CRC agenda. Member Tucker seconded the motion and it passed by consensus.

Attached please find a draft agenda for the CRC retreat/planning session for review and consideration.

ITEM C (2) Potential Amendments to Cannabis Ordinances

At the October 2, 2020 CRC meeting staff presented potential amendments to the City's cannabis ordinances, Oakland Municipal Code (OMC) 5.80 and 5.81; the CRC accepted half of the recommended items and moved to continue the remaining proposals, including any updates from staff consistent with feedback received, to the November CRC meeting.

One of the October proposals included limiting the delivery of cannabis in Oakland. After the October 2nd CRC meeting, staff solicited additional feedback from cannabis operators on potential limitations on the delivery of cannabis in Oakland and the creation of an onsite consumption permit for delivery operators. While operators expressed some support for the creation of an onsite consumption permit for delivery operators, operators raised concerns around the limiting of delivery locations reducing access to cannabis. Based on these concerns and the impracticality of permitting onsite consumption sites during COVID-19, staff does not recommend moving forward on these proposals right now.

On the other hand, below is a summary of ordinance amendments staff recommends considering and staff looks forward to feedback from the CRC and the public.

With respect to Proposed Amendments to Overall Cannabis Program, staff recommends the following:

- 1. Prohibit New Cannabis Permit Applications in HBX (Housing-Business Mix) Zones and New Cultivation and Volatile Manufacturing Within 300 Feet of a Residential Zone
- 2. Allow Non-Volatile Manufacturing in Areas Where Custom-Manufacturing Industrial Activities are Conditionally Permitted Provided the Non-Volatile Manufacturing Applicant Undergo the Same Conditional Use Permit Process as a Custom-Manufacturing Industrial Use and There Is a 300 Foot Buffer Between Cannabis Uses
- 3. Allow Delivery-Only Dispensaries in CN Neighborhood Center Commercial Zones and D-BV Broadway Valdez Zones Provided the Delivery-Only Dispensary Does Not Situate on the Ground Floor.
- 4. Remove Discretionary Language in OMC 5.80.020(D)(1) re Location of Dispensaries

First, staff recommends prohibiting new cannabis operations in HBX zones to avoid conflicts with residential uses, as HBX allows industrial activities and residential uses right next to each other, which has proven incompatible from security, parking and other perspectives. Similarly, staff recommends limiting new cultivation and volatile manufacturing, potentially the most impactful uses, from within 300 feet of a residential zone. Attached please find maps of HBX zones and the proposed buffer from residential zones.

In response to concerns about limiting areas where cannabis operators can locate, staff's second and third recommendations include potential expansions of cannabis uses in commercial zones. The second recommendation would allow cannabis non-volatile manufacturing operators to undergo a Conditional Use Permit (CUP) process in the same areas where non-cannabis custom manufacturers undergo a CUP process, albeit with a 300 foot buffer between cannabis uses to mitigate any displacement of non-cannabis manufacturing by cannabis manufacturers. This buffer is proposed in response to concerns of cannabis operators being able to afford higher rent than non-cannabis operators. The third recommendation would allow delivery-only dispensaries to expand into every commercial zone, provided they do not situate on the ground floor, which is intended to support pedestrian-oriented uses that are open to the public, unlike delivery-only dispensaries that are not open to the public.

Last, staff recommends removing old discretionary language in OMC 5.80.020(D)(1) that provides an ambiguous standard for where dispensaries may locate; in the 2017 equity analysis staff identified avoiding as much subjective language as possible to minimize governmental discretion and the possibility of disparate outcomes. Staff then deleted similar language from OMC 5.81 but unintentionally left this old discretionary language in OMC 5.80 and now recommends its deletion. The language at issue is pasted below for reference:

Unless the City Administrator in his/her discretion determines that the location will not impact the peace, order and welfare of the public evidence that the proposed location of such dispensary is not within six hundred (600) feet of a public or private school providing instruction in kindergarten or grades 1 to 12, inclusive (but not including any private school in which education is primarily conducted in private homes), another dispensary or youth center, unless the school or youth center moved into the area after the dispensary was issued a permit under this Chapter.

With respect to Proposed Amendments to the Equity Program, staff recommends the following:

1. Authorize Equity Businesses to Transfer Permits After Three Years to Non-Equity Businesses

The CRC adopted this recommendation in December 2019 after multiple discussion in 2019 after staff asked for input on whether and how to allow an equity business to transfer its permit to a general applicant business. The current language around transferring business permit resides in OMC 5.02.20, pasted below for reference:

No permit in this Chapter required shall be transferable, nor apply to any premises other than those originally specified as the location of the thing permitted, except upon written permission of the City Administrator, or other official originally granting such permit, granted upon written application by the transferor, made in the same manner as may be required in the instance of the original application for such permit.

Staff has interpreted this language as allowing general applicants to transfer their permits to general or equity businesses that comply with permitting requirements, but prohibit equity applicants from transferring their permits to general applicants, because the equity applicants' status as an equity applicant was a prerequisite to them obtaining their permit in the first instance. While this avoids the flipping of permits from equity to general applicants and undermining the intent of the equity program of providing business ownership opportunities to equity applicants, it also permanently restricts equity businesses from receiving the financial benefits of selling more than fifty percent of their business to general applicants. After months of discussion in 2019, the CRC ultimately recommended allowing equity businesses to transfer their permits after three years, the same period as incubation, to provide equity applicants with the choice of keeping or transferring their business at that point.

In light of turnover of CRC members and the fact that staff has not yet presented this recommendation to the City Council, staff is presenting this issue again for the CRC's consideration.

ITEM C (3) Supplemental Report from Revenue Management Bureau

At the October 2, 2020 CRC meeting members requested additional information from the Revenue Management Bureau (RMB) regarding the total gross receipts in 2019 versus 2020 and the equity tax rebate program. Attached please find a supplemental report from the RMB.


Figure 5: Withdrawn Applications

ITEM F (2) Update on BCC and Go-Biz Grant Implementation

In the summer of 2020, the Special Activity Permits Division launched a BCC and Go-Biz funded grant program for equity operators for all eligible expenses that is administered along with the no-interest loan program by 4Front Partners, dba Elevate Impact. At the recommendation of the CRC, staff and Elevate Impact have held monthly meetings with equity operators the Tuesday after the CRC meeting to provide any updates regarding the program and maintain an ongoing feedback loop. Every week staff and Elevate Impact monitor the programs and analyze what adjustments are needed to effectively disburse funds. Then in September staff launched two shared-use manufacturing facilities funded by the BCC grant. The two teams managing the kitchens have selected 15 manufacturers to use the sites and are now working to get these operators permitted and operating in the coming months. Next, in late October staff launched a workforce development grant program providing equity operators with grants of up to \$50,000 to recruit, train, or retain equity employees. More information is available here: https://www.oaklandca.gov/services/workforce-development-grant-program

Finally, staff intends on releasing a Request for Proposals (RFP) for the approximately \$2million that will be available to equity operators to purchase property(ies) that support multiple equity operators. Staff anticipates releasing an RFP after the City Council considers converting these funds into forgivable loans at the November 10th City Council meeting.






Proposed Buffers for Cannabis Cultivation & Volatile Manufacturing From Residential Zones

INFORMATION

At the October 1, 2020 Cannabis Regulatory Commission ("CRC") Meeting, the CRC requested that the Revenue Management Bureau provide follow-up answers to questions and recommendations related to the tax rates and the tax rebate program.

Accordingly, below are questions(Q), recommendations (R), and answers(A).

Tax Rates:

- Q. What were the combined total gross receipts from all cannabis businesses for 2019 and 2020 tax years?
- A. 2019: \$165,351 million from 195 businesses 2020: \$167,494 million from 252 businesses
- Q. What would be the total amount of revenue if the tax rates for 2019 were maintained for 2020?
- A. The City would have collected approximately \$15.51 million in Revenues with the old tax rates, as opposed to \$8.89 million that is owed under the new tax rates for 2020.

Tax Rebate Program:

Q. What is involved in getting a tax rebate?

A. Submit the application and supporting documentation. The information and application, including required documentation, are available at https://www.oaklandca.gov/services/request-a-cannabis-tax-refund.

Q. How is the program marketed?

A. Detailed information regarding the 2020 Cannabis Busines Tax Program was included in the tax renewal notice sent to each business on January 3, 2020. The Special Activity Permits Division sent out an email to its cannabis businesses in October 2020 reminding operators about the program and has updated its website to include information on the Equity Tax Rebate Program.

Q. What is the plan for outreach?

A. Detailed information will once again be included in the upcoming 2021 tax renewal notice to be sent out to each business in early 2021. Additionally, the Special Activity Permits Division will continue to remind cannabis operators about the Equity Tax Rebate Program.

R. Ask businesses why they have not yet applied.

A. The Special Activity Permits Division will send a survey to cannabis operators to understand why they have not yet applied in the first Quarter of 2021 if not sooner.

Q. How many rebate conditions are there?

A. The 2020 Cannabis Tax Rebate Program has nine rebate conditions. Six out of nine rebate conditions have the qualifying period of one year to mature, meaning cannabis businesses must meet the required conditions for an entire year (2020) in order to qualify.
