Continued from page 3 Environmental Determination:	The Draft EIR for the Downtown Oakland Specific Plan was published (SCH No. 2019012008) on August 30, 2019. The 45-day public review period will be extended from August 30, 2019 to October 22, 2019 for a total of 53 days. The Draft EIR will appear before the Planning Commission on October 2, 2019 for public comment.
Historic Status:	52 Landmarks, 21 Areas of Primary Importance (API); 27 Areas of Secondary Importance (ASI)
City Council District:	2 and 3
Status:	The Draft Plan was released on August 30, 2019, and was presented before the Planning Commission on September 4, 2019 for initial comments. The Draft EIR was published on August 30, 2019, and is subject to a 45-day public review and comment period, which has been extended to 53 days (Aug. 30 to Oct. 22), and a public hearing before the Planning Commission on October 2, 2019. The Draft Plan will continue to be subject to public review and comment beyond October 22, 2019 to allow for public review of the upcoming zoning incentive study.

**Vince Sugrue**, Landmarks Preservation Advisory Board member gave a summary of the motion given at a previous Landmarks Preservation Advisory Board meeting. The summary of the motion is stated as follows:

To delete from the Downtown Specific Plan, action item 54, bullet #3 that explores allowing additional height on parcels adjacent to historic properties that rehabilitate the adjacent historic property.

To delete from the Downtown Specific Plan, action item 74 which updates the city's demolition findings to allow development near the periphery of fragmented APIs and ASIs. Reclassify opportunity sites into distinct categories to explain their intensions. Don't include historic properties and opportunity sites. Incorporate the items listed into the DOSP DEIR for mitigation measures, cult A-1 through cult A-F in the action items in the Specific Plan as part of the Downtown Oakland Specific Plan statement about establishing an iconic downtown. Add new design review criteria that includes massing and building setbacks as well as standards for building tops.

As a follow up to the Landmarks Advisory Board's previous comments on reducing the baseline intensity and density throughout the plan area. The intensity density should be significantly reduced in historic districts in the DOSP intensity density map and don't wait for the establishment zoning regulations.

Recommendation: Staff provide clarification as to whether the increased height allowance in the waterfront warehouse district was intentional or not. If it's a mistake, please correct it in the Specific Plan.
