#### A. Call to Order/Recite AC-OCAP Promise

G. Green called the October 12, 2020 Administering Board Teleconference to order at 5:34 p.m. The AC-OCAP Promise was recited.

#### B. Roll Call/Determination of Quorum/Approval of Agenda

Roll call was performed by staff M. Francisco. A quorum was established. **MOTION:** To approve the October 12, 2020 Administering Board Agenda.

## C. Approval of Draft September 14, 2020 Administering Board Minutes – Attachment C1 MOTION: To approve the Draft September 14, 2020 Administering Board Minutes.

#### D. Presentation: Voter Campaign 2020 – Attachment D1

E. Clemons announced AC-OCAP's partnership with Alameda County Community Food Bank (ACCFB) to provide voter registration and education to the community. E. Clemons welcomed ACCFB's Government Relations Manager, Alexandra Boskovich to present Voter Campaign 2020 to board members, staff, and community members in attendance. A. Boskovich shared a PowerPoint Presentation "Get Out the Vote 2020!" on the teleconference screen. A. Boskovich provided a brief overview of ACCFB's work including the agency's breakdown of service recipients, the 2018-2022 Strategic Plan to Advance the Policy Fight Against Hunger, and Lessons Learned from Voter Engagement 2018 and Census 2020 Campaign. A. Boskovich then discussed the election 2020 campaign goals: (1) leverage trusted presence in the community to disseminate quality, multilingual information about voting for the people we serve (2) continue to develop messaging that clearly connects voting to fight against the root cause of hunger, racism and poverty (3) mobilize volunteers to make calls to encourage and assist people with voting. Get Out The Vote (GOTV) Partnership activities include GOTV bus shelter ads (Attachment D1), Accessible Voter Location map postcards, GOTV robo-calls to potential food bank clients, and traffic stopping GOTV t-shirts for food bank staff, distribution, partners, and volunteers. The website <a href="accf.org/vote">accf.org/vote</a> displayed on postcards and transit shelter ads provide information on how to ensure votes are counted, and to find opportunities to get involved. A. Boskovich concluded her Voter Campaign 2020 presentation with a question and answer session.

#### E. Community Action Partnership (CAP) Updates (E. Clemons)

#### 1. Board Update

- **A. Board Vacancies** -- Oakland District 1 and Alameda County Community E. Clemons and staff plan to meet with District 1 to discuss efforts to recruit a community representative. E. Clemons is scheduled to present to the Alameda County Board of Supervisors on October 26, 2020. One ask will be for assistance in recruiting a community representative for Alameda County. AC-OAP's Organizational Standards submitted to the California State Department in August include a plan to fill board vacancies by January 31, 2021.
- B. National Community Action Foundation (NCAF) Annual Conference Pre-Election Session: October 29-30, 2020| Post-Election Session: November 5 &16, 2020 | General Session: October 17-18, 2020 Board Members and staff are registered for NCAF's Unlimited Package, which provides access to all three sessions of the virtual conference. Board Members are to email staff M. Francisco if they have not received their NCAF registration confirmation.
- **C. Board Membership Terms Attachment E1C -** Board Membership Terms were shared on the Teleconference screen. E. Clemons discussed the ending terms of the elected councilmembers (Lynette McElhaney, Noel Gallo, Larry Reid, and Supervisor Nate Miley) of the Administering Board and the election for new Board Officers to take place at the December 14, 2020 Administering Board Teleconference.

#### 2. 2020 Programming

- **A. Census 2020 Update** The Alameda County Self-Response Rate as of October 08, 2020 was shared on the Teleconference screen. E. Clemons discussed Alameda's 75.5% Self-Response rate from households via online, by mail, or by phone. The Census count completion date continues to shift between October 5, 2020 and October 31, 2020. At the onset of the COVID-19 pandemic, the Census Bureau extended the count completion date to April 2021. The extension date, however, conflicts with the federal law requiring the Census Bureau to send population totals to the president by December 31 of every census year. Currently, the completion deadline decision is in litigation, and therefore messaging should not include a date, but instead encourage the community to not delay Be counted today!
- **B. 2020-2022 CSBG/CARES Act Funding Attachment E2B -** E. Clemons reported on the October 7, 2020 Executive Committee Meeting, where the CSBG/CARES funding was discussed in detail. The CSBG CARES Work Plan CSD 901 (**Attachment E2B**) was shared on the Teleconference screen. The Work Plan includes financial program enhancements and supports to address the sudden disruption due to Alameda County's Shelter in Place, program expansion to support food security, and a new program "AC-OCAP CARES Relief, Recover, Rebuild (R3)" to create new services to support AC-OCAP's existing Community Economic Opportunity (CEO) network.
- The Proposed Budget (**Attachment E2B**) was shared on the Teleconference screen. E. Clemons addressed the changes to the budget due to personnel costs. The total CARES allocation is \$1,893,460. Oakland's allocation is 60% of total budget, \$1,136,076; Alameda County share at 40% is \$757,384. The AC-OCAP 2020-2022 RFP programming supports 14 grantees and two internal grantees Housing and Economic Rights Advocates (HERA) and Eden I&R.
- **C. Mandatory Grantee Training Friday, October 23, 2020 via Zoom** The Mandatory Grantee Training will cover CSBG Contract Amendments, Reporting & Requirements, and the CARES contract. E. Clemons encouraged Board Members to join the zoom webinar to observe the Grantee Training.

**ACTION:** Staff M. Francisco to email Mandatory Grantee Training invites to Board Members.

**D. Presentation to Alameda County Board of Supervisors – Monday, October 26, 2020** - E. Clemons will present the AC-OCAP 2020 Update which includes new poverty data, 2020-2022 funded programs, 2020-2025 Strategic Plan One Sheet, and the GOTV Campaign 2020.

**ACTION:** Staff M. Francisco to email AC-OCAP 2020 Update to Alameda County Board of Supervisors invites to Board members.

**E. Strategic Planning - Attachment E2E -** E. Clemons unveiled the newest draft of the Strategic Plan One Sheet on the Teleconference screen. E. Clemons noted the addition of the National Community Action Partnership branding. Board Members were asked to help expound on the Values listed on the One Sheet – what does "Community-driven", "Equitable", "Collaborative", "Impactful", and "Results-driven" mean? Sample language will be presented, and feedback will be requested. The Strategic Planning Ad-hoc Committee was congratulated on the outcome of their hard work and for being intentional about the direction Community Action is headed in the next five years.



#### BOARD OFFICER ELECTION POLICIES AND PROCEDURES

#### <u>Policy</u>

The officers of the Community Action Partnership Administering board shall be Chair, Vice chair, Secretary and Treasurer. All officers must be members of and elected by the Board. Officers shall serve two-year terms, or until she or he resigns or becomes disqualified, or until a successor shall be named. The election of officers will be held every other year with those elected assuming office commencing January.

#### **PROCEDURES**

- 1. Per Article V of the bylaws, "election of each officer shall be at the regular monthly meeting of the Administering Board in December, bi-ennially" and must be agendized and noticed in advance.
- 2. At the noticed meeting, establish that a quorum is present. A quorum for CAP is the *majority* of the eighteen (18) member board or ten (10) members.
- 3. Reiterate Board bylaw that stipulates "No Proxy voting": Refer to Section VII.D.5 of the Bylaws that state that "proxy voting by any Administering Board Member shall be prohibited at meetings of the Administering Board and its Committees." For clarity's sake, proxy is defined as "the authority or written authorization to act for another."
- 4. Nominations can be made from the floor or via the nomination form.
- 5. Accept nominations for each Office: Chairperson, Vice Chairperson, Secretary and Treasurer. After each nomination, announce that the nomination for that office is "closed".
- 6. Either announce or write the nominees' names on the board. Here is an example:

For Chairperson: Donna Jones

- 7. Each candidate is allowed no more than 2 minutes to present their reason for seeking office.
- 8. A ballot for each office is distributed and then each Board member is asked to write in the name of the candidate of their choice and return the folded ballot to persons in charge of counting. Ballots are signed by board member. Ballots are not distributed until the slate of officers is established.
- 9. Tallying of votes should be done by staff and at least one board member who are not running for office. When the ballots have been counted, they are given to the presiding officer who announces the results. The results must be read in their entirety. For example, Donna Jones has been elected as the new chairperson by receiving a total of 10 votes.
- 10. This procedure is repeated until all officers have been elected. In the event of a tie, ballots are re-distributed and the vote is taken again.
- **11.** In the case where a candidate is running unopposed, only a single vote is needed to elect them. This can be handled with a verbal motion to "elect Donna Jones by acclimation" **This motion must be seconded.**
- 12. A motion should be rendered that the ballots be kept for 30 days and then destroyed.
- 13. Return control of the meeting to the current Chairperson. The newly elected officers will assume their role at the next regularly scheduled meeting in January. At that time, the "Acting" chairperson will officially relinquish the gavel to the newly elected chairperson.
