IMPORTANT NOTICE FROM THE CITY OF OAKLAND FIRE DEPARTMENT



*City of Oakland Ordinance 13720 Chapter 49

You are receiving this notice because your property is within the

Very High Fire Hazard Severity Zone and an annual defensible space inspection is required by the Oakland Municipal Code*.

Please read inside for important information on the upcoming vegetation inspection season.

Annual inspections will begin for all properties in June. Start preparing your property for fire safe conditions now. Do not delay!





Red Flag Day Information:

Red Flag declarations are made by the National Weather Service in response to critical weather and dry conditions that could lead to rapid or dramatic increases in wildfire activity. Weather patterns that could result in a Red Flag declaration include low humidity and strong winds as well as other specific conditions. (OMC 307.4.4 "Red-flag" and other high fire risk conditions. Open burning, including recreational fires and fires within portable outdoor fireplaces, shall not be permitted on "red-flag" or other days which pose a high fire risk as determined by the fire code official.)

Smoking, using gasoline powered equipment, or using any type of outside cooking device are also not allowed anywhere in the Very High Fire Severity Zone on designated red flag days.

Whether you've lived through past wildfires or are new to the area, it's crucial that all residents in high-risk zones are informed about their role in fire prevention. Creating and maintaining defensible space around our properties is essential for slowing the spread of wildfires.

Our Fire Prevention Bureau works tirelessly year-round to ensure our personnel are well-trained and equipped with the latest educational resources. Additionally, our firefighters undergo rigorous training to effectively respond to wildfire emergencies.

In the coming months, we will utilize every available channel to disseminate information about fire safety. Your partnership in spreading this critical message and reducing hazardous fuel loads in our hills is invaluable.

Defensible Space Requirements and Code Explanations

OMC 4907.4: Defensible Space minimum — Maintain 30 feet of defensible space by cutting tall weeds, grasses, hazardous vegetation, and removing all dead & dying vegetation.	CFC 505.1: Property address — Addresses must be visible for all emergency responders.
	OMC 4907.5.2: Roadside Clearance — Maintain at least 10 feet of
OMC 4907.5: Defensible Space maximum — Increase defensible space protection to 100 feet from all structures due to slope of land.	clearance along all roadsides, driveways, parking lots, and fire trails.
	Note: Maintenance of roadsides on public right-of-ways are the responsibilities of adjacent property owners per California Streets &
OMC 4907.5.4: Clippings & Mulch — Do not leave cut grasses and other vegetation more than 3 inches deep on property. Wood chips and mulch can't be left more than 12 inches deep on property.	Highway Code.
	CFC 507.5.5: Clearance above roads — All trees and vegetation need to be cut back at least 13 feet & 6 inches above all roadsides,
CFC 304.1.1: Waste & Storage on property — No combustible or flammable waste or storage is allowed anywhere on property. Even outside of required defensible space areas.	driveways, parking lots, and fire trails.
	CFC 507.5.5: Fire Hydrant clearance — Do not allow overgrown vegetation within 3 feet around any fire hydrant.



Defensible space from hazardous vegetation is the required 30 feet for flat properties or 100 feet on properties with a slope between all structures and the surrounding areas.

Defensible space is the first line of defense for your home and neighborhood against wildfire.

OMC 4912.8.3: Sources of Ignition — All items or devices that can be a source of fire shall be at least 30 feet away from any combustible	OMC 4907.5.1.3: Tree separation from ground — Limb up all trees within defensible space area at least 6 feet from ground.
material. This includes grills, BBQ's, fire pits, torches, and any other device which generates flame or heat. Even not in use.	OMC 4907.5.1.1: Tree clearance from roofs — Keep tree limbs and other growth at least 10 from rooflines and above structures.
CFC 304.1.2: — Keep roofs clear of dead & dying vegetation such as pine needles and fallen leaves.	OMC 4907.5.1.2: Clearance from chimneys — Keep all vegetation, including tree limbs, at least 10 feet from all chimneys and rooftop exhaust pipes. This includes chimneys or fireplaces "not in use".
