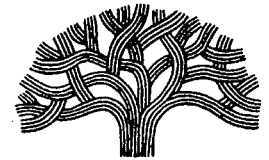

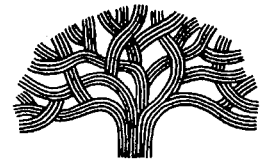

    - OUSD's All City Council Youth Vote Updates  
*Informational/Discussion Item: Commissioners receive updates from All City Council members*
      - Presenters: Roxie: Kids First Coalition Organizer & J. Ramos, Health and Wellness Director
      - Background on ACC: interested in shifting power in the district of 3,000 students; representatives are elected by schools, representing Tech, McClymonds, Castlemont, Fremont, Oakland High, Life

Academy, MetWest Academy, etc. Fifty to sixty students per school are active. Last year's campaign was about A-G requirements. Contrast to OYAC in that the body is elected by students all around the district while OYAC members are appointed by the Mayor and CC.

- Campaign: ACC is part of a coalition to expand voting rights to 16 and 17 years old to school board elections. Expand the Vote Coalition is working on a state-wide legislation - canvassing, pre-registering people to vote, and demonstrating youth want to be civically engaged. Last year, youth came together for the teacher strikes, fight school closures and budget cuts, and saved APISA and RJ and foster care managers. The solution is to gain control of conditions impacting us. Expand the Vote is a natural next step. ACC has met with CC members and gotten support. ACC centers youth voice on their mission and vision. Private schools students can support but directly impacts OUSD youth. This is also a nationwide movement. Currently education youth on what is voting.
- Would like to join in coalition with OYAC.
- Discussion:
  - I. Garcia - What are the specific requirements from OYAC? Is there an impact on attending meetings?
  - J. Ramos: Attend retreats and meet with organizations around Oakland – help with policy, and share common actions
  - Roxie: OYAC can endorse this campaign and influence decision makers; for instance, vocalize support when it is time to meet with Mayor. Assist with outreach.
  - M. Stern: What is timeline for the ballot?
  - Roxie: Thus far, CM Taylor, Thao, Bas, Gallo, and Kaplan have expressed support; Kaplan offered to co-author legislation. ACC will share so young people will provide feedback; the timeline is that the resolution will be passed [by voters] as an ordinance in Nov 2020.
  - MS: Can we provide feedback on ordinance?
  - Roxie: Yes.
  - Staff: Are there similar campaigns nearby?
  - J. Ramos: BUSD passed Y1. ACC is taking precedent from them. They will be voting for school directors. Fremont and Livermore have started to create this.
  - A. Long: Are charter school students involved?
  - J. Ramos: Yes, they can vote.

  - B. Harper: Berkeley passed this but I didn't know about that and maybe we can help.
  - M. Stern: How will the election be carried out?
  - Staff: Can help inform voters about it for the Nov 2020 election? How will we receive updates?
  - J. Ramos: Updates will be from B. Salop and J. Ramos, ACC liaisons. The civic engagement ad hoc committee can attend meetings anytime.
  - I. Garcia motioned to vote for support; M. Stern seconded. Unanimous vote to support.

- J. Espinoza (YLI): Fundamentally young people have been the ones who made the difference in history. What does youth voice mean to you? What does youth power mean to you?
    - Lee Lee: Youth have power and voices to change the city and things that impact us the most
    - Ivan: Youth assert themselves in positions of power where historically denied access; movement of people
    - Jessica: Youth as students making a change for the future
  - Video shown: Marin County, youth helped meet the needs in transit by going through voters
    - Small group report back of what stood out from the video:
      - Affordability
      - Video was interesting to watch
      - Spoke from the “I” perspective
      - Provoked emotion
      - Backed by statistics
  - J. Espinoza: over 20 community organizations and young people made this happen; County supervisors voted to put it on the ballot, placed tax to increase routes, increase service. Voters passed it.
    - What is social change? MS: shift in power dynamics.

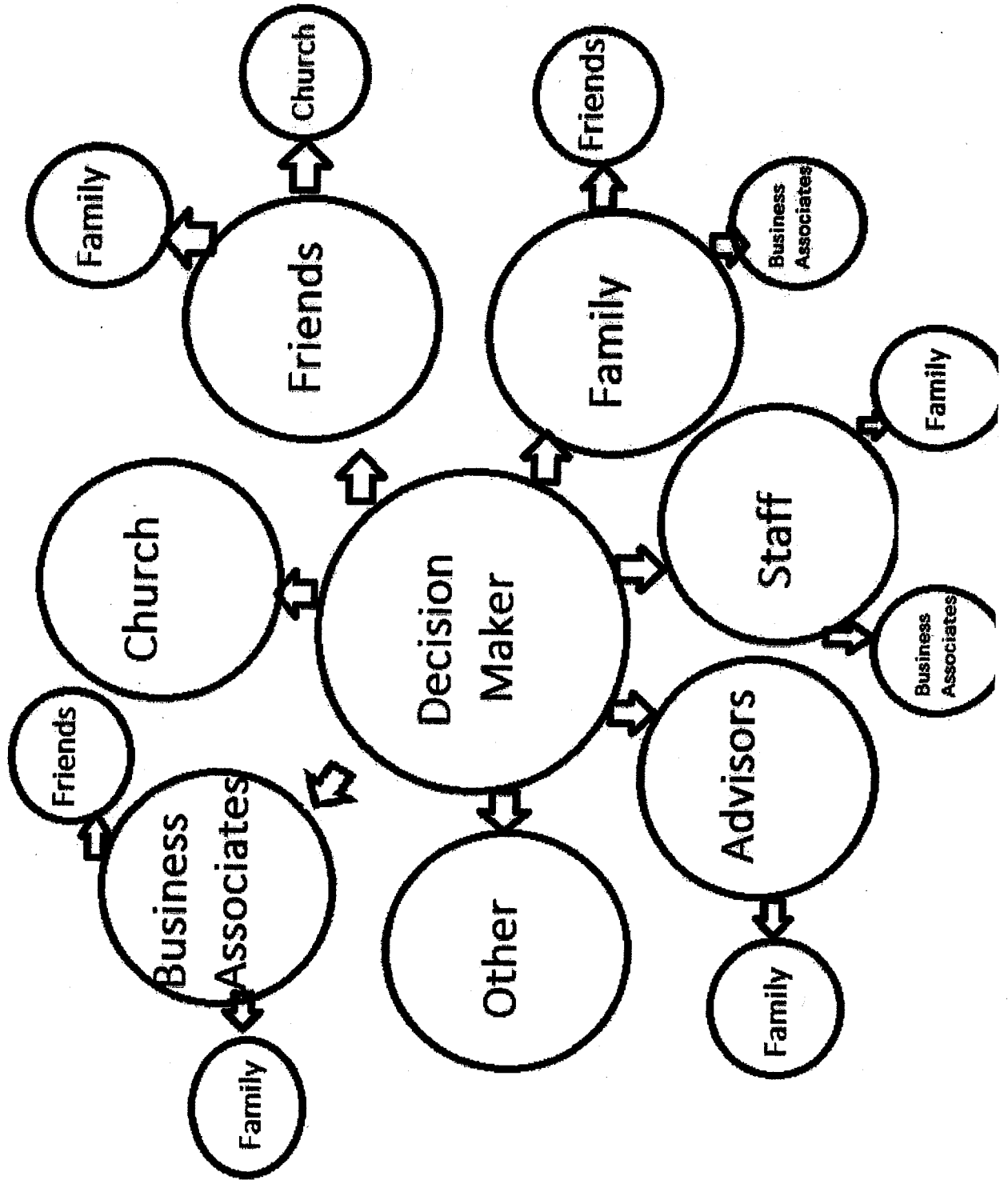
