There is a lack of access to playing fields in Oakland. Many of their practices and games get cancelled due to lack of rec space.

- VI. Item 1: Swearing In Ceremony Debrief

Commissioners reflected an overwhelmingly positive experience with the Mayor, and many shared as returning commissioners it felt comfortable, more like a conversation instead of just an interview. Commissioners found her answers to be thorough and insightful, and appreciated her passion showed through her answers. The OYC also appreciated she was seriously discussing collaborations between the mayor and the youth commission. Some questions that arose were related to homelessness, and the clearing of homeless encampments.

VII. Item 2: Understanding the National Elections - What's at Stake, Understanding the Electoral College and Rank Choice Voting

Commissioners discussed what are the key issues at the forefront of this election and why it is being called the most important presidential election in modern history. OYC Staff reviewed how the electoral college works, which swing states to watch in the Presidential election, the work of Seed the Vote in bringing people to work in battleground states, and what to expect and watch for in the coming days. Commissioner Olivia Richardson Feldman also reviewed how rank choice voting works and what some of the pros and cons, and previous controversies have been.
