I understand that if any of the above information is found to be untrue, I may forfeit my eligibility. I further understand that this form may be subject to an audit, verification check, and possible denial of the exemption. I hereby authorize the City of Oakland to verify all the information herein provided.

Directions for completing the Non-profit Organization exemption application

Submit completed application (one application per parcel) with supporting documentation via **email to vptsupport@sci-cg.com** or US mail to the address at the top of the first page.

- 1. To qualify for the exemption, you must be the owner of the property and hold 501 (c) designation. Please fill in your last, first and middle name, along with the parcel number and address. Your parcel number can be found on the top right corner of the VPT notice you received by mail. Approved exemptions will receive an exemption for 100% of the Vacant Property Tax levied on the parcel for which a Non-profit Organization exemption application is submitted. Eligible property owners must reapply each tax year.
- 2. The applicant must also include the name of the organization and must include a copy of the501(c)(3)

 Determination or Affirmation Letter from the IRS. An applicant can request a copy of an affirmation letter to have "proof" of your tax-exempt status.

Contact the IRS Customer Service for nonprofit organizations at 1-877-829-5500 and give them your nonprofit's name and Employer Identification Number. After an agent determines the organization's exempt status, ask them to issue an affirmation letter.

3. Owner and co-owners must complete, sign, date, and provide contact information on their application.

Submission of documents does not guarantee approval. Additional documentation may be requested.
