ITEM I.c. – APPROVAL OF MINUTES

Thursday, May 6, 2021

<u>Vice Chair Vera</u> called the meeting to order at 8:31 a.m.

<u>Vice Chair Vera</u> reviewed the process of how the meeting would proceed under Zoom. She welcomed Carol Asch as the new member of the board as Brian Salem's replacement.

Board Member Asch provided a brief background about herself.

Roll Call: Ahmed Ali Bob, Carol Asch, John Brauer, Jason Gumataotao, Polly Guy, Lee McMurtray, Gilbert Pete, and Lynn Vera were present. Derreck Johnson arrived at 8:38 am. **Excused:** Zeydi Gutierrez and Kalpana Oberoi. Omar Sabeh was absent.

Approval of Minutes

Chair Gutierrez stated the minutes from the February 4, 2021 Workforce Board Meeting and March 19, 2021 Special meeting were presented for approval.

Board Member Ali Bob moved, seconded by Board Member McMurtray to approve the minutes of the February 4, 2021 meeting as presented.

Board polled as follows: Ali Bob, Asch, Brauer, Gumataotao, Guy, Johnson, McMurtray, Pete, and Vera voted "aye."

Board Member McMurtray moved, seconded by Board Member Pete to approve the minutes of the March 19, 2021 special meeting as presented.

Board polled as follows: Ali Bob, Asch, Brauer, Gumataotao, Guy, Johnson, McMurtray, Pete, and Vera voted "aye."

BUSINESS Action Items

II a. 2021 Summer Youth Employment Program Allocations

<u>Vice Chair Vera</u> noted staff was seeking the board's approval on the following recommendations for the six program grants totaling \$847,000 for the OWDB 2021 Summer Youth Employment Program to the following agencies: Lao Family Community Development, Inc, Youth Employment Partnership, Inc, The Spanish Speaking Unity Council, Youth Uprising, East Bay Asian Youth Center, and Rising Sun Energy Center; authorize staff to finalize contracts; and authorize staff to allocate any additional summer youth funds raised for the 2021 Summer Youth Employment Program and distribute equally to these organizations without returning to the OWDB for approval.

Workforce Development Board Executive Director Dial explained how the City of Oakland had a long history of providing Summer Youth Employment. She noted it had been through several name changes. She noted the city was in the final year of a three-year RFP contract. She mentioned how the six agencies would 1) recruit and enroll youth in their program, 2) facilitate in-person job-readiness training; 3) recruit businesses and organizations to serve as work sites for youth as well as match youths with those worksites; 4) act as the employer-of-record/fiscal sponsor for youth whose wages are subsidized by the program; and 5) facilitate ongoing coaching and support. She noted during 2020 there was flexibility with the program due to the pandemic and advised there may again be no on-site worksites. She discussed prioritization of services for Black, Latinx, Native American, and Pacific Islander youth as well as the focus areas were East Oakland, Fruitvale and West Oakland. She mentioned the breakdown of funding as: \$400,000 from Measure HH Sugar-Sweetened Beverage Tax, \$200,000 from General Funds, and \$247,000 carry over. She reviewed the OWDB funding, OFCY recommended funding, OWDB and OFCY funding, and projected number of youths to be served.

Discussion held pertaining to what types of youth were involved in the programs.

Discussion held regarding how service providers were not in all zip codes, but the service providers promise to reach out to those areas.

Discussion held relating to how the program could reach out to the school districts and develop a partnership to help reach the youth.

No speakers on the item.

Board Member Brauer moved, seconded by Board Member Ali Bob to approve staff's request to approve the following six program grants totaling \$847,000 for the OWDB 2021 Summer Youth Employment Program to the following agencies: Lao Family Community Development, Inc, Youth Employment Partnership, Inc, The Spanish Speaking Unity Council, Youth Uprising, East Bay Asian Youth Center, and Rising Sun Energy Center; authorize staff to finalize contracts; and authorize staff to allocate any additional summer youth funds raised for the 2021 Summer Youth Employment Program and distribute equally to these organizations without returning to the OWDB for approval

Board polled as follows: Ali Bob, Asch, Brauer, Gumataotao, Guy, McMurtray, Pete, and Vera voted "aye." Johnson did not have audio.

II b. Contract Amendments

<u>Vice Chair Vera</u> explained that staff was requesting the OWDB accept and allocate the revised amount of \$960,000 Transforming Climate Communities (TCC) funds and authorize contracts to Cypress Mandela Training Center (CMTC) in the amount of \$434,300 and West Oakland Job Resource Center (WOJRC) in the amount of \$407,700 for a period of four years from May 1, 2021 to December 31, 2024 and also amend the Prison to Employment (P2E) grant award agreements with Lao Family Community Development (LAO) and Building Opportunities for Self Sufficiency (BOSS) to extend the period of performance through March 31, 2022.

Staff Member Lindsay noted at the last meeting they voted to allocate the funds for the first year, but staff was now asking the board to allocate the funding for the four-year allocation. She noted it would be consistent with TCC grant and legislation. She advised that the California Strategic Growth Council (SGC) requires the City to enter into agreements over a period of four years to provide training and job placement services for residents located in the TCC project area.

Workforce Development Board Executive Director Dial explained the request was to allow them to into a four-year contact and not have to come back annually. She noted she would like for a presentation to be done on the TCC so the Board was aware of what the projected included. She advised in 2019 the City was awarded \$642,966 through the P2E initiative funded by the State – the existing grant was due to expire June 2021, but staff was requesting an extension of the contract to allow the expenditure of the funds. She stated staff would be bringing an update on all special grants to a future meeting.

Staff Member Hudson stated due to COVID it was a slow start, but things were picking up. She noted the extension of the grant would be very helpful.

Mai Quach – Lao Family, stated they had already met their goals, but were still working on CalJOBS. She stated they had an in-house tracking and the information was provided to Staff Member Hudson. She provided a brief overview of what their program had done.

Discussion held concerning the number of individuals to be served.

Su Dung noted they had enrolled 39 but ended up helping 41. However only 16 obtained occupational certifications and 22 were placed in jobs.

Discussion held relating to performance and the total grant amount.

Discussion held that the age group for the P2E is for 18 and older.

Staff Member Lindsay noted the Cypress Mandela program would train 250 and place 114 people in jobs.

Board Member McMurtray moved, seconded by Board Member Pete to accept and allocate the revised amount of \$960,000 Transforming Climate Communities (TCC) funds and authorize contracts to Cypress Mandela Training Center (CMTC) in the amount of \$434,300 and West Oakland Job Resource Center (WOJRC) in the amount of \$407,700 for a period of four years from May 1, 2021 to December 31, 2024 and also amend the Prison to Employment (P2E) grant award agreements with Lao Family Community Development (LAO) and Building Opportunities for Self Sufficiency (BOSS) to extend the period of performance through March 31, 2022

IV. STAFF REPORTS

Workforce Development Board Executive Director Dial advised the Board the City of Oakland brought on Executive FUSE Fellows to work with staff on projects. She stated there would be a FUSE Fellow who would be brought on to assist with the project "Expanding Pathways into High Quality Jobs by Aligning Workforce Investments." She stated she would send something to the board regarding the FUSE fellow and project. She stated they were also looking to aligning with the local and regional plans and ask the board to weigh in what they would like to see. She stated she hopes to bring an item to the next Executive Committee meeting, a request for volunteers to participate on a board development ad hoc committee.

Staff Member Walker mentioned how the previous month she partnered with the Oakland Chamber of Commerce and invited local tech companies to talk about apprenticeships. She stated 45 people attended. She also stated the summer youth employment program received additional funds and there was now an official financial literacy program. She stated they were still looking for a bank that would work with the youth.

Staff Member Hudson welcomed the new board member. She advised she worked with the WIOA adult and dislocated worker programs. She provided a brief update on the COVID grants that were received: the National Dislocated Worker Grant was targeted for low wage workers with a focus on retail, hospitality, and tourism expires in March 2022, providers have focused on spending of other special grants with earlier deadlines, but they would be looking to shifting their focus to this grant once the other deadlines are closing; the Emergency Additional Assistance Grant focus was also retail, hospitality, tourism and low wage workers received an extension to June 2020 and a majority of funds have been spent with the expectation that all funds will be spent prior to the deadline; finally the COVID Underserved Impacted Individuals Grant with a focus towards English language learners and ELL Navigator programs, is expected to end by November 2020 and it was difficult to expend the funds due to the extensive eligibility requirements. She stated that a data driven report would be presented at a future meeting.

- 3. Amend and extend 2021 Summer Youth Employment Program grant award agreements for Rising Sun Center for Opportunity, East Bay Asian Youth Center and Youth Uprising to June 2022.

BACKGROUND

The Fiscal Year (FY) Workforce Development Board budget was approved at the June 18, 2021 Executive Committee meeting. City Council approved a General Fund allocation of \$1,510,000 at a Special Meeting, July 26, 2021. Council action directed grant agreements in the amount of \$1,010,000 to agencies outlined in Table 1 above. Additionally, the Council approved a \$500,000 General Fund allocation for programs with a focus on flatlands neighborhoods below 580 - Fruitvale, Chinatown, East Oakland, West Oakland and impacted communities including youth, homeless and formerly incarcerated. Staff proposed allocations are as follows:

Career Center Funding:

Increase the City Council directed funding by \$62,500 to \$237,500 for Lao Family Community Development and The Unity Council. These service providers also serve youth.

Youth Service Provider Funding:

Increase the City Council directed funding by \$25,000 to \$200,000 for Youth Employment Partnership and by \$125,000 to \$200,000 for Civicorps.

Training Provider Funding:

Fund West Oakland Job Resource Center at \$75,000.

Summer Youth Provider Funding:

Fund the East Bay Asian Youth Center and Youth UpRising at \$75,000.

Staff will submit a revised budget reflective of the amendments at its next meeting. Table 2 below reflects the amended FY 2021-22 Service provider allocations.
