# Item 2. Open Forum / Public Comment

This item was facilitated by Midori Tabata, a member of BPAC's Open Forum Committee.

• Commissioner Yee noted this past week a street festival on Broadway from 20<sup>th</sup> St to 22<sup>nd</sup> St that blocked the sidewalk on both sides of the street. This created some challenges for pedestrian access. OakDOT staff Jason Patton responded that it may have been authorized through the Police Department's special events permit process.

# Item 3. Approval of meeting minutes

# Item 4. Recent Bicyclist and Pedestrian Fatal Traffic Crashes

Vice Chair Schader led the commission in a discussion of recent fatal traffic crashes in Oakland involving bicyclists and pedestrians:

• On 8/27/21 before 5:10am, a 29-year-old male Alameda resident was struck and killed by a big rig truck in a hit-and-run on the 200 block of Market St.

# Item 5. Martin Luther King Jr (MLK) Library Bike Programming

Commissioner and Oakland Public Library staff RB led a discussion on bicyclist programming efforts happening at the MLK Library located at 6833 International Blvd. Anthony Propernick and Manuel Hernandez, staff with the Oakland Public Library, provided an overview of the library's bicycle services at the 81<sup>st</sup> St Ave Library, Martin Luther King Jr Library, and other locations in partnership with the Scraper Bike Team and EBALDC. Jason Cook, OakDOT staff, provided an update on capital improvements being made to support such programming. Modified shipping containers will be installed to create a workshop, storage, and space for programming. OakDOT is partnering with the Oakland Public Library on these improvements, funded primarily by the Transformative Climate Communities grant. OakDOT is helping with the design, construction, and additional funding to prepare the site for the new repurposed shipping containers. This item was introduced by Commissioner Lok. The presentation is attached to these minutes.

Summary of Discussion:

- Tom Holub noted that the existing container for the "The Shed" will be relocated to a nearby park and continue to offer community bike services. This relocation will also clear the space for the new facility to be constructed.
- Commissioners offered thanks to the Library staff and the Scraper Bike Team for providing valuable services in Deep East Oakland where there is a lack of bike shops.
- On behalf of Bike East Bay, Dave Campbell offered thanks to Library staff for their bike programming and partnerships.

# **Item 6. Flex Streets**

Greg Minor, from the City of Oakland's Economic & Workforce Development Department, provided an update on the city's Flex Streets program, Oakland's program for outdoor merchant activity including Café seating, parklets and street closures. This presentation provided details about the scope of the program evaluation currently underway including administrative review, fiscal analysis, and design standards. You can read more about the program at: <u>https://www.oaklandca.gov/resources/business-use-of-streets-and-sidewalks-initiative</u>. This item was introduced by Commissioner Yee. The presentation is attached to these minutes.

Summary of Discussion:

- The City should consider additional safety measures at Flex Streets installations, like the barricades that have been used at some street closure locations.
- The one parklet on International Blvd (at 46<sup>th</sup> Ave) was hit by a drunk driver. The parklet was not rebuilt. The restaurant moved its outdoor dining to its parking lot.
- The City's previous parklet program only replaced parking spaces with parklets. The Flex Streets program has replaced other curb uses including red curb, loading zones, and bike parking.
- The Flex Streets evaluation process should give additional attention to accessibility for people with disabilities, improving upon the ADA compliance guide that is already in place.
- Consider using the evaluation process to develop updated design guidelines.
- Based on the recommendations developed for City Council, the future program could involve a permitting fee that would help cover the City costs of the program. A fee-based program could include a waiver component to ensure the program is widely accessible to Oakland businesses.
- Staff is seeking to finalize recommendations for City Council by March 2022. The public is encouraged to submit comments in the next couple of months.
- Consider surveying businesses, especially asking businesses why they didn't participate. For example, on Telegraph Ave there are many installations in the Temescal but none in KONO. Notably, the roadway configuration is the same in both neighborhoods.
- Consider studying traffic speeds as part of the evaluation. For example, traffic on Telegraph Ave in the Temescal is now very slow.
- Parklets provide a personal security benefit by having more people on the street at night.
- Consider the impacts on other businesses of Flex Streets occupying loading zones and parking spaces.
- The Flex Streets program includes mobile food vendors both food trucks and push carts by waiving permit fees and eliminating the limits on the allowed number of mobile food vendors.
- Explore opportunities for mini-grants to support small businesses with few resources to take advantage of the program.

# Item 7. Committee Report Back

Committees of the BPAC provided brief updates to the Commission. A list of active committees was included in the agenda packet and at <u>https://www.oaklandca.gov/resources/bicyclist-and-pedestrian-advisory-commission-bpac-committees-and-liaisons</u>.

Summary of Discussion:

- 2022 Recruitment Committee: Midori Tabata reported that the committee members have been meeting weekly in anticipation of new commissioner applications being received by this Friday, 9/17, for the upcoming 2022 appointments to the BPAC. The committee consists of Commissioners Burnette, Mangrum, and Schader, and Midori Tabata.
- Bicyclist Pedestrian Police Relations Committee: Commissioner Mangrum noted the committee has scheduled December 4 for its next ride with the Oakland Police Department. The committee is also interested in developing a new mission statement and strategic plan for the Commission's input. Commissioner Mangrum is interested in starting 2022 with this updated mission and plan. Commissioner Mangrum also noted State legislation on the Governor's desk that would allow bicyclists to treat stop signs as yield signs (AB 122). Another bill would decriminalize jaywalking, allowing pedestrians to legally cross mid-block (AB 1238). Both bills would help reduce

opportunities for law enforcement to profile people of color while bicycling and walking. Commissioner Mangrum asked the commissioners to support these bills.

• Infrastructure Committee: Commissioner Yee noted the committee will meet next on Thursday, October 7, 3:30pm. They are considering items on access to Coliseum BART and the Martin Luther King Jr Shoreline, Measure DD-funded Bay Trail Projects, Slow Streets, the Rapid Response program, a project to implement Lead Pedestrian Interval (LPI) timing at eighty downtown traffic signals, and the sideshow prevention pilot program.

- General Plan Update (Commissioner Ralston): OakDOT staff noted this item could be coordinated with the recurring update from the Planning Department's Strategic Planning group.





Uakland's 2019 3-Year Paving Plan & has won the California Transportation Foundation Sustainable/Environmental Enhancement Project of the Year.

Until now, Oakland has only been able to prioritize a handful of major streets for repaying due to limited funds. But with Oakland's Infrastructure Bond (Messure KX) and guaranteed gas tax revenues (Senate Bill 1), the city can increase paying on neighborhood streets, while still keeping major roads in good condition.

Following policy direction from City Council, staff developed a plan that incorporates equity, street

O akland, California has long fought against gentrification, and for racial equity, but it has rapidly become one of the most gentrified areas of the country, with limited housing availability and a high cost of living. These changes have particularly impacted folks of color in the city, an issue that city leaders are working hard to combat.

One of the ways that the city is addressing these challenges is through the Department of Race and Equity, launched in 2016 to work with city departments "to create a city where our diversity is maintained, racial disparities have been eliminated and racial equity has been achieved." 




 Share of Local Streets in Poor Condition
 Share of Underserved







# **Interests & Experiences**

Please tell us how your qualifications and participation will relate to the requested board and/or commission's mission.

I'm born and raised in Ca (San Diego) and, now in my 30s, have experienced many of my peers, many born here in the Bay, struggle to raise their young families due to the untenable cost of housing. I'd bring the perspective of someone who has had been fortunate to be able to afford a home but who understands that my "barely making it" is hardly a reason the status quo should be persisted. I'm also a regular cyclist and public transit user. My wife is an essential worker who has had to ride the bus to work throughout 2020. Furthermore, I would bring a lens focused on promoting public health, equity, and policies that enact systemic and structural changes. I am a resident of Oakland's Highland Park neighborhood within City Council District 5, and I've lived in the city since 2013. During nonpandemic times, I'm a daily bike commuter and I reveled in exploring Oakland and its surroundings by bike and foot with my family. I recently became a father, and while I have greatly enjoyed taking my daughter on bike rides to explore different neighborhood parks, I have quickly realized how much further the City has to go in making streets safe and inclusive for all to use. I don't feel safe riding with my daughter in parts of the city that don't have adequate infrastructure, and this is often been in some of the City's most disinvested neighborhoods, including my own District 5. This experience has helped to impress upon me the importance and need not only for adequate and expansive biking and walking infrastructure, but to ensure it is equitably distributed throughout the city. I am exhilarated by the momentum for creating safer and more inclusive streets to address these issues, and have participated in community outreach events for numerous active transportation and planning projects in the city, such as the Telegraph bike lane improvements, West Oakland Specific Plan, and Howard Terminal Stadium Development. I have observed the critical role community voices play in advocating for and improving active transportation projects. Serving on the BPAC would provide an opportunity to draw on my personal experiences as an Oakland resident to formally shape these important biking and walking projects. In addition to my personal experience as an Oakland resident, my professional experiences demonstrate a strong alignment with duties and priorities of the BPAC. As my resume details, I bring a myriad of skills and diverse experiences working on public policy issues in various government settings. Currently, I coordinate San Francisco Department of Public Health's state and federal affairs work. I analyze legislative, regulatory, and financial health policies and their impact on the department and community. This role has included supporting the City's Vision Zero initiative through data analysis and policy advocacy (e.g. automated speed enforcement, etc.). Before joining the state and federal affairs team, I coordinated the departments' Health Impact Assessment program where I oversaw and conducted various health assessments of city programs, plans, and polices to inform and support decision-making at all levels of government. Through this role, I worked to incorporate a health and equity lens on policy issues ranging from housing safety, transportation access, land use planning, and climate change adaptation. As a commissioner on the BPAC, I'd be excited to apply both my professional and personal experiences to the many transformative bike and pedestrian related efforts underway in Oakland. I believe that for me to be successful in this work, bringing an equity lens is imperative to this work - data demonstrates that low-income communities of color have been historically disinvested in urban infrastructure projects and disproportionately impacted by pedestrian and bicycle safety issues. Systematic change is needed to combat the epidemic of rising traffic injuries and deaths that is endangering us all, but which is also having a disproportionate effect on people of color in low-income neighborhoods. I would be honored to help shape these important issues as a BPAC commissioner. I believe all Oakland neighborhoods can become safe and welcoming for walkers and cyclists no matter their background, be it by race, gender, ability, or income.

Dear Oakland Bicyclist & Pedestrian Advisory Commission Recruitment Committee: I am applying for a seat on the Oakland Bicyclist & Pedestrian Advisory Commission (BPAC). As a long-time Oakland resident in District 2 and as an advocate for sustainable and equitable mobility, I am very excited about this opportunity and can make important contributions. I have almost ten years of professional experience in bicycle and pedestrian planning, and I have a Master's in City Planning from UC Berkeley, where I focused on transportation and urban design. As a woman of color and a mother of a 2-year-old, street safety and comfort is my top priority. I recently bought an e-bike to take my son to preschool, and while biking is a really fun and sustainable way to get around with kids, on certain streets I have great concerns about safety - both traffic and personal safety, which limits where we can bike together. My immediate concern and interest focus on District 2, especially providing safer bicycle and pedestrian facilities in and around Chinatown and along the highway underpaths. Currently I live in Chinatown, and getting to the nearest bike lane is challenging because of speeding cars and double parking, and crossing streets is scary because of left-turning vehicles. I am also interested in the larger network throughout Oakland and adjacent cities, such as Berkeley, Emeryville, Alameda, and San Leandro. I know from both personal and professional experience that there is a great need to not only expand a safe regional network but also fill in the gaps in existing networks. We need to do both to ensure a safe, effective and equitable bicycle and pedestrian environment for Oakland residents. I will utilize my expertise and professional experience to contribute to making a more bikable and walkable environment in Oakland. As a Senior Planner in the San Francisco Planning Department, I have experience managing different types of transportation projects in urban planning. I lead an interagency street design body, called the Street Design Advisory Team (SDAT).
