The pedestrian suffered severe injuries and later passed on September 10<sup>th</sup>, 2023.
  - On Sunday, September 26th, 2023 at approximately 7:30-7:45 AM, a 72-year-old female pedestrian was killed by a driver in a hit-and-run collision along the 3600 block of Seminary Avenue, near the intersection with Outlook Avenue.
  - On Tuesday, September 26<sup>th</sup>, 2023 at approximately 9:34 PM, a female pedestrian was killed by a driver in a hit-and-run collision in the westbound direction in the 5400 block of International Boulevard.
  - On Friday, October 6th, 2023 at approximately 8:49 AM, a pedestrian was killed by a train while crossing the railroad tracks at the 900 block of 37th Avenue.

### Item 2. Open Forum / Public Comment

- Robert <u>Prinz</u> brought postcards to advertise for Bike East Bay's annual fundraiser event, Biketopia, at 1736 Franklin Street in Oakland on October 5<sup>th</sup> from 5:00 to 8:00 PM.
- On Monday, September 25<sup>th</sup>, OakDOT will have held a press conference to celebrate the first round
  of lower speed limits in Business Activity Districts and to unveil a new speed limit sign on Fruitvale
  Avenue at Farnham Street (between East 15<sup>th</sup> Street and International Boulevard). More

### Item 3. Approval of Meeting Minutes

### Item 4. Recent Bicyclist and Pedestrian Fatal Traffic Crashes

Commissioner Schader (<u>patricias.oakland@gmail.com</u>) led the commission in a discussion of recent fatal and other high-profile traffic crashes in Oakland involving bicyclists and pedestrians.

The list of recent crashes was included in the meeting's agenda packet.

### Summary of Discussion:

- George Spies shared more details about the pedestrian death at International Blvd. Commissioner
  Frank shared a language concern about the victim listed in this agenda item's description. He
  criticized the use of the word "laying" to describe the victim's behavior in the roadway, as
  described by witnesses and recorded in the police memo regarding the incident.
- On Wednesday, September 6<sup>th</sup>, from 5 PM to 7 PM, a vigil was held for the 4-year-old girl who died after she and her father were hit by an opening door from a parked car on Lakeshore Avenue at Hanover Street.

### **Item 5. Telegraph Avenue Paving Project**

Cathy DeLuca (<u>CDeluca@oaklandca.gov</u>), a Transportation Planner from OakDOT's Planning & Project Development team, introduced a paving project on Telegraph Avenue between 52nd Street and Woolsey Street. Staff recently kicked off the project and received Commissioner and public feedback on initial conceptual designs.

### Summary of Discussion:

- A two-way cycle track on one side of the street would create sightline issues for drivers turning at intersections.
- UC Berkeley students, as possible major bicyclist and transit users of this roadway, will be surveyed for this project.
- Pedestrian safety could be compromised should the design expect them to cross 4-6 lanes of vehicular traffic without a pedestrian safety refuge island.
- AC Transit has provided ridership data, but has not yet provided data on current bus speeds and projected transit travel time improvements with the installation of bus-only lanes.
- There is political risk in a street design that eliminates up to 75% of parking (e.g., motor vehicle parking on only one side of the street, down from both sides of the street).
- UC Berkeley's Mobility Coordinator should be contacted for outreach for this project.
- The installation of center turn lanes often provide the opportunity for illegal vehicle parking in the middle of the roadway.
- Caltrans should be consulted with regards to any interchange underpasses involved in this project, including the section underneath Highway 24.
- The City of Berkeley released <u>a high-level concept plan in October 2022</u> for the Telegraph Avenue Multimodal Corridor Project from Dwight Way to Woolsey Street (the City limit with Oakland).
- Chair Yee asked staff to learn from AC Transit their updated schedule for the Telegraph Avenue
  Rapid Corridors project. OakDOT staff heard back from AC Transit staff that "AC Transit is

embarking on a Telegraph Rapid project to consolidate bus stops and install signal communication and Transit Signal Priority on upper Telegraph (construction slated for June 2024)."

- One of the concept designs in this presentation includes 6.5-foot-wide bike lanes, representing the
  minimum width for a bicyclist to comfortably pass a slower rider or ride side-by-side with another
  cyclist.
- Queue jump lanes should be designed specifically for busses and to avoid their use as vehicle loading zones.
- RRFBs may not effectively increase pedestrian safety when the roadway is too wide.
- The final design should be context-sensitive to the land uses along the project corridor.
- Bicyclist turning movements onto adjoining bikeways should be considered for optimal bikeway connectivity.
- Other public agencies may have led recent outreach efforts, and too many community input events
  can lead to meeting fatigue from otherwise engaged members of the public who would like to
  provide input on public projects. It may be wise to space out community meeting events to avoid
  this fatigue and encourage public participation in the planning process.
- The existing separated bike lane on Telegraph Avenue may support commercial activity for pedestrians and bicyclists, and this support should be considered in the design for the commercial section of this project's extent.

### **Item 6. Seminary Avenue Paving Project**

Colin Piethe (<a href="mailto:CPiethe@oaklandca.gov">CPiethe@oaklandca.gov</a>) and Cathy DeLuca (<a href="mailto:CDeluca@oaklandca.gov">CDeluca@oaklandca.gov</a>), Transportation Planners from OakDOT's Planning & Project Development team, introduced a paving project on Seminary Avenue between Sunnymere <a href="mailto:Boulevard-Avenue">Boulevard-Avenue</a> and Foothill Boulevard. Staff received Commissioner and public feedback on initial conceptual designs, including a potential new bikeway between Sunnymere <a href="mailto:Boulevard-Avenue">Boulevard-Avenue</a> and MacArthur Boulevard.

### Summary of Discussion:

- Commissioner Ralston, while a City of Oakland Community and Economic Development (CEDA),
  Redevelopment Project Manager and Urban Economic Analyst in 2008, wrote the successfula
  thoughtful-proposal for a Caltrans Community-Based Transportation Planning Grant, to fund a
  feasibility study for what would become the Laurel Access to Mills, Maxwell Park and Seminary
  (LAMMPS) project. Alysha Nachtigall, a Mills College student in 2007, wrote a policy analysis on
  linking Mills College and its surrounding neighborhood to the Laurel commercial district and
  neighborhood.
- Commissioner Frank suggested installing chicanes to slow vehicles and suggested that relative speed between the vehicle and the bicyclist is more important than considering overall speed for each mode.
- Posts in the middle of the roadway are meant to discourage parking, though drivers can still drive over them (due to the need for Fire Department vehicles to drive over them for fire response access).
- Traffic calming should be installed near the Highway 24 off-ramps to provide a more dramatic interface between speeds on the highway and non-highway roadways.

- Lighting improvements will be included in the final design.
- OakDOT staff should explore funding options to ensure that the LAAMPS bike path along Mills College can be completed.
- Parking in front of multi-family housing units at the bottom of the hill on this section of Seminary Avenue is used more heavily than the parking lane towards the top of the hill.
- Commissioner Frank wondered whether materials other than asphalt or concrete are possible for Class I bike paths.
- Mills College denied usage of their right-of-wayproperty for construction of a Class I bike path.

Commissioner Frank led a short discussion on the BPAC's planned response to the Oakland Fire Department's recommendations to the City Council Public Safety Committee regarding Appendix D of the City of Oakland's Fire Code.

### Summary of Discussion:

- The Committee will meet virtually the first week of October.
- Recommendations from the Oakland Fire Department on Appendix D of the Fire Code may be presented to the City Council's Public Safety Committee at their meeting on October 24<sup>th</sup>, and the agenda for that meeting would be released by October 13<sup>th</sup>.
- OakDOT is working closely with the Fire Department to discuss the proposed changes to the Fire Code.









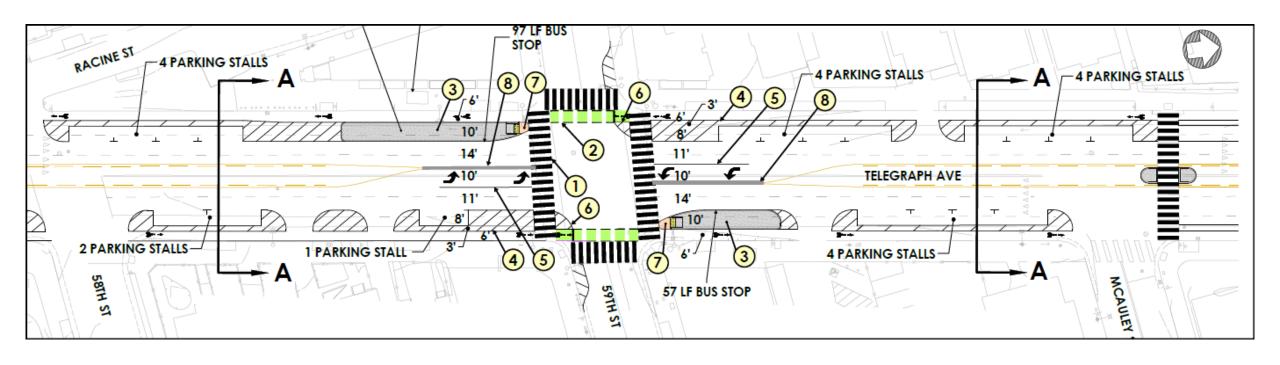



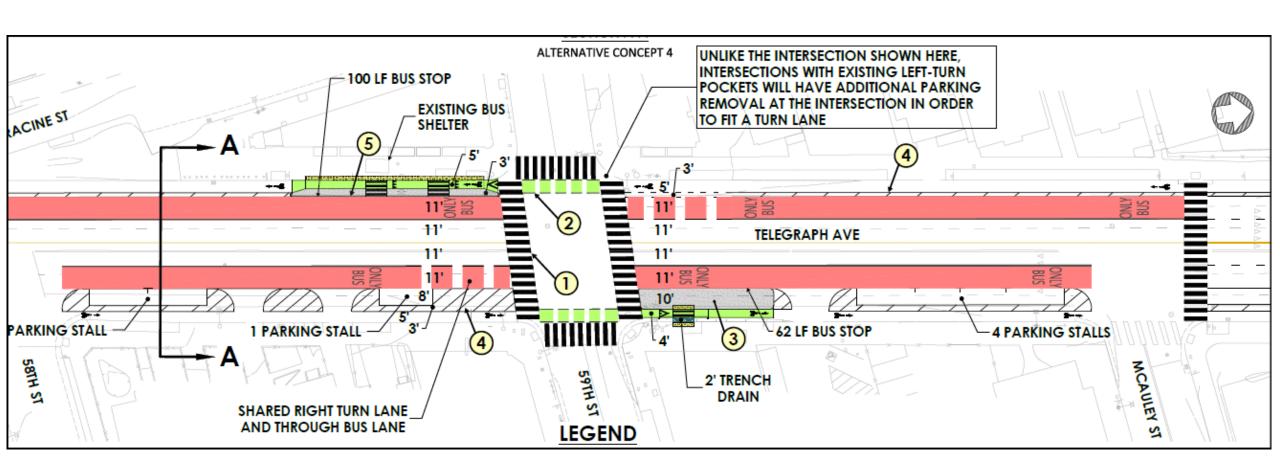




- Bus-only lanes (increased efficiency & reliability; aligns with AC Transit's long-term goals)

- Significant parking removal (one side plus removals for left turn pockets)
- Approaching intersection, bus lane shared with bikes and right-turning vehicles
- If major signal changes needed, then slower delivery timeline (7-10 yrs)





On 26 Sep 23, at approximately 2134 hrs, a Chrysler 300 blk, which was later discovered to be a stolen vehicle out of Vallejo, was traveling westbound in the 5400 blk of International Blvd, when it struck a pedestrian in the roadway, outside of the crosswalk. The impact of the collision, caused the pedestrian to come to rest in the westbound lane of traffic, in the 5400 blk of International Blvd. While lying injured in the roadway, a 2 door silver vehicle (possibly a mid-2000s Nissan Altima), traveling westbound International Blvd, struck the pedestrian and continued driving westbound International Blvd without stopping to render medical aid or provide their information.

Medical personnel responded to the scene to render aid to the pedestrian. The pedestrian (an unidentified female Hispanic, unknown age or residence) succumbed to her injuries and was pronounced deceased on scene.

The occupants (3 or 4 people) of the Chrysler 300 were observed by witnesses exiting the vehicle and fleeing on foot southbound 53rd Ave, leaving the disabled vehicle on scene. The driver was later detained, near the scene, and arrested for the fatal hit and run collision and driving a stolen vehicle. The driver of the stolen Chrysler 300 was identified as a 27-year old, female Black, San Leandro resident.

The driver of the 2 door silver vehicle fled the scene, in their vehicle, and has not been identified.

The pedestrian's identity is unknown at this time.

It is unknown if alcohol/drugs were a factor in this collision.

I would be a strong addition to the Bicyclist & Pedestrian Advisory Commission because I live car-free in Oakland, and I care deeply about making Oakland a safer and more enjoyable place for cyclists and pedestrians to move around. I love this town, and strongly believe a move towards less car-centric infrastructure would improve the health, safety, and well-being of our citizens, as well as be a great step towards us as a community fighting climate change. I first moved to Oakland in the fall of 2018; I spent 2019 living in San Francisco before returning to Oakland in early 2020. Living in a walkable place where a car is unnecessary is one of my main criteria in choosing a home (I have never owned a car in the Bay Area). In March of 2022, I took SF Bike Coalition's Adult Learn-to-Ride course and began biking around Oakland. Since then, biking has replaced walking and running as my main mode of transit, and I have also started cycling for sport, with my first triathlon coming up next month. As a relatively new cyclist, I was initially particularly nervous about urban biking alongside cars. My comfort level has grown as I've biked more and become more nimble, but regular news of cyclist and pedestrian fatalities (I am particularly heartbroken by Maia Correia's death last month) reminds me that there is so much more we can be doing as a town to protect our citizens. As such, this year it has become increasingly important to me to get more actively involved in making the changes I want to see. To this end, I started volunteering with Bike East Bay in May, and have enjoyed learning more about what it takes to make better infrastructure a reality from an advocacy perspective, connecting to like-minded community members, and contributing however I can, whether that's distributing fliers for fundraising events to bike shops around Oakland, calling monthly donors, or administrative work. I'm excited by the upcoming improvements to San Pablo, and the projects in development for MLK and Grand, which I learned more about at the BPAC's Infrastructure Committee meeting last week. Last month, I also volunteered for Cycles of Change's Lake Merritt-thon, a fundraising ride to support their work in bike education for East Oakland youth. This was an incredibly inspiring experience, and it was deeply satisfying to help and befriend people doing such needed work. The event emphasized the theme of bikes being both an agent of joy and of economic empowerment. If selected to serve on the BPAC, I would keep this idea central, as I believe it encompasses the diverse range of populations Oakland's infrastructure serves. I am privileged enough to mostly see movement as a source of joy: it is a way to meet friends, to replenish endorphins, to celebrate my body's abilities. However, many in Oakland bike or walk because these are their only accessible modes of transportation by which they can earn a livelihood and fulfill their basic needs. This group is disproportionately composed of people of color, people with disabilities who cannot drive, and low-income communities. These folks deserve better, safer options, and I want to do my part to help make those options a reality.



My experience working as a Program Coordinator and Community Organizer at the East Oakland Collective, my degree in Landscape Architecture, and my personal use of Oakland's bike facilities are most relevant to the Bicycle and Pedestrian Advocacy Commission's mission in several ways. These traits as a community member, organizer, and interest in design can align with the commission's mission to improve the conditions and safety of pedestrians and cyclists in their respective communities. At the East Oakland Collective, I started as an Organizer in the Community Planning Department. My first project was working on a feasibility study called Power The People. This project aimed to get East Oakland residents access to the Martin Luther King Jr. Shoreline by investigating existing socioeconomic and physical barriers, zero-waste modalities, accessibility, and culturally competent programming. Individuals and partnerships in East Oakland could advocate for better infrastructure, such as safer sidewalks, dedicated bike lanes, and improved traffic calming measures by engaging in community organizing efforts. I assisted in advocacy efforts for safer streets through community bike rides and querilla-like design tactics where community members gathered to post up slow street signage and other temporary calming infrastructure. This aligns with the commission's mission to promote the needs and rights of pedestrians and cyclists and ensure their voices are heard in matters that affect their safety and accessibility. Furthermore, community organizing taught me to gather input from residents, identify areas of concern, and work together to develop solutions and advocate for change by hosting monthly community planning meetings related to the Power The People project. There was also another project named Mobility For All, in which I helped plan a program that would distribute e-bikes and traditional bikes to individuals facing unemployment or underemployment as a means of cost-effective transportation. While I was not present to see how the program performed, I learned to take input from previous versions of this program to accommodate more needs. The commission can benefit from the insights and perspectives brought forth through community organizing efforts in East Oakland, helping to guide their recommendations and initiatives in an often overlooked place. While my knowledge is not specific to East Oakland or community organizing efforts there, I can provide general information, tips, and strategies on how to engage in community organizing and advocate for improved bicycle and pedestrian infrastructure. My studies as an undergrad at UC Berkeley to pursue Landscape Architecture as a career have given me some insight into designing public spaces that are safe, accessible, and attractive for pedestrians and bicyclists. I can apply this knowledge to develop recommendations and proposals for infrastructure improvements that promote walking and bicycling as safe and viable modes of transportation. As part of my studies, I have also learned how to incorporate sustainable design and green infrastructure initiatives into my work. By incorporating green infrastructure elements like bioswales, rain gardens, and permeable paving into bicycle and pedestrian infrastructure projects, we can help improve water quality, reduce the impact of stormwater runoff, improve air quality, and provide other environmental benefits. Moreover, landscape architecture balances the physical and natural environment with social and cultural factors. In the same way, the Bicycle and Pedestrian Advocacy Commission's mission seeks to promote a safe and sustainable transportation system that is equitable and accessible to everyone, regardless of socioeconomic background. I can help the commission identify how to balance physical infrastructure improvements with social and environmental priorities to create a comprehensive system that benefits the community. As a firstgeneration Latina from East Oakland, I enjoy sharing the unique experiences and perspectives I have been gifted as a first-generation Oaklander. Exposure to multiple cultures, diversity, art, and social justice movements inspires me to be more active within city limits. As I explore a career in Landscape Architecture and possibly Urban Planning, I look forward to restoring the relationship between the people of Oakland and local leadership. Overall, my experiences provide me with relevant skills and knowledge that can contribute to achieving the Bicycle and Pedestrian Advocacy Commission's mission.

Dear Oakland Bicyclist & Pedestrian Advisory Commission Recruitment Committee: I am applying for a seat on the Oakland Bicyclist & Pedestrian Advisory Commission (BPAC). As a long-time Oakland resident in District 2 and as an advocate for sustainable and equitable mobility, I am very excited about this opportunity and can make important contributions. I have over ten years of professional experience in bicycle and pedestrian planning, and I have a Master's in City Planning from UC Berkeley, where I focused on transportation and urban design. As a woman of color and a mother of two kids, street safety and comfort is my top priority. I often ride my e-bike to take my son to preschool, and while biking is a really fun and sustainable way to get around with kids, on certain streets I have great concerns about safety - both traffic and personal safety, which limits where we can bike together. My immediate concern and interest focus on District 2, especially providing safer bicycle and pedestrian facilities in and around Chinatown and along the highway underpaths. Currently I live in Chinatown, and getting to the nearest bike lane is challenging because of speeding cars and double parking, and crossing streets is scary because of left-turning vehicles. I am also interested in the larger network throughout Oakland and adjacent cities, such as Berkeley, Emeryville, Alameda, and San Leandro. I know from both personal and professional experience that there is a great need to not only expand a safe regional network but also fill in the gaps in existing networks. We need to do both to ensure a safe, effective and equitable bicycle and pedestrian environment for Oakland residents. I will utilize my expertise and professional experience to contribute to making a more bikable and walkable environment in Oakland. While I was a Senior Planner at San Francisco Planning Department, I led an interagency street design body, called the Street Design Advisory Team (SDAT). One of the SDAT's responsibilities is to develop detailed multimodal corridor plans at a micro scale, with a deep understanding of larger transportation networks, transit operations, and vision zero projects. For the Balboa Reservoir Development Agreement project, a 1,100 unit, 17 acre master planned development adjacent to BART, I led a multi-disciplinary team to develop a transportation plan for the site and presented at multiple public hearings for project approvals, including the San Francisco Board of Supervisors. Currently, I am with BART and in charge of station area planning and access improvements for BART stations in Oakland, Hayward and Fremont, I can contribute my technical expertise and professional experience to bring diverse perspectives to the BPAC discussions. Hello Commissioners,

I would like to provide the requested candidate statement for a renewed BPAC term.

First of all, it has been a seemingly quick first term and I have mixed feelings of the success of our commission and my own role. I have greatly enjoyed the camaraderie and chance to work with the full commission which became - despite the logistical challenges - much more concrete once we emerged from COVID as well as the on-going opportunity to help define and implement our strategic plan over the last three years. My mixed feelings stem from my own intentions to work with the BPAC to help shape city policy on equitable bicycle and pedestrian infrastructure investments and planning, especially for many of our under-resourced communities such as in the greater East Oakland area for which I have long-standing working relations and knowledge. While our commission raised many important issues, submitted letters of recommendation, and directed staff on several fronts - e.g. issues I have been vocal in: furthering waterfront connections projects in East Oakland; connecting neighborhood bike routes and slow streets to neighborhood planning structures, and weighing in on pending infrastructure/streetscape projects via our infrastructure committee - it still feels like our collective efforts are only slowly being formalized in on-going planning and development. Part of this points to the fact we need much more inroads, participation, and representation from communities such as East Lake, Fruitvale, Deep East Oakland. I am hopeful that as we ramp up our outreach and community engagement we will build the necessary energy and awareness to implement many of these needed changes. I still remain dedicated to building this type of engagement to the greatest extent I can. This brings me to my further goals and objectives for the next three years.

The next two years present a tremendous opportunity for the BPAC to engage in formalizing many of the strategic actions we have outlined via the phase two of the City's General Plan process which includes the land-use, transportation, open space, and infrastructure element. My own background and interest as a policy planner focused (mostly in Oakland) on green and active transit projects are areas I wish to apply to ensuring our advisory role is fully represented in the forthcoming General Plan process.

Specifically, in these terms, my goals would be to see explicit Class I bike greenway networks be envisioned and explicitly mapped and prioritized in the General Plan providing accessible routes across the flatland communities and connecting across barriers like the I-880 freeway to the waterfront/MLK shoreline. In addition, the structure of intended community engagement and empowerment articulated in the just passed EJ Element should be connected to the on-going development of neighborhood bike routes and slow streets and I would also like to advocate for more robust civic action opportunities to help quick or short-term build out of such neighborhood facilities including upgrading of mid-block stair paths, developing community stewardship options, and such.

Beyond these planning goals, I would also like to see the BPAC directly involved in expressing strong advocacy for implementation of projects such as the 66th Ave. BART-Bay Project, The East Bay Greenway, and the San Leandro Creek Urban Greenway project. These projects have largely been caught up in many layers of politics resulting in delays in implementation. I believe the BPAC can be a more forceful body to communicate the imperative for these projects and the need to proactively bring attention to how the City can fulfill its responsibility to see these projects get constructed in a timely fashion. I also intend to continue to be a vocal supporter of efforts and initiatives to slow automobile traffic across our city and make existing corridor streets as green and complete as feasible.

## Please tell us how your qualifications and participation will relate to the requested board and/or commission's mission.

Finally, as a D2 resident, I recognize how important the Lake Merritt area is for the whole City as a destination for biking and walking. This resource must not only be accessible but safe for all levels of riders and walkers from all sectors of the City. Here again, I wish to help advocate for north-south connectors across Oakland (including the I-580 corridor and the aforementioned East Bay Greenway) that can make safe access for bicyclists and walkers a reality. In addition, I would love to see formal "Sunday Street" days around the Lake (as well as in other areas of the City) as a regular occurence to encourage and celebrate our active mobility lifestyles as a shared Oakland culture.





### Safe Routes to BART - Results from Cycle 1 and 2

#### **Cycle 1 Results**

The inaugural <u>Safe Routes to BART (SR2B)</u> grant program Cycle 1 for FY 2020/2021 has been a resounding success so far! BART received ten applications from public agencies representing the geographical diversity encompassed by the eligible counties of Alameda, Contra Costa and San Francisco.

A Selection Committee consisting of BART staff and representatives from Walk SF, TransForm and the Contra Costa Transportation Authority (CCTA) reviewed and selected four projects to receive SR2B funding (presented in the table below).

# **About the Project**

Lake Merritt Boulevard from Lakeside to E 12th Street are set to be repaved in 2021. This presents an opportunity to extend the popular two-way protected cycletrack around Lake Merritt from Madison Street southward and over the Estuary Bridge to E 12th Street! The OakDOT project team has worked alongside the community to craft a comprehensive redesign of these streets to improve safety for people walking and biking, enhance the transit connection to the Tempo BRT, and better connect the Eastlake neighborhood with the Lake and Downtown destinations via the under-construction 14th Street Project.


# **Project Goals**

- Provide a protected and welcoming place to ride a bike around Lake Merritt from Madison Street to E 12th Street
- Coordinate with AC Transit to provide bus-only lanes for the new Tempo BRT service, where feasible
- Alleviate congestion on the Lake Merritt mixed-use pathway
- Provide two-way bicycle connectivity on the lake side of Lake Merritt Boulevard Drive for recreational users, and provide one-way bike facility on south side of Lake Merritt Boulevard
- Leave the freshly-paved roadway better than we found it, with a new roadway plan that encourages recreation and safe travel by all modes

- Caltrans Highway I3/Bruns Court Pedestrian Overcrossing Project (POC) OakDOT Comments on Draft Environmental Document: OakDOT staff submitted comments on the Caltrans draft mitigated negative declaration for the replacement of the Bruns Ct POC over Highway I3 at Montclair Park. The environmental document evaluates three alternatives: a bridge with a switchback ramp landing between Highway I3 and Moraga Ave (Alternative 2); a bridge with a linear ramp along Montclair Park with two possible configurations for Moraga Ave (Alternatives 3a and 3b); and surface street improvements in lieu of a replacement bridge (Alternative 4). If a bridge alternative is selected, OakDOT supports Alternative 3b which includes a road diet on Moraga Ave to improve pedestrian/bicyclist safety and to address existing sub-standard travel lane widths. While OakDOT staff do not support Alternative 4 as proposed, OakDOT staff see a significant opportunity for an expanded Alternative 4 to improve access between Bruns Ct and Montclair Park and reduce pedestrian exposure to traffic in a manner comparable to a new bridge.
- Direct Community Grant for Spokeland: The City's FY 23-25 Budget earmarked a total of \$750,000 for the 2023 Direct Community Grant Program. City Council subsequently selected the grantee organizations, including Spokeland, a bicycle repair collective based in Oakland's Longfellow neighborhood since 2011. The Finance Department identified OakDOT as the department responsible for managing the Spokeland project, which received a grant of \$16,250. The Bicycle & Pedestrian Program is tasked with establishing and administering this contract. Towards the end of FY23-24, the Citywide Grant Coordinator will present a Grant Continuation or Renewal Recommendation to City Council, creating an opportunity for this program to recur annually. - Park Blvd Crossing to Safety: Two traffic signals were turned on over the last two weeks along Park Blvd. This includes one new traffic signal at the intersection with 13th Ave adjacent to Edna Brewer Middle School, and one traffic signal modification at the intersection with Excelsior Ave/Grosvenor Pl. Pedestrian "recall" was programmed at the 13th Ave traffic signal to occur weekly between 4:30 PM on Friday and 9:30 PM on Saturday of the request of Beth Jacob Congregation to ensure the pedestrian lights come on without the need to push the pedestrian buttons during observance hours. Landscaping at the 13th Ave intersection is beginning the final week of September and is scheduled to be complete in October. Streetlights were adjusted at 13th Ave to accommodate resident concerns while still meeting safety standards. Additional adjustments to pavement markings and traffic signs are to follow in the Fall. By early Winter, a travel lane will be removed in each direction of Park Blvd approaching the crosswalks at Beaumont Ave using plastic delineators, pavement markings, and signs.
- OakDOT Major Projects Map Updates: In collaboration with the Capital Finance Section, the Bicycle & Pedestrian Program has completed the GIS data update and web map refresh on the OakDOT Major Projects Map with major updates in capital projects as of 8/21/2023. The update includes an additional 23 capital projects and significant updates on the attributes of the existing projects in fields such as project status, funding source, project information, project costs, project managers, expected completion dates, and more.
