1. Call to Order/Determination of Quorum/Approval of Agenda

The October 19, 2022, Special Meeting of Program Planning Committee Teleconference, was called to order at 6:06 p.m. Roll call was recorded by J. Waggoner. A guorum was established by M. Francisco.

MOTION: To approve the October 19, 2022, Program Planning Committee Agenda.

2. Approval of Draft October 12, 2022 Special Meeting of Program Planning Committee Teleconference Minutes – Attachment 2 M / S / Carried: A. Gums / P. Schader / Motion Carried.

3. 2023-2025 AC-OAP Request for Partnership (RFP) & Recommendations – Attachment 3

- Previously Funded Programs Previously funded programs were reviewed and referred to during the RFP Revision Discussion.
- Advisory Panel Proposal scoresheet The Advisory Panel's scoresheet handout was explained by D. Williams. The 2023-2025 Applicants all either provide low-income housing or job training. E. Clemons gave instructions to review the proposals and consider not only the score, but the geographic location of services in relation to those living in poverty.
- Review Discussion Per D. Williams, goal is to select for recommendation 12-14 grantees maximum. E. Clemons noted guidelines for collectively assessing the applicants: including does the program fulfill AC-OCAP's goals, what were outcomes if grantees funded, are services and number served aligned with funding requested, where are the gaps in funding. Categories for review and discussion will be Alameda County Job Training and Alameda County Housing, then Oakland Job Training and Oakland Housing. Grantees will be selected for recommendation first, then later dollar amount of funding for recommendation will be decided.

Discussion focused on Alameda County first. Two grantees for housing (Alliance for Community Wellness, Fremont Family Resources) and two for job training (Chabot, Rubicon) were selected for recommendation with a possible fifth grantee (Love Never Fails) to be seeded.

Discussion continued, focusing on Oakland Housing first. Four were selected for recommendation (Operation Dignity, St.

Mary's Center, Covenant House, Lao Family Foundation) with four additional grantees (A Diamond in the Rough, International Rescue, Change to Come, Sister to Sister 2) for seeding consideration. Thirteen proposed job training programs were compared to the guidelines and seven were eliminated from consideration as they did not match as well with the strategic plan of serving families with children, and seniors. Two were selected for recommendation (Hack the Hood, New Door Ventures). Additional data will be reviewed on the four remaining contenders for recommendation (Building Opportunities for Self Sufficiency, Urban University, Community Works, Lighthouse Community Public Schools).

ACTION ITEM: Committee to review staff-prepared spreadsheets for the 4 Oakland Job Training applicants with budgets with the match, proposed numbers to be served and projected outcomes, and what group is served (families, youth, adults, seniors) at next Program Planning Committee Teleconference.

- **5. Future/Proposed Agenda Items:** Continue with the review process at the next meeting, focusing on the 6 remaining Oakland Job Training programs and the selection for recommendation of Oakland Housing.

ACTION ITEM: Complete review process by selecting the Oakland Job Training and Oakland Housing grantees and finalizing the Alameda County Housing grantees (3rd grantee being considered for seed) in October 26, 2022 in preparation for providing to the Executive Committee.

Program Planning Committee Proposal Evaluation Criteria/Guidelines

The Program Planning Committee used as its first tier of review all proposals with scores over 40. Its second tier of review included proposals which provided services in the communities with the highest geographic concentration of poverty based on data.

- 1. Has the program been funded in the past and did they meet their outcomes, goals and terms of their contract (compliant vs. non-compliant)?
- 2. Does this program address AC-OCAP's vision, mission, needs assessment, and focus areas?
- 3. Does this program have *outcomes* which help AC-OCAP achieve its goals of helping low-income individuals become self-sufficient?
- 4. Are services and numbers served in alignment with the amount requested?
- 5. Does this proposal leverage collaborations and resources?
- 6. Does the program support CAP's Community Economic Opportunity (CEO) continuum of services for low-income residents in high poverty areas throughout Alameda County?
- 7. Is the agency providing services in AC-OCAP communities of poverty currently not served? Do they have physical locations in the community(ies) or an MOU with a local organization?
