- 1. Welcome/ Roll Call / Meeting called to order at 5:35 p.m. PAAC Chair Sarah Miller called the meeting to order and performed roll call.
- **2. Land Acknowledgment**: K. Leventi recited the Cultural Affairs Commission/Public Art Advisory Committee Land Acknowledgment.
- **3. Public Comment:** No comment was provided.
- 4. Action Item: Adopt the December 2, 2024, Public Art Advisory Committee (PAAC) Meeting Minutes. M. Guillard motioned to approve the minutes. K. Leventi seconded; S. Miller Aye; K. Kushner Aye; E. Murphy abstained. Motion passed.

- 5. Action Item: Review and Approve Tyrone Carney Park Memorial Sculpture Proposal by artist Dana King. Public Art Coordinator Kristen Zaremba introduced the project, noting the designs are funded by a grant secured by community members to re-open the park, located off 105<sup>th</sup> and Acalanes Drive. Zaremba advised Public Works staff and the project designers, landscape architects Dillingham Associates, on the competitive artist selection process. The artist selection panels also included community and family members of Tyrone Carney. The original artist selection of artist Dana King was approved by the PAAC in May 2023, but the PAAC didn't approve the artist's conceptual proposal at that time. Quincy Williams provided an overview of the project and introduced artist Dana King. Committee members reviewed the artist proposal which included examples of King's past work, and a mock-up of the memorial sculpture. King discussed her design concept and intent for the next phase of the project, including community engagement and fabrication. King and Williams answered clarifying questions from the committee about design of the sculpture. Committee members complimented the artist on her work and expressed enthusiasm for the project. E. Murphy motioned to approve the Tyrone Carney Park Memorial Sculpture Proposal by artist Dana King, M. Guillard seconded, K. Leventi Aye; S. Miller Aye; K. Kushner Aye. Motion passed unanimously.
- 6. Action Item: Review and Approve Mosswood Community Center Artist Selection- Phase 1 Finalists Recommendations Zaremba and Assistant Public Art Coordinator Josie de Mira provided an update on the artist selection process for the project, presented the five recommended finalists (Demetri Broxton, Adia Millett, Taller SANAA, Muzae Sesay, Jason Jagel), and discussed the next steps for the artist orientation and final interviews. Committee member K. Kushner and Quincy Williams, Assistant Capital Improvement Project Coordinator, Parks, Recreation and Youth Development shared their experiences as advisory members of the artist selection panel. Zaremba answered Committee member questions about the range of suitable artwork styles, the artwork location and it's relationship to the park. M. Guillard motioned to Approve Mosswood Community Center Artist Selection- Phase 1 Finalists Recommendations; K. Leventi seconded; E. Murphy Aye; K. Kushner Aye; S. Miller Aye. Motion passed unanimously.
- 7. Action Item: Review and Approve Deaccessioning of Shifting Topographies BART 17<sup>th</sup> Street Gateway Public Art by artist Dan Corson Zaremba provided an overview of the Shifting Topographies project, shared how the project opportunity and the artists' integrated artwork designs were developed, and the events that led to its current conditions, referencing information from the staff report. Due to the current conditions, the City's limited resources and the changes in property ownership, it is not possible to restore the artwork. Zaremba answered questions from committee members regarding the disposal of the artwork and costs for removal. Committee members expressed concern and understanding for the specific circumstances surrounding the project and acknowledged the challenges for this site could well inform future project planning. M. Guillard moved to approve Deaccessioning of Shifting Topographies BART 17<sup>th</sup> Street Gateway Public Art by artist Dan Corson; E. Murphy seconded; K. Kushner Aye; S. Miller Aye; K. Leventi Aye.
- 8. Informational Item: Public Art Program Coordinator
  - a. Updates Cultural Affairs Division/Citywide Updates:
  - b. City Elections, Budget Updates Zaremba shared that four new councilmembers and an

interim mayor have been sworn in. New council members will receive briefings on the Cultural Affairs Division and the Public Art Program shortly. Zaremba updated the committee on the budget and how it has affected the work of the Cultural Funding Program.

- 1. Welcome/ Roll Call / Meeting called to order at 5:32 p.m. PAAC Chair Sarah Miller called the meeting to order and performed roll call.
- **2. Land Acknowledgment**: K. Kushner recited the Cultural Affairs Commission/Public Art Advisory Committee Land Acknowledgment.
- **3. Public Comment:** No comment was provided.
- 4. Action Item: Adopt the January 6, 2024, Public Art Advisory Committee (PAAC) Meeting Minutes. Attendance did not meet the required quorum. Tabled until the following meeting on March 3.
- 5. Informational Item: Public Art Program Coordinator Updates
  - a. Program Updates
    - i. Josie de Mira, Assistant Public Art Coordinator shared updates with committee members about the status of the Mosswood Community Center public art project and the recent site visit conducted for the artist finalists. The artist finalists met on-site on January 24<sup>th</sup> where they participated in a tour of the building and received information from the project architects. Kristen Zaremba,

- Public Art Coordinator described the artist selection in more detail, and shared information about the artwork location surrounding architecture.
- **ii.** Zaremba shared information and photos of artwork in the Civic Art Collection and their current conditions, including staff site visits to inspect the public art installations at Bushrod Park, Broadway Auto Row Plaza, Rockridge Temescal Greenbelt.
- b. PAAC Recruitment- Review Current PAAC Expertise Roster and Discuss Nominees for Mayor and Council Appointment to the PAAC Zaremba discussed the PAAC expertise list and how the program is approaching nomination of new members to fill three vacant seats on the committee and a replacement for the seat of E. Murphy who is serving in a holdover status. She reiterated the need for demographic, geographic, and discipline diversity within the committee. Staff will bring a list of candidates to the March meeting for the committee to review. Committee members S. Miller, K. Kushner, M. Navasero, K. Leventi verbally concurred that they are willing to be reappointed for a second term. Zaremba confirmed that the expertise list is a living document and can be updated with suggestions from the committee. S. Miller suggested "Parks and Rec" and "Infrastructure" as additional categories for the list. Interim Cultural Affairs Manager L. Leifheit encouraged the committee to identify expertise categories that should be prioritized during recruitment.
- c. Public Art Plan Update; 2025 Program Priorities Zaremba shared that funds are being verified for the use of conservation and maintenance, or other civic collection needs such as a database and communication, in addition to commissioning new work. Currently, staff has been advised not to appropriate the full public art fund balance and are working to re-prioritize the funding. Updates will be made to the Public Art Plan draft and brought back to the PAAC for review and approval. Committee member K. Leventi brought up the possibility of an "Adopt-A-Monument" program that could assist the City in facilitating maintenance of art installation and provide outside funds. Staff and committee members discussed examples of these programs that have been successful in other cities. Zaremba shared the current City maintenance guidelines for the public art collection. L. Leifheit shared her support for the City to perform an audit of the public art collection and look at further options for maintenance of the artwork. Staff shared draft graphics and charts reflecting various project types and statistics from the results of the prequalified artist roster.

## SUMMARY

Staff requests the Public Art Advisory Committee (PAAC) receive a report on the Public Art for Private Development proposed artwork for the residential development at 121 East 12<sup>th</sup> Street, and provide comments on the public artwork designed by artist Craig Dorety for placement on a City owned parcel, in accordance with Oakland Municipal Code Chapter 15.78 Public Art for Private Development.

## **BACKGROUND**

The project applicant, East Bay Asian Local Development Corporation (EBALDC), is commissioning new permanent public artwork to comply with the municipal code requirement for nonresidential development to contribute 1.0 percent and residential development to contribute 0.5 percent of building development costs for public art on their development site. The development is located at 121 East 12<sup>th</sup> Street, on a city owned parcel, in Council District 2. The public art proposal includes five illuminated sculptural elements designed by artist Craig Dorety. See the art plan submittal attached (Item V.b) The artist was directly selected by EBALDC and will be co-facilitating a free educational event on March 4 at Space 1308 (1308 Broadway) in Oakland for artists as part of a community engagement effort related to this project. The event will educate artists on the public art opportunities and the role of public art in development, as well as technical details around design, fabrication, and installation of public art. Additionally, EBALDC collected input from students through a public art survey at a career fair at Dewey Academy (OUSD) in April 2024.

The City requires that public art projects intended for placement on city property or within the public right of way be reviewed and approved by the Public Art Program and Public Art Advisory Committee prior to proceeding with all other city permitting requirements. The applicant previously submitted complete public art plans prior to building permit issuance, and subsequent conceptual designs on schedule and as required, and will be responsible for securing relevant permits as part of the larger project.

The artwork to be placed on City property will be documented in accordance with the OMC and is anticipated to remain the property of and be maintained by the applicant, the East Bay Asian Development Corporation (EBALDC), unless approved otherwise by the City. Plans for ongoing maintenance of the artwork will be developed after design approval for incorporation into the final covenants recorded with Alameda County.

If any project cannot be realized to comply with the Oakland Public Art Ordinance and Oakland building codes, the applicants have the option to propose an alternate artwork and/or location, or to

make an in-lieu contribution to the Public Art Project Account, prior to issuance of a Certificate of Occupancy from the City for each project.

# **ACTION REQUESTED**

Staff requests the Public Art Advisory Committee (PAAC) receive a report on the Easy Bay Asian Local Development Corporation permanent public art proposed for 121 East 12<sup>th</sup> Street, as designed by artist Craig Dorety; review and approve the artwork for placement on City property and in the public right of way, in accordance with Oakland Municipal Code Chapter 15.78 Public Art for Private Development; and authorize staff to proceed with facilitation of the development of agreements for ownership responsibilities and ongoing maintenance of all artwork placed on city property.







6. Artist's Statement and Description of Proposed Work

#### **Artist Statement**

As an artist, I am deeply inspired by the interplay of light, color, and form to create dynamic, immersive experiences in public spaces. My work often explores themes of connectivity, community, and nature, using technology as a bridge between the organic and the built environment. By incorporating animated lighting into architectural elements, I seek to transform everyday spaces into vibrant, engaging encounters that foster a sense of wonder and belonging. My approach is rooted in an understanding that public art should not only beautify but also resonate with the people who live, work, and gather around it.

Light, with its ephemeral yet powerful presence, allows me to shape environments in a way that is both interactive and contemplative. By drawing inspiration from nature and cultural symbolism, my work encourages reflection on the relationships we form with each other and the spaces we inhabit. I strive to create works that invite audiences to pause, engage, and find meaning in the subtle yet profound ways that art can illuminate our lives.

# **Proposed Artwork Description**

This proposed artwork will utilize animated, full-color LED lighting to illuminate the entrances of a new mixed-use, mixed-income retail and apartment building located at East 12th Street and 2nd Avenue in Oakland, CA. The installation will be seamlessly integrated into the canopies above two building entrances, transforming these thresholds into welcoming, visually captivating portals.

The primary design motif consists of layered circles nested within one another, with each layer featuring its own unique animated color patterns. These dynamic lighting elements draw inspiration from the natural flora of the region, reflecting the rich biodiversity of Oakland's landscape. Additionally, the color palettes will evolve over time, influenced by seasonal changes and local environmental cues, ensuring a living, breathing presence within the urban fabric.

Conceptually, the layered circles symbolize the interconnectedness of community, representing the way individuals, families, and neighborhoods come together to form a greater whole. Just as nature thrives in ecosystems of diversity and interdependence, so too do communities flourish through collaboration and unity. The artwork serves as a visual metaphor for this shared experience, reinforcing the building's role as a space of inclusion, gathering, and growth.

This installation not only enhances the architectural identity of the building but also fosters a sense of place and belonging. It aims to offer a moment of beauty and contemplation to residents, visitors, and passersby, contributing to the cultural and aesthetic vitality of the neighborhood. Through the interplay of light, movement, and meaning, this work aspires to celebrate the dynamic spirit of Oakland and the communities that make it home.



















8. Materials and Methods Plan

#### 1. Materials

- Structural Components: Spun aluminum for durability and lightweight design.
- Sealing: Gaskets to ensure protection against moisture and dust.
- Lighting: Waterproof LED pixel strips for illumination.
- **Electronics**: Custom electronic components for system integration.
- **Control System**: Advatek control system for LED management and operation.

#### 2. Fabrication


- Metalwork: Welding aluminum brackets onto spun metal parts for structural integrity.
- **3D Printing**: Fabrication of wire and connector shrouds and housings to ensure proper protection and organization.
- Glass Cutting: Water jet cutting of glass elements for precision during assembly.
- **CNC Machining**: CNC cutting of aluminum and acrylic components for accurate and repeatable production, helping to ensure a complete water and dust seal.

#### 3. Methods

- **Assembly**: Components will be assembled using mechanical fasteners to ensure secure and stable protection against dust and moisture.
- **Suspension**: Artwork elements will be suspended from an adjustable Unistrut system, providing flexibility for alignment and maintenance.
- Installation: Installation will be performed on-site using a scissor lift or equivalent, ladders, and hand tools. All electrical components will be installed following best practices for waterproofing and cable management to ensure longevity and performance. Sidewalk obstruction during installation will be minimized, and necessary permits will be obtained to comply with local regulations.
- **Transportation**: All components will be transported to the installation site in secure packaging to prevent damage. Large components will be handled with appropriate lifting equipment to ensure safety.
- Quality Assurance: Each component will undergo testing before and after installation to verify functionality and safety.
- **Collaboration**: The artist will collaborate with local fabricators and installers to complete the work, ensuring high-quality execution and adherence to design specifications.

This plan ensures that the materials used and methods employed contribute to the longevity, safety, and aesthetic integrity of the public artwork.

### Maintenance Plan for Public Artwork with LED Lighting

#### 1. Introduction

This maintenance plan outlines procedures for preserving the functionality and aesthetic quality of the public artwork featuring LED lighting, installed within a metal canopy structure above building entrances.

### 2. Maintenance Schedule

- Weekly: Visual inspection of LED lights for outages, flickering, or discoloration.
- Monthly: Inspection of power supply, wiring, and control systems for any signs of damage or wear.
- **Quarterly**: Cleaning of LED fixtures and metal canopy to remove dust, debris, and environmental buildup.
- Annually: Comprehensive electrical and structural assessment, including software updates for programmable lighting.

### 3. Inspection & Preventive Maintenance

- LED Fixtures: Ensure all LEDs function correctly, replace malfunctioning units promptly.
- **Wiring & Connections**: Check for fraying, loose connections, or exposed wiring. Secure or replace as needed.
- Power Supply & Controls: Test voltage levels, inspect controllers, and confirm programming functionality.
- **Metal Canopy**: Inspect for corrosion, rust, or physical damage, and clean or repair as necessary.

If power failure occurs, inspect circuit breakers and restore connections if safe.

- In case of structural damage, cordon off the affected area and contact professional maintenance personnel.
- Address flickering or non-functioning LEDs immediately to prevent further system issues.

### 7. Long-Term Preservation

- Conduct an annual review of environmental impacts and adjust maintenance accordingly.
- Evaluate the need for technology upgrades, such as more energy-efficient LEDs or improved control systems.
- Engage with professional conservators or engineers for periodic expert assessments.

This plan ensures the longevity and reliability of the public artwork while maintaining safety and visual appeal for the public. Regular documentation of all inspections and repairs is essential to tracking performance and identifying potential improvements.

### Exhibit B Budget and Payment Schedule

- e) \$18,500 upon written notification of completion by Vendor.

### SUMMARY

Staff recommends that the Public Art Advisory Committee (PAAC) accept the selection panel's recommendation of Adia Millett as the recommended artist; and Jason Jagel as the alternate for the Mosswood Community Center Public Art Project.

### **SELECTION PROCESS**

Artist recruitment for the Mosswood Community Center Public Art Project was initiated using a short list of qualified artist candidates from the Oakland Prequalified Artist Roster.

### Artist Roster

Previously, the Public Art Program issued a Request for Qualifications for a prequalified artist roster. Practicing, professional artists or artist teams living or working in California were eligible to submit their qualifications for possible commission on various projects.

The City received a total of 418 applications to the artist pool. Staff reviewed all applications and forwarded the 297 eligible applications to the selection panel. Criteria for the selection of artists are found in the Oakland 2024 Prequalified Artist Roster Request for Qualifications (RFQ). The panel recommended 260 finalists.

Voting members of the prequalified artist roster selection panel were local arts representatives Kevin Chen, Oakland-based artist, curator, and previous Public Art Advisory Committee member; Jennifer Easton, Oakland-based BART Art Program Manager and Oakland Cultural Affairs Commission representative; and Mario Navasero, Oakland-based public artist, and Public Art Advisory Committee member. The panel was facilitated by Public Art Program staff, Public Art Coordinator Kristen Zaremba and Assistant Public Art Coordinator Josie de Mira.

### Mosswood Artist Selection Panel Process

For the Mosswood Center Public Art Project, staff developed a short list of fifty-one (51) eligible artists/artist teams with experience working in suitable materials (for translation to tile and mosaics or equivalent) to be reviewed and interviewed by a panel of City and community representatives. A community-based selection panel met on December 20, 2024 for a project orientation and on December 30, 2024, via Zoom, to review artists' credentials from the eligible pool.

The panel selected Demetri Broxton (Oakland), Adia Millett (Oakland), Muzae Sesay (Oakland), Taller SANAA (Oakland), and Jason Jagel (San Francisco) as finalists to be interviewed prior to making a final artist commission recommendation. The finalists attended an orientation meeting and site visit prior to interviews to become familiar with aspects of the project, receive direction on how to prepare for interviews, and ask questions of City staff.

The selection panel met again on February 8, 2025, and February 10, 2025, via Zoom, to view artist presentations and conduct an interview with each finalist. After careful consideration and discussion of each presentation, the panel submitted scores based on a fixed set of criteria that assessed artistic/project vision, collaboration skills, experience, and technical range. The selection panel made a final recommendation to award the commission to Adia Millett.

Voting members of the Mosswood Community Center Public Art Project selection panel were community representatives Charmin Baaqee (Mosswood Master Plan Community Outreach consultant and previous Public Art Advisory Committee Member); Ben Campbell (community member), Ragni-Larsen-Orta (community member), William Manley (community member), and Krista Chan (community member). Advisory (non-voting) panel members included project architect Ryan Jang, OPRYD CIP Coordinator Quincy Williams, and Mosswood Community Center Directors Terri Westbrook, and Public Art Advisory Committee member Kaitlin Kushner. The panel was facilitated by Public Art Coordinator Kristen Zaremba and Assistant Public Art Coordinator Josie de Mira.

### PROJECT BACKGROUND

The Oakland Public Art Program agreed to commission an artist, as required through Ordinance 11066 C.M.S. to enhance the Mosswood Community Center capital improvement project located at 3612 Webster Street, Oakland, CA 94609.

Staff worked with the project designers, Leddy Maytum Stacy Architects, Einwiller Kuehl Landscape Architecture, Art is Luv (community engagement); and Oakland Parks Recreation and Youth Development (OPRYD) and Department of Public Works (DPW) staff to identify public art opportunity types and sites. Multiple locations, most notably the front façade and entry of the main facility, as well as the interior stairwell and other lobby spaces within the center, were recommended for public art, as outlined in the Mosswood Park Master Plan. The master plan includes multiple buildings, to be delivered in phases. For this Phase One / main facility capital project opportunity, staff identified the exterior location above the building entrance, facing northward and the park fields, as the most beneficial location to elevate the building's identity and create a welcoming point of entry. The new work should successfully compliment the building's architecture and surrounding park land, while celebrating Oakland culture and the Mosswood community center's identity. A second, interior public art installation coordinated with community center staff and youth, will be implemented once the exterior project is underway.

The selected artist will develop final designs with community input in the spring of 2025, for design review by the PAAC prior to fabrication. The permanent artwork is planned for installation later in 2025, to be coordinated with the facility's opening.

### **FISCAL IMPACT**

The Mosswood Community Center Public Art Project is funded through City of Oakland percent for art funds (per Ordinance Number 11066 C.M.S) by Measure KK and state grant funds. Once approved by

the PAAC, the selected artist will be contracted for design development, fabrication, and installation coordination of the final artwork in an amount up to one hundred seventy-five thousand dollars (\$175,000). A portion of the budget, to cover installation, will be administered through a licensed general contractor, to be determined at a later time.

### RECOMMENDATIONS

Staff recommends that the Public Art Advisory Committee (PAAC) accept the selection panel's recommendation of Adia Millett as the recommended artist to receive a commission of up to \$175,000 for design, fabrication and installation of artwork for the Mosswood Community Center Public Art Project.

### SUMMARY

Staff requests the Public Art Advisory Committee (PAAC) receive a presentation, provide comments and approve the revised draft FY 2023-25 Activities Report and FY 2025-27 Public Art Projects Plan for City Council, in accordance with the Oakland Public Art Ordinance 13562 CMS, and to authorize staff to proceed with final plan development and presentation to the City Council for final approval in May 2025.

### **BACKGROUND**

The City of Oakland's Public Art Ordinance (No. 11086 C.M.S.), adopted in 1989 (amended in 2019: Ordinance No. 13562 C.M.S.), established the Public Art Program, the Public Art Advisory Committee, and requirements for adoption of a Public Art Projects Plan. The plan consists of a prioritized list of visual arts projects to be undertaken in any given year, including budgets and recommended site and design approaches, when applicable. The Public Art Projects Plan is developed by Public Art Program staff in cooperation with financial and capital project management staff of the City's Public Works Agency- Project Delivery Division, and Department of Transportation – Planning and Project Delivery.

This Public Art Projects Plan identifies new and current public art projects. Projects are funded from 1.5% of the budgets of the City of Oakland capital improvement projects, as established by the ordinance, from other sources of City and Agency funding, and from outside grants.

Additionally, funds generated by the Oakland Municipal Code Chapter 15.78, Public Art for Private Development (Ordinance No. 13491 C.M.S.) developer in-lieu contributions are now contributed to the Public Art Project Account for program administration and the commissioning of public art across the City.

To develop the plan, Public Art Program staff reviews the current City of Oakland capital improvement projects and confirms budgets for public art funding. Working with other City departments, staff evaluates the opportunities and feasibility of implementing new public art projects at sites on City property and in the Public Right of Way, then consults with the City Council-appointed Public Art Advisory Committee (PAAC) to prioritize and recommend sites for project development. Staff presents the Public Art Projects Plan for review to the PAAC and to the City Council for approval and prior to implementation. Approved projects are reviewed at monthly public meetings of the PAAC and through dialogue with advisory groups of arts professionals and residents with a stake in the communities impacted.



### **PLAN REVISIONS**

The first draft of this plan presented in July 2024 was focused on program priorities for the single FY 2024/25 year. The plan has now been updated to align with the City's upcoming, bi-annual FY 2025/27 budget, to incorporate additional capital projects and to realign the Public Art Project Account in-lieu funds with Civic Art Collection priorities including a master plan, collections assessment and maintenance, prior to implementing a new public art program for underserved communities across Oakland. Final revisions to the plan may be implemented, as directed and informed by Economic & Workforce Development Department leadership, the City Administrator, Budget Office and City Council.

### **ACTION REQUESTED**

Staff requests the Public Art Advisory Committee (PAAC) receive a presentation, provide comments, and approve the revised draft FY 2023-25 Activities Report and FY 2025-27 Public Art Projects Plan for City Council, in accordance with the Oakland Public Art Ordinance 13562 CMS, and to authorize staff to proceed with final plan development and presentation to the City Council for final approval in May 2025.

### The Public Art Projects Plan

In 2018 the City Council adopted the Oakland Cultural Plan which declared, "Aesthetic expression and values of the City find their way into the civic cultural commons through the Public Art Program related to public works. Pieces of public art in Oakland may be subtly or boldly incorporated into public spaces—through a window, in the walkway, on a bench, as an archway or entrance, or as a sculpture in a public lobby or plaza. Such projects contribute to the visual cultural dialogue between the different parts of the city where public spaces exist," and people gather.

Oakland's Public Art Ordinance (No. 11086 C.M.S.), adopted in 1989 (amended in 2019: Ordinance No. 13562 C.M.S.), established the Public Art Program, the Public Art Advisory Committee, and requirements for adoption of a Public Art Projects Plan. The plan consists of a prioritized list of visual arts projects, community investments, and public art related initiatives supporting the Civic Art Collection to be undertaken in any given year, including budgets and recommended site and design approaches, when applicable. The Public Art Projects Plan, informed by the Capital Improvement Program and the Oakland Cultural Plan to invest in and uplift Oakland's vibrant cultural communities, is developed by Public Art staff in cooperation with financial and capital project management staff of the City's Public Works - Project Delivery Division, and Department of Transportation — Planning and Project Delivery.

Working with other City departments, staff evaluates the opportunities and feasibility of implementing new public art projects at pending capital projects sites and in the Public Right of Way and consults with the City Council-appointed Public Art Advisory Committee (PAAC) to prioritize and recommend sites and opportunities for project development. Staff presents the Public Art Projects Plan for review to the PAAC and to the City Council for approval and prior to implementation as needed. Approved projects are reviewed at monthly public meetings of the PAAC and through dialogue with advisory groups of arts professionals and residents with a stake in the communities impacted.

An internationally recognized cultural center, Oakland has supported public investment for art in the public realm and architecturally integrated public art for generations. Public art strengthens Oakland communities through economic and social investments. Studies show that public art enhances tourism and foot traffic, which boosts local businesses and stimulates economic growth. Tangible expressions of creativity and storytelling foster belonging and pride among our residents and encourage cultural exchange. Public art importantly also provides platforms for artists to showcase their work which enrich Oakland's dynamic arts and cultural environment and supports creative industries, attracting residents and visitors to the diverse array of neighborhoods across the city.

### **Public Art by the Numbers:**

- The Oakland Public Art Program has continuously supported arts and cultural investment across Oakland for over 35 years.
- The City of Oakland Public Art Program has commissioned more than 130 public artworks valued at over five-million dollars (\$5,000,000) since adoption of the ordinance in 1989.
- The Public Art for Private Development program (Est. 2014) has supported over 50 privately owned, permanent public artworks in freely accessible locations across the City; an investment valued at approximately nine-million dollars (\$9,000,000).
- An average of ten private and community initiated public art proposals planned for City property are presented annually to the Public Art Advisory Committee for review and approval prior to installation.
- The nine member Public Art Advisory Committee of Oakland-based curators, artists and cultural workers review and approve placement of all work funded by the city or to be placed on city property at their monthly meetings.
- Artist recruitment, program administration, project delivery, community engagement support, collections management and facilitation of the Public Art Advisory Committee is currently supported by two full-time staff.

## **Funding:**

This Public Art Projects Plan identifies new and current public art projects. Projects are funded from 1.5% of the budgets of City of Oakland capital improvement projects (CIP), as established by the ordinance, from other sources of City and Agency funding, and from outside grants. Funds may be deposited into the Public Art Project Account or remain with the related CIP accounts when required, but assigned to the Public Art Program for project administration.

Additionally, funds generated by the Oakland Municipal Code Chapter 15.78, Public Art for Private Development (Ordinance No. 13491 C.M.S.), developer in-lieu contributions are now contributed to the Public Art Project Account for program administration and the commissioning of public art across the City.

## **Public Art Program Overview**

Oakland's Public Art Program provides oversight and guidance on best practices for public art in the city, and commissions original works of art for public spaces in Oakland. Informed by the Oakland Cultural Plan, Oakland Public Art:

- Enriches the City's visual environment
- Integrates the creative thinking of artists into our deeply rooted neighborhoods and new construction public improvement projects
- Provides professional development and career opportunities for emerging and established professional artists
- Fosters financial investment in Oakland's economy through creative place keeping
- Contributes to safe and vibrant communities
- Creates opportunities for residents and visitors to enjoy and experience the cultural diversity of Oakland

## **Key Program Oversight Responsibilities:**

Public Art Program staff act as program and collections managers, community liaisons, project delivery managers, facilitators and artist advocates for projects on public property (e.g., City/Caltrans/BART) and Oakland Municipal Code (OMC) mandated public art projects for private property, with guidance and support from the PAAC. Program responsibilities include:


- City Managed CIP Public Art Projects
   Funded through a 1.5% allocation from all eligible
   City capital improvement projects (CIP), including all bond projects and all other capital
   projects funded from other sources excluding specific sewer repairs, eligible grant
   revenue as well as private contributions. Established in 1989, the City adopted
   Ordinance No. 11086 C.M.S. (amended in 2019: Ordinance No. 13562 C.M.S.)
   authorizing the allocation of 1.5% of municipal capital improvement project (CIP) costs
   to commission, acquire and facilitate private and community investment in public art for
   public spaces.
- 2. <u>Public Art for Private Development Projects</u> Funded through the 2014 OMC adopted requirement for 0.5% of residential or 1% of nonresidential private development costs. In June of 2018, the municipal code was amended to adopt Chapter 15.78, Public Art Requirements for Private Development (Ordinance No. 13491 C.M.S.). Staff provide guidance, facilitate artist opportunities, community engagement and final compliance. Staff also facilitate review when required by the PAAC (see below).

3. <u>Civic Art Collection Records and Maintenance</u> Monitoring and assessing City commissioned permanent artworks, when funds are available. Staff facilitate and provide oversight of necessary maintenance in coordination with the respective departments and Public Works staff. Monitoring and caring for the City's cultural investments is an important, and historically under-resourced, responsibility. The permanent artwork funded by the City requires future investment in documentation,

- education, and maintenance to sustain the City's capital investments and cultural assets.
- 4. <u>Temporary/Permanent City-Funded Artist and Community Initiated Projects</u>
  Commissioned as funding becomes available; facilitated in collaboration with other departments and reviewed for completeness and feasibility with City requirements.

- 5. <u>Artists' Professional Development and Workshops</u> Provided by City staff to local artists for new CIP opportunities, and through partnerships with local organizational stakeholders and regional trainings with public art programs in nearby cities.
- 6. Public Art Advisory Committee (PAAC) Staff recruit and facilitate committee appointments; prepare agendas, minutes, staff reports; and facilitate presentations for the monthly meetings of the nine-member, Mayoral-nominated and City Council-appointed committee. Members of the PAAC Oakland-based artists, designers, curators and makers provide feedback and oversight, and review and approve public art for the City of Oakland. The Committee advises and makes recommendations to the City Council, City Administrator, and Cultural Affairs Division related to public art funded by the City and public art placed on city property and in the public right of way, including on property owned by other public agencies.

## The Oakland Cultural Plan and Public Art

Adopted by City Council in July 2018, the Cultural Plan set out new, clear priorities and goals for the Public Art Program, excerpted here, within the framework of the "Civic Cultural Commons":

"The civic cultural commons are where people can intentionally build a sense of community and belonging. It is where cities create their sense of identity through what is promoted, allowed, and prohibited in the shared environment...

"Public Art in Public Works: Aesthetic expression and values of the City find their way into the civic cultural commons through the Public Art Program related to public works.... The process for incorporating public art into public works projects is typically long and complex—sometimes involving multiple agencies and iterative cycles of approval—and in recent times, regulatory requirements have only increased. But given these interfaces with different parts of government, Public Art projects can be a valuable entry point into cultural equity discussions with partner agencies, and open new opportunities for enlarging and diversifying the pool of artists knowledgeable about the intricacies and timelines of incorporating creative elements into public works...

"Public art in private development: Projects have the potential to substantially increase resources for the creation of visual art or arts space accessible to the public and to help employ Oakland artists (an encouragement, though not a requirement of the ordinance). Incorporating inviting artworks and cultural spaces at street level opens the possibility for visually relating to surrounding spaces, making reference to the history of the place, enlivening foot traffic, and giving passers-by a reason to interact. The ordinance can act as an important reminder to private developers that even if a building is privately owned, it still exists in the interactive space of the public commons....

"The Public Art Program is staffed by one full-time person. The program recently lost a full-time position though the workload has increased due to State and City regulations and is anticipated to grow as clarifications related to Measure KK and the private development ordinance are made. The program previously had a staff of 2.5 FTEs. There is neither program capacity to complete an up-to-date inventory and assessment of the public art collection nor the resources to maintain it."


## FY 2023-25 Public Art Activities and Accomplishments











## **Mosswood Community Center**

**Project Description**: Bay Area artists will develop public art projects for two locations in the Mosswood Community Center. Artist will be selected from the Prequalified Artist Roster candidates including Oakland artists, artists residing in District 3 and graduates of the "CSIG" Public Art Workshops. Permanent artwork in ceramic tile or mosaics will be sited above the exterior entrance of the new recreation center, with a second, separate commission for a mural in the public lobby / stairwell within the facility. Artwork designs will be developed with community stakeholder input.

Community and Economic Development Benefits: The vision for the new Community Center is to create a vibrant destination for civic, cultural, social, educational, and recreational activities. The Community Center will incorporate sustainable design principles, enhanced by public art. It will be inclusive of a diverse community of users, universally accessible, flexible in use, and thoughtfully designed. The public art project will celebrate community, engender deeper feelings of belonging, and generally contribute to the revitalization of this highly anticipated rebuilt recreation center.

**Project Status:** Oakland artist Adia Millett was recommended by a community-based selection panel to be awarded the commission for a permanent exterior ceramic mural at the building entrance facing Mosswood Park. A second commission for interior artwork in the stairwell for the two-story building will commence shortly. Both commissions will be awarded to artists prequalified for the public art roster. Construction is underway, with anticipated artwork completion in late 2025.

Permanent painted murals will be integrated into the building exterior. Artwork designs will be developed with community and recreation center stakeholder input.



**Community and Economic Development Benefits:** The DeFremery Park project presents an exciting opportunity to bring permanent artwork improvements to existing facilities within the park. The artwork opportunity is intended to create greater visibility and awareness of the park's active communities, including the adjacent skatepark and Panther skatepark.

Permanent artwork in durable materials such as steel, bronze, concrete and porcelain enamel will be utilized to ensure resiliency. Artwork designs will be developed with community and Black Arts Movement and Business District (BAMBD) stakeholder input on artist selection and designs.

**Community and Economic Development Benefits:** The streetscape project will enhance pedestrian and bicycle access to the 14<sup>th</sup> Street corridor, enhanced by public art. It will be inclusive of a diverse community of users and universally accessible. The public art project will celebrate the BAMBD community, engender deeper feelings of belonging among community, and generally contribute to the revitalization of this previously heavily used and highly anticipated rebuilt recreation center.

Community and Economic Development Benefits: The vision for the renovated Estuary Park is to create a revitalized park and vibrant destination for civic, cultural, social, educational, and recreational activities, including watercraft access to the Estuary. It will be inclusive of a diverse community of users, universally accessible, flexible in use, and thoughtfully designed. The public art project will celebrate community, engender deeper feelings of belonging among community, and generally contribute to the revitalization of this important waterfront park.

Permanent artwork in durable materials such as tile, mosaic or porcelain enamel will be located near the entrance of the new recreation center and/or within the new gymnasium and public lobby areas. Artwork will be developed with community / stakeholder input.



Community and Economic Development Benefits: Located in Oakland's Chinatown, the Center occupies one corner of the 1.75-acre urban block park.
